# RECOMMENDATION

That the Oversight Board approves a Resolution (Attachment II) amending the Fiscal Year 2017 Administrative Budget.

# BACKGROUND AND DISCUSSION

The Successor Agency pays for City staff to conduct the affairs of the Agency from a \$250,000 annual administrative allowance authorized and approved by the Department of Finance.

On January 27, 2016, the Oversight Board approved the Fiscal Year 2017 Successor Agency Administrative Budget. Staff is proposing an amendment to the Administrative Budget to account for increases in personnel costs related to a promotion.

While there is no formal procedure for amending the administrative budget once it has been approved by the Oversight Board, staff and agency legal counsel recommend obtaining Oversight Board approval for the increase in personnel services to ensure no future DOF issues arise.

# FISCAL IMPACT

The net budget impact from this change is \$7,301. The Successor Agency has enough administrative budget allowance to cover this increase. This increase in the Personnel Services budget is commensurate with a decrease in the Agency Supplies and Services budget. This increase will have no bearing on the FY17 ROPS approved Foothill Façade and Property Disposition project budgets. Furthermore, this change does not require the submission of an amended ROPS. Attachment III provides the new Administrative Budget.

# **NEXT STEPS**

Staff will process necessary budget adjustments pending completion of all personnel action forms with the Human Resources Department.

## RESOLUTION NO. 2016-

A RESOLUTION OF THE OVERSIGHT BOARD FOR THE HAYWARD SUCCESSOR AGENCY, APPROVING AN AMENDMENT TO THE ADMINISTRATIVE BUDGET FOR THE 2016-17 FISCAL YEAR, AND DIRECTING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE REQUIREMENTS ASSOCIATED WITH THIS APPROVAL

WHEREAS, pursuant to ABx1 26 (as amended by AB 1484, the "Dissolution Act"), the separate legal entity known as the Hayward Successor Agency (the "Successor Agency") must prepare "Recognized Obligation Payment Schedules" ("ROPS") that enumerate the enforceable obligations and expenses of the Successor Agency for each successive twelve-month fiscal period until the wind down and disposition of assets of the dissolved Redevelopment Agency of the City of Hayward (the "Dissolved RDA") has been completed; and

WHEREAS, the Successor Agency staff has prepared a ROPS for the twelve-month fiscal period commencing on July 1, 2016 and continuing through June 30, 2017 ("ROPS 16-17") which was approved by the Successor Agency's oversight board (the "Oversight Board") on January 27, 2016, in accordance with Health and Safety Code Section 34180(g); and

WHEREAS, the Successor Agency staff has prepared an administrative budget for the fiscal period commencing on July 1, 2016 and continuing through June 30, 2017 ("FY 16-17 Administrative Budget"), which was approved by the Oversight Board on January 27, 2016, in accordance with Health and Safety Code Section 34177; and

WHEREAS, the Successor Agency is entitled to an administrative cost allowance (the "Administrative Cost Allowance") pursuant to Health and Safety Code Sections 34171(b) and 34183(a)(3) in the approximate amount of \$250,000 for the 2016-17 fiscal year of which approximately \$125,000 will be disbursed during the ROPS 16-17A and ROPS 16-17B periods; and

WHEREAS, the FY 16-17 Administrative Budget requires an amendment in order to provide enough personnel services budget for a planned promotion, the revision to the FY 16-17 Administrative Budget will not result in a change to the approved Administrative Cost Allowance approved by the Oversight Board and Department of Finance and will not result in any changes to the ROPS 16-17; and

WHEREAS, the accompanying staff report provides supporting information upon which the actions set forth in this Resolution are based.

NOW, THEREFORE, BE IT RESOLVED that the Oversight Board hereby finds, resolves, and determines that the foregoing recitals as true and correct, and, together with information provided by the Successor Agency staff and the public, form the basis for the approvals, findings, resolutions, and determinations set forth below.

BE IT FURTHER RESOLVED that the Oversight Board, pursuant to Health and Safety Code Section 34177(j), hereby approves the Amended FY 16-17 Administrative Budget, in the form on file with the City Clerk. In connection with such approval, the Oversight Board finds that the amendment to the FY 16-17 Administrative Budget will assist in the continued administration of the ongoing enforceable obligations and the expeditious wind-down of the affairs of the Dissolved RDA by the Successor Agency.

BE IT FURTHER RESOLVED that the Successor Agency is authorized and directed to enter into any agreements and amendments to agreements consistent with the Dissolution Statutes and necessary to memorialize and implement the agreements and obligations in the Amended FY 16-17 Administrative Budget as herein approved by the Oversight Board.

BE IT FURTHER RESOLVED that the Oversight Board hereby authorizes and directs Successor Agency staff, to take all administrative actions necessary under the Dissolution Statutes, to file, post, mail or otherwise deliver via electronic mail, internet posting, and/or hardcopy, all notices and transmittals necessary or convenient in connection with the approval of the Amended FY 16-17 Administrative Budget, and to take any other actions necessary to ensure the validity of the FY 16-17 Administrative Budget, as amended, and corresponding Administrative Cost Allowance.

BE IT FURTHER RESOLVED that the Oversight Board hereby authorizes and directs the City Manager, acting on behalf of the Successor Agency, to execute the documents and instruments as are appropriate, in consultation with the City Attorney, acting in the capacity of counsel to the Successor Agency, to effectuate and implement the terms of this Resolution;

BE IT FURTHER RESOLVED that this Resolution shall take effect at the time and in the manner prescribed in Health and Safety Code Section 34179(h).
