#### Call to Order

Vice Chairperson Araujo called the meeting to order at 7:05pm.

Ms. Franco conducted roll call.

Commissioners in Attendance: Araujo, Davis, Fagalde, Isais, Glover-Gardin, Guzman, Kassouf, Leppert, Macmadu, Mehdavi, Moore, Roche (arrived at 7:13pm) and Zargar.

Staff in attendance: Sean Reinhart, Director of Library and Community Services, Dana Bailey, Acting Community Services Manager, Monica Davis, Management Analyst II, Rachael McNamara, Management Analyst II and Lara Franco, Administrative Assistant III.

Visitors in attendance: Karen Norell of La Familia, Jillian Schaffer of Spectrum Community Services, Vera Ciametti of Ruby's Place, Gay McDaniel of FESCO, Erin Scott of Family Violence Law Center, Kimberly Conn of Family Paths, Kenny Altenburg of YMCA and Sara Finnegan of Eden I&R. Council Members in attendance was Elisa Márquez. Commissioners Absent were Balram, Bonilla and Samayoa.

There were no public comments.

Minutes from the January 18, 2017 Regular Meeting were approved.

Debrief and Review: Application Review Committee (ARC) Preliminary Draft Recommendations for FY 2018 Community Agency Funding. Dana Bailey reviewed each agency that requested funding along with their requests and the ARC recommendations. Division of recommended funding is in line with Council priorities. Dana Bailey reviewed the Arts and Music ARC. Commissioner Mehdavi reviewed the Infrastructure ARC. Commissioner Moore reviewed the Social Services Arc. Infrastructure and Arts and Music were fully funded. In Social Services, there were 28 agencies funded, 18 not funded and 3 new agencies. There were comments and questions from the Commission. The 30-day Public Comment period is open. Commission will be back in April to approve the recommendations and send them to Council. May 23<sup>rd</sup> will be the City Council work session.

Commissioner Announcements: Commissioner Fagalde will send details of memorial for her daughter to Dana Bailey to distribute to the Commission. Council Member Márquez encourages that the agenda for the March meeting go out to all agencies receiving funding and applicants as well. Commissioners are encouraged to attend the March Community Services Commission prepared to have an effective April meeting with Council. Anti-discrimination task force will have first meeting in room 2A Wednesday, February 22<sup>nd</sup>. Commissioners Moore and Mehdavi will attend as representatives of the Community Services Commission. Mr. Reinhart suggested a small committee of Commission to represent the entire Commission in a joint session with City Council. This item to be discussed in the March Commission meeting.
