RECOMMENDATION

That the City Council reviews five reappointment requests from members of the Community Services Commission, Library Commission, and the Downtown Hayward Business Improvement Area Advisory Board; and confirms the process for conducting the annual interviews on Tuesday, July 25, 2017.

BACKGROUND

The annual recruitment for Boards/Commissions/Committees/Task Forces was conducted from April 21 to July 10, 2017, to fill 21 vacancies. Fifty-six applications were received by the application submission deadline and fifty applicants qualified to be considered for appointment. Attachment II contains the final list of applicants and their preference for service. A binder containing the fifty applications was made available on Thursday, July 13, 2017.

DISCUSSION

Review of Vacancies

Staff has identified members whose terms expire in September 2017 and has contacted them to confirm if they want to continue serving. The table below summarizes the current vacancies on the Community Services Commission; Downtown Hayward Business Improvement Area Advisory Board; Keep Hayward Clean and Green Task Force; Library Commission; and Planning Commission.

<u>Community Services Commission (CSC)</u>:

There are seven (7) vacancies and two (2) requests for reappointment on the Community Services Commission. Two (2) vacancies were created by the resignation of Commissioners Annette DeJulio and Robert Leppert; three (3) are due to the terms of Commissioners Todd Davis, Linda Moore, and Elizabeth Samayoa terming out in September 2017; and two (2) are due to the Commissioners Crystal Araujo and Neha Balram's terms expiring in September 2017 and not seeking reappointment. Commissioners Diane Fagalde and Janet Kassouf's terms expire in September 2017 and they are seeking reappointment.

Downtown Hayward Business Improvement Area Advisory Board (DBIA):

There are six (6) vacancies and (1) request for reappointment on the Downtown Hayward Business Improvement Area Advisory Board. Five (5) were created by the resignation of Board Members Gustavo Barrios, Sid Hamadeh, Darren Guillaume, Dion Griffin, and May Shay; one is due to Board Member Syed Karim's business leaving the DBIA Zone. Board Member Martha Grogg's term expires in September 2017 and she is seeking reappointment. Economic Development (ED) staff recommend continuing the DBIA because of funds that will be available until 2019. ED staff has engaged DBIA Zone businesses but has not been able to recruit new members. According to the City Attorney's office, three members could constitute the DBIA and two members could create a quorum. In addition, staff is still continuing to pursue the formation of a Community Benefit District in the downtown area, which would ultimately replace the functions of the DBIA and be more sustainable and financially viable for the long term.

Keep Hayward Clean and Green Task Force (KHC&G TF):

There are nine (9) vacancies on the Keep Hayward Clean and Green Task Force. Three (3) were created by the resignation of Members Angela Moore, Natasha Neves, and Allen Zargar; and there are six (6) additional vacancies due to the increase in membership approved by the Task Force and incorporated into the Task Force Bylaws on March 23, 2017.

Library Commission (LC):

There are two (2) requests for reappointment on the Library Commission. Commissioners Peter Bufete and Iris Murillo's terms expire in September 2017 and they are seeking reappointment.

Planning Commission (PC):

There is one (1) vacancy on the Planning Commission created by the resignation of Commissioner Parso-York.

Interview Process for July 25, 2017

On July 17, 2017, the Keep Hayward Clean and Green Task Force (KHC&G TF) Subcommittee, comprising Members Linda Dobb, Jillian Hogan, and Chuck Horner, will interview applicants who have indicated KHC&G TF as one of their preferences for service. Applicants selected by the Subcommittee will be recommended to the City Council. The City Council may accept the applicants selected by the KHC&G TF Subcommittee and/or choose to invite them to also interview with the City Council on July 25, 2017.

The City Council will continue the interview process that was followed last year which involved a "pre-screening" process that would allow the City Council to narrow the field of candidates to be interviewed. Council Members will have an opportunity to review the applications submitted by each qualified applicant and select up to five applicants for each body. They will then individually communicate their selections to the City Clerk by noon on Thursday, July 20, 2017. Applicants who received at least two votes would be invited to interview with the City Council on July 25, 2017.

FISCAL IMPACT

There is no fiscal impact associated with this report.
