## **Public Comments:**

Approval of Minutes of the Community Services Commission Meeting on June 20, 2018.

It was moved by Commissioner Kassouf to approve the Minutes and a second motion by Commissioner Roche. All Commissioners in attendance moved to approve the Minutes.

## **Staff Announcement**

Ms. Bailey noted that the By-Laws Subcommittee Update was not included on the 7/18/18 CSC Agenda, and that this item would not be up for discussion. The update from the CSC By-Laws Subcommittee will be included at the 9/19/18 CSC meeting.

### Discussion: Community Agency Funding Process

Ms. Bailey discussed the history of the Community Agency Funding process and reviewed the CSC Strategic Alignment proposal presented to Council at the May 2017 work session. The proposal recommended changes to future funding cycles (WS 170-023). Among the recommendations to Council were targeted funding to priority issues and funding evidence-based proposals. At this work session, no action was recommended for FY 17-18 and Council requested that the item be reconsidered to allow time for an adjustment period.

Councilmember Márquez noted that since the Council work session, no other discussion has occurred regarding the CSC Community Agency Funding Process.

Commissioner Glover Gardin asked how to re-introduce the Strategic Alignment proposals recommending changes to the Community Agency Funding process. Councilmember Márquez suggested scheduling a work session to review the recommendations and request Council approval to implement the changes. Staff will research the process for requesting a work session for CSC to present their recommendations to Council.

### Commissioner/Staff Announcements

Commissioner's Isais and Glover-Gardin announced they would not be returning to serve on the CSC. Commissioner Roche thanked the Commissioners' on behalf of the Commission for their service and leadership. Councilmember Márquez thanked Commissioners Isais and Glover Gardin for their service on behalf of the City Council and Mayor. Staff presented Commissioners Isais and Glover Gardin with Certificates of Recognition for their service.

## Future Agenda Items

The Agenda for 9/18/18 will be updated to include the presentation from the CSC By-Laws Subcommittee and include a report from staff on the process for scheduling a work-session with Council.
