#### RECOMMENDATION

#### SUMMARY

On November 6, 2018, the City of Hayward conducted a General Municipal Election, which was consolidated with the General Election. This item recommends that the City Council adopt a resolution acknowledging receipt of the Certificate of Election Results and Official Canvass of the General Municipal Election held November 6, 2018, for the Mayor, two Members of the City Council for terms of four years each, and Measure T – Real Property Transfer Tax increase.

#### BACKGROUND

On November 6, 2018, the City of Hayward conducted a General Municipal Election, which was consolidated with the General Election. The election included selection of the Mayor and two Members of the City Council for terms of four years each as well as Measure T, which proposed an increase to the City's Real Property Transfer Tax.

In accordance with the provisions of California Elections Code Section 10260 and as directed by Resolution No. 18-120 and Resolution No. 18-170 of the City Council, the Alameda County Registrar of Voters, Tim Dupuis, has completed the official canvass of returns of the General Municipal Election, which was consolidated with the General Election. The Certificate of Election Results and a copy of the Official Canvass are included as Exhibit A of the Resolution.

This agenda item is a routine operational item and does not relate to one of the Council's Strategic Initiatives.

#### RESOLUTION ACKNOWLEDGING RECEIPT OF CERTIFICATE OF ELECTION RESULTS AND OFFICIAL CANVASS BY THE CITY CLERK OF THE GENERAL MUNICIPAL ELECTION HELD NOVEMBER 6, 2018, AND DECLARING THE RESULTS THEREOF

WHEREAS, a General Municipal Election was held in the City of Hayward, California, on Tuesday, November 6, 2018, as required by law; and

WHEREAS, the General Municipal Election was authorized to be made by the Alameda County Registrar of Voters in accordance to Resolution No. 18-120 and Resolution No. 18-170; and

WHEREAS, the Alameda County Registrar of Voters canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit A; and

WHEREAS, the total number of vote by mail voter ballots cast in the City was 28,929 (41.78 percent turnout), the total number of election day ballots cast in the City was 10,925 (15.78 percent turnout), making a total of 39,854 (57.56 percent turnout) ballots cast in the City; and

WHEREAS, the names of persons voted for at the election for Mayor are as follows: Barbara Halliday and Mark Salinas; and

WHEREAS, the names of persons voted for at the election for Member of the City Council are as follows: Joe Orlando Ramos, Didacus Ramos, Sara Lamnin, Tom Ferreira, Mekia Michelle Fields, Marvin Peixoto, and Aisha Wahab; and

WHEREAS, that the number of votes given at each precinct and the number of votes given in the City to each of the persons named for the respective offices for which the persons are candidates were as listed in Exhibit A attached; and

WHEREAS, that the number of votes given at each precinct and the number of votes given in the City for and against Measure T (Real Property Transfer Tax) were as listed in Exhibit A attached.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the City Council does declare and determine that Barbara Halliday was elected as Mayor for the full term of four years; Aisha Wahab was elected as Member of the City Council for the full term of four years; and Sara Lamnin was elected as Member of the City Council for the full term of four years; and that a majority (22,358 ballots cast, 57.56 percent turnout) of voters voting on Measure T did vote in favor of it, and that Measure T was carried, and shall be deemed adopted and ratified.

FURTHERMORE, BE IT RESOLVED by the City Council that the City Clerk shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected. That the City Clerk shall certify the passage and adoption of this resolution and the ordinance approved by the voters; and enter a copy of this resolution with appropriate other entries upon the minutes of this City Council as a statement of the results of the election.

# ORDINANCE OF THE CITY OF HAYWARD, CALIFORNIA AMENDING SECTION 8-6.05 OF THE HAYWARD MUNICIPAL CODE RELATING TO REAL PROPERTY TRANSFER TAX

#### THE PEOPLE OF THE CITY OF HAYWARD DO ORDAIN AS FOLLOWS:

Section 1. Section 8-6.05 of the Hayward Municipal Code is hereby amended to read as follows:

#### SEC. 8-6.05 - IMPOSITION OF TAX.

A tax is hereby imposed on each transfer, by deed, instrument, or writing, by which any lands, tenements, or other real property located in the City are sold, granted, assigned, transferred, or otherwise conveyed to, or vested in, a purchaser or purchasers thereof, or any other person or persons at or by the direction of said purchaser or purchasers, when the value of the consideration exceeds one hundred dollars (\$100.00), said tax to be at the rate of eight dollars and fifty cents (\$8.50) for each one thousand dollars (\$1,000.00) or fractional part of one thousand dollars (\$1,000.00) of the value of the consideration.

As used herein, 'value of the consideration' shall mean the total consideration, paid or delivered, or contracted to be paid or delivered, in return for the transfer of real property, including the amount of any indebtedness, existing immediately prior to the transfer which is secured by a lien, deed of trust or other encumbrance on the property conveyed and which continues to be secured by such lien, deed of trust, or encumbrance after said transfer, and also including the amount of any indebtedness which is secured by a lien, deed of trust, or encumbrance given or placed upon the property in connection with the transfer to secure the payment of the purchase price or any part thereof which remains unpaid at the time of the transfer. Value of the consideration also includes the amount of any special assessment levied or imposed upon the property by a public body, district, or agency, where said special assessment is a lien or encumbrance on the property and the purchaser or transfere agrees to pay such special assessment or takes the property subject to the lien of such special assessment. The value of any lien or encumbrance of a type, other than those which are hereinabove specifically included, existing immediately prior to the transfer and remaining after said transfer, shall not be included in determining the value of the consideration. If the value of the consideration cannot be definitely determined or is left open to be fixed by future contingencies, value of the consideration shall be deemed to mean the fair market value of the property at the time of transfer after deducting the amount of any lien or encumbrance, if any of a type which would be excluded in determining the value of the consideration pursuant to above provisions of this section.

Section 2. To the extent allowed under Article XIII C of the California Constitution, this Ordinance may be amended by the City Council without a vote of the people, except that voter approval shall be required for any amendment that increases the tax, within the meaning of Government Code section 53750(h), beyond the levels authorized by this chapter.

Section 3. California Environmental Quality Act (CEQA). The City Council independently finds and determines that this action is exempt from CEQA pursuant to Section 15061(b)(3) of the CEQA Guidelines, as an activity that is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The general exemption applies in this instance because it can be seen with certainty that there is no possibility that the proposed amendments could have a significant effect on the environment, and thus are not subject to CEQA. Thus, it can be seen with certainty that the proposed project would not have a significant effect on the environment.

Section 4. If any section, subsection, paragraph or sentence of this Ordinance, or any part thereof, is for any reason found to be unconstitutional, invalid or beyond the authority of the City of Hayward by a court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance.

Section 5. This Ordinance shall become effective 10 days after the certification of its approval by the voters at the Election pursuant to Elections Code section 9217.

Section 6. Upon approval by the voters, the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause it to be published according to law.

Based on the guidelines listed below, Council Member Zermeño would be the next eligible Council Member to serve as Mayor Pro Tempore should the Council choose to continue the traditional selection process.

#### Mayor Pro Tempore

In even number years, the Council shall elect the Mayor Pro Tempore following the installation of those newly elected Council Members. The Mayor Pro Tempore shall serve at the pleasure of the Council for the term of one year and shall be elected and removed by the affirmative votes of at least five (5) members of Council.

In odd years, the Council Member with the most seniority as a Council Member, who has not previously served as Mayor Pro Tempore shall be elected. In the event two Council Members begin service in the same year, the Council Member with the highest number of votes will serve as Mayor Pro Tempore. (City Council Minutes, 4/28/92)

Prior to being elected as Mayor Pro Tempore, a Council Member shall have served at least two years on the Council. The term of the Mayor Pro Tempore shall be based on the fiscal year of July 1 to June 30. (Resolution 98-120 and Council Minutes, 6/26/2001)

The Mayor Pro Tempore shall perform the duties of the Mayor during her/his absence or disability. (Sec. 605, City Charter)
