# 21st Century Library Construction Update

Director Addleman stated that fire inspection was still pending. Hopeful to have temporary certificate of occupancy by end of this month. Donor leaves will be placed this week or the next.

#### VII. New Business

### **Discuss Opening Day Celebrations**

Director Addleman says the current tentative opening date is end of June, with a tentative June 29<sup>th</sup> (Saturday) opening date for the public. Make an "Open House" date with several different activities, and tours of the different floors scheduled in different languages. Would include music, maybe the Hayward Marching Band or Russell City Blues. The donor event could be the Thursday evening prior to the opening and another Wednesday evening for the different donor categories. She stated the library will need volunteers for the event, and is awaiting confirmation on the temporary certificate of occupancy, to confirm the opening date.

Commissioner Zaineb suggested tours during the first week and extra programs. She also suggested sending out communications regarding opening date early to the community.

Commission Vicechair Bufete inquired about name badges for the Library Commission.

Commissioners volunteered to help support the library opening day celebrations in the activities or as tour guides. Director Addleman is going to set up a tour for Library Commissioners to familiarize them with the building.

# **Friends of Hayward Library**

Director Addleman provided an update on behalf of the Friends of the Hayward Library. The library presented financial requests for upcoming programs, including summer reading. The food for summer reading is provided through HUSD. She would like to find food options to provide for the parents and caregivers of the children, as well, as they are also often hungry.

Commissioner Sharafali inquired about the cost of someone sponsoring food for the program.

Commissioner Zhang suggested local businesses could provide catering in exchange for advertising.

Commissioner Reynoso suggested there be food options that are healthy. A discussion ensued regarding the quality of the meals provided to children through the Hayward Unified School District.

Councilmember Mendall suggested that the commission agendize this item and write an official letter to the Hayward School District regarding their concerns over the unhealthy food options.

Commissioner Zhang inquired about the Library Commission survey creation. Commissioner Prada replied that he has the notes and will share them with the group. Commissioner Reynoso will draft the letter and bring it to the next meeting.
