#### **CLOSED SESSION ANNOUNCEMENT**

The City Council convened in closed session at 5:30 p.m., regarding the annual performance evaluation of the City Clerk pursuant to Government Code 54957. Mayor Halliday noted there was no reportable action.

#### **PRESENTATION**

Mayor Halliday acknowledged the donation of a check in the amount of \$83,000 from the Hayward Rotary Club Foundation for the Hayward Navigation Center. Mr. George Pacheco, Hayward Rotary Club Foundation member, presented the check to the City Council on behalf of Mr. Paul Martin, Hayward Rotary Club Foundation president and the Hayward Rotary Club Foundation.

#### **PUBLIC COMMENTS**

Mr. Charlie Peters, Clean Air Performance Professional representative, spoke about items related to voluntary ethanol and smog check.

Deputy City Manager Ott and City staff provided language clarification related to the proposed local ordinance, introduced on February 4, 2020; the effective dates and rates compared against State law, and the \$20,000 per year notification cost.

City Attorney Lawson noted the clarifying language for small employers specified that increases on July 1, 2021 and July 1, 2022 cannot exceed a total of \$15 per hour before it merges with the State rate in January 2023. City Attorney Lawson recommended the clarifying language be included in the motion.

Discussion ensued among Council members and City staff regarding further changes to the proposed ordinance and amending the ordinance after its adoption to have small and large employers match to the January date. It was noted that further amendments or clarifications could be brought before the Council Economic Development Committee.

issuer of tax-exempt bonds known as Workforce Housing Revenue Bonds; CalCHA's Joint Exercise of Powers Act (JPA) and representation on the Board; Catalyst Housing Group's role as the asset manager of acquisitions and developments; temporary relocation assistance for existing tenants; housing programs involving issuance of municipal bonds; and the City Manager's authority to enter into purchase option agreements.

There being no public comments, Mayor Halliday opened and closed public comments at 8:34 p.m.

Members of the City Council were in general agreement to become a member of the California Community Housing Agency (CalCHA); support CalCHA's issuance of tax-exempt bonds for the production, preservation and protection of essential middle-income rental housing; and authorize the City Manager to execute purchase option agreements with CalCHA to acquire middle-income rental housing. Council members provided the following recommendations: ensure there is a mechanism in place to prevent displacement of existing tenants; evaluate ownership opportunities for existing tenants when the City has the option to purchase a property financed with the proposed financing model using tax-exempt bonds; provide information on CalCHA Board meetings to remain informed and involved; explore the opportunity to leverage mortgage/asset-backed securities into the proposed financing model; and make sure FPI Property Management will not manage properties acquired with the proposed financing model.

The City Council took a brief recess and reconvened the meeting at 9:19 p.m.

10. Mission Boulevard Phase 2 Construction and Mission Boulevard Phase 3 Design: Receive an Update on the Construction and Design Phases of the Mission Blvd Project and Provide Comments (Report from Public Works Director Ameri) **WS 20-009** 

Staff report submitted by Public Works Director Ameri, dated February 25, 2020, was filed.

Public Works Director Ameri announced the report and introduced Senior Civil Engineer Hung who provided a synopsis of the staff report.

Mayor Halliday opened public comments at 9:38 p.m.

Ms. Susie Hufstader, Bike East Bay Advocacy Manager, expressed support for the Mission Boulevard Corridor improvements and proposed raised cycle track design, and encouraged to look for opportunity areas to create more pedestrian space.

Ms. Lacei Amodei, Hayward resident, supported the Mission Boulevard Corridor improvements from a climate change, quality infrastructure and equity perspective.

Mayor Halliday closed public comments at 9:45 p.m.

Council Member Salinas disclosed he resides near the Mission Boulevard Phase 3 improvement project and was advised he could participate in the discussion.

Discussion ensued among Council members and City staff regarding: cleaning of divider planter islands; plan for businesses during the construction of Mission Boulevard Phase 3 improvements; traffic at A Street and Mission Boulevard related to the new business; dimensions of designs and plant maintenance at Fairway Park Sign and Blanche Street Gateway; and the metal fence.

Council members expressed general appreciation for the update to the construction of the Mission Boulevard Improvements Phase 2 and the design of the Mission Boulevard Improvements Phase 3 projects. Council members offered the following recommendations: keep an eye for ACTC possible alternative consideration of moving stops for bus rapid transit from Mission Boulevard to Foothill Boulevard; after construction of the metal fence is complete, bring to a Council Infrastructure Committee meeting options for the green shade, possible art work and cost estimates; consider a light fixture that directs the light in an upward direction for the entry monument at Rose Street and Mission Boulevard; keep the "No Room for Racism" sign and confer with the business owners and the Fairway Park neighborhood about its placement; explore redesigning the signage at the corner of A Street and Mission Boulevard to match with other signs along Mission Boulevard; make sure all crosswalks are painted; ensure traffic lights are synchronized; make sure streets are well lit; make sure there are visible street reflectors to differentiate areas and at the beginning of divider planter islands; ensure upkeep and maintenance of sidewalks along Mission Boulevard; and make the area as safe as possible for bicyclists.

Bike East Bay was commended for its contribution to the projects' improvements.

Discussion ensued among Council members, City staff, Beckie Menten, Building Electrification and Energy Efficiency program manager, and an East Bay Community Energy consultant regarding: cost to build all-electric; resiliency planning and how East Bay Community Energy (EBCE) can support resiliency; emergency planning considering the number of people who might be affected; outreach to the development community and

input; residential solar and storage program; housing affordability; and battery backup for all-electric homes.

Mr. Ben Granholm, Western Propane Gas Association (WPGA) representative, noted WPGA was supportive of decarbonizing efforts and noted that residents should have access to diverse energy options and disagreed with the cost-effective study.

Mr. Charlie Peters, Clean Air Performance Professionals representative, spoke about natural gas and expressed concern about who would benefit from all energy suppliers.

Ms. Beckie Menten, Building Electrification and Energy Efficiency program manager, applauded the City for bringing forward electrification reach codes and spoke about the need for electric buildings and the affordability.

Mayor Halliday closed the public hearing at 8:46 p.m.

Council Member Mendall offered a motion per staff's recommendation, including revisions to the resolution regarding subsections 5 and 6 of Section 1: Findings and Determinations.

Council Member Wahab seconded the motion.

Council Member Mendall noted the proposal would make the building inspection process faster and smoother, cost less to build, have less risk of a catastrophic explosion from gas lines, and help meet greenhouse gas reduction goals.

Members of the Council Sustainability Committee, Council Members Mendall, Zermeño, and Marquez, as well as City staff, were commended for helping prepare building and vehicle electrification reach codes.

It was moved by Council Member Mendall, seconded by Council Member Wahab, and carried unanimously, to approve the resolution including revisions regarding subsections 5 and 6 of Section 1: Findings and Determinations:

#### RECOMMENDATION

That Council adopts a Resolution (Attachment II) rejecting all bids for the Sewer Line Replacement Project, Project No. 07694, approving the revised plans and specifications incorporating revised bidding requirements and Addendum No. 1, and calling for construction bids to be received on April 7, 2020.

#### **SUMMARY**

This project will replace approximately 4,300 linear feet of 6-inch to 10-inch vitrified clay pipe (VCP) with 8-inch and 10-inch polyvinyl chloride (PVC) pipe by traditional open-cut method. In addition, approximately 660 linear feet of 12-inch asbestos cement pipe (ACP) will be rehabilitated by a cured-in-place pipe liner. On March 3, 2020, four (4) bids were received ranging from \$1,747,520 to \$2,038,000. On March 6, 2020, the second lowest bidder informed the City that the low bidder did not include Department of Industrial Relations (DIR) registration numbers with their listing of subcontractors. Upon review of Public Contract Code 4104, the City is required to provide in the specification a requirement for bidders to include public works contractor registration numbers with the bid. For this project, two of the four bidders did not include DIR registration numbers including the low bidder. Therefore, staff is requesting Council approval to reject all bids, approval of the revised plans and specifications incorporating revised bidding requirements and Addendum No. 1, and authorization calling for construction bids to be received by April 7, 2020.

#### **BACKGROUND**

The City's current Capital Improvement Program includes funding to replace the City's undersized and/or structurally damaged sewer mains through annual sewer line replacement projects. The City's sanitary sewer collection system was mostly constructed after World War II. Among its 325 miles of sewer pipelines, approximately 9% of the sewer mains are four or six inches in diameter. As the City grew over subsequent decades, sewer flows have increased and as a result, a majority of these small size sewer mains are now undersized. Industry experience has shown that these small diameter pipes are more likely to cause

overflows and blockages in the system than 8-inch pipes. Therefore, the City has adopted a standard minimum sanitary sewer main size of eight inches.

The Utilities Division staff performs regular sewer main cleaning and has an ongoing program to monitor and inspect the condition of the City's sanitary sewer collection system using closed circuit television (CCTV) technology. The inspection is performed by placing a camera, mounted on tracks, inside a sewer pipe and remotely guiding it through the length of the pipe. As the camera moves forward, it sends back video to a TV monitor that enables the staff to inspect the condition of the pipe. These inspections are used to identify structurally damaged sewer mains for repair or replacement. The sewer mains selected for this project were identified as having structural defects or being undersized.

Approximately 4,300 linear feet of existing pipe will be replaced with 8-inch and 10-inch polyvinyl chloride (PVC) pipe by traditional open-cut method. Traditional open-cut sewer repair involves excavating a trench of approximately two to four feet in width and to the depth of the damaged or undersized pipe. Once the sewer main is exposed, the damaged or undersized section is removed and replaced with new PVC pipe. At the same time a portion of the existing sewer laterals that connect to the sewer are replaced and service restored. When the repair is complete, the opened trench is backfilled, compacted, and paved to match the original pavement section. The locations of open-cut replacement are on E Street, 1st Street, Armstrong Street, Main Street, Vallejo Street, Sunset Boulevard, and Fletcher Lane.

The remaining 660 linear feet will be rehabilitated by a trenchless pipe replacement technique known as cured-in-place pipe (CIPP). CIPP involves inserting a resin-impregnated flexible tube into the pipe, inflating, and curing with hot water or steam forming a structurally sound, water-tight new pipe within-a-pipe that has all the structural properties of a standalone pipe.

This project also includes installation of new manholes in areas where there is a distance more than 350 feet between manholes to facilitate future maintenance, as Hydro cleaning and CCTV equipment operate best within a range of 350 feet.

#### **DISCUSSION**

On July 16, 2019, Council approved the plans and specifications for the project and called for bids to be received on August 20, 2019. Shortly after approval to advertise for bids, staff discovered that a portion of one of the pipelines originally included in the project was in private property. In addition, another pipeline was identified by CCTV video to have a severely eroded base with a portion of the pipeline potentially at risk for imminent collapse. Staff dropped the pipeline in the private easement from the project and added the severely eroded pipeline to the project resulting in a delay in advertising and opening bids. Subsequently, Staff decided to delay the project to advertise and bid in early 2020 to allow the City to take advantage of a traditionally more competitive bidding climate and spring/summer construction period. This also provided the opportunity to allow construction to proceed on E Street in front of Bret Harte Middle School during summer break resulting in less disruption to the school caused by construction activities. Subsequently, the bid date was postponed to March 3, 2020.

On March 3, 2020 the City received four (4) bids for the project, ranging from \$1,747,520 to \$2,038,000. Andes Construction Inc. submitted the low bid in the amount of \$1,747,520, which is approximately 19% below the Engineer's estimate of \$2,152,000.

On March 6, 2020 the City was informed by the second to low bidder that the low bidder did not list the Department of Industrial Relations (DIR) registration numbers for the listed subcontractors on the bid form. Upon review of Public Contract Code 4104, the City must require bidders include public works contractor registration numbers with the bid. Because the City's bidding instructions did not explicitly require the DIR registration numbers be listed in the bid form, two of the four contractors did not include the registration numbers for their subcontractors including the low bidder. Therefore, Staff is requesting Council's approval to reject all bids, approve revised plans and specifications incorporating revised bidding requirements and Addendum No. 1, and authorization calling for bids to be received by April 7, 2020.

#### **ECONOMIC IMPACT**

Construction of this project would be subject to the requirements of the Community Workforce Agreement, which provides potential local economic benefits, such as the hiring of Hayward residents.

#### FISCAL IMPACT

The adopted FY2020 Capital Improvement Program (CIP) includes \$2,620,000 for the Sewer Line Replacement Project, Project No. 07694. Staff anticipates rebidding the project should not materially affect the bid results and the project should be well under the budgeted amount for the FY2020 sewer line replacement CIP.

#### STRATEGIC ROADMAP

This agenda item supports the Strategic Priority of Infrastructure. Specifically, this item relates to the implementation of the following project:

Project 15: Upgrade sewer collection system by replacing 3-4 miles of sewer lines annually.

A separate CIP project will be implemented later this year to incorporate upgrades to additional sewer collection system pipelines.

#### SUSTAINABILITY FEATURES

The repair and replacement of deteriorating sewer lines reduces the risk of sewer overflows, which can cause untreated wastewater to flow into public waterways.

#### PUBLIC CONTACT

This project is statutorily exempt from environmental review under the California Environmental Quality Act (CEQA) Section 15282(k), which allows for the repair and restoration of an existing subsurface pipeline, provided the project does not exceed one mile in length.

#### **NEXT STEPS**

If Council adopts the attached resolution, staff will send a formal rejection notice to all four bidders. If Council approves re-advertising the project for public bidding, staff will return to Council for the award of the construction contract after construction bids have been received and reviewed.

#### **SUMMARY**

On March 11, 2020, the City Manager, in her capacity as Director of Emergency Services, proclaimed a local emergency due to the ongoing spread of a severe acute respiratory illness in Alameda County caused by a novel coronavirus (COVID -19). This report requests that the City Council approve a resolution ratifying the Proclamation of a Local Emergency (Attachment III), which empowers the Director of Emergency Services to make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by such local emergency.

#### **BACKGROUND AND DISCUSSION**

On March 1, 2020, the Alameda County Public Health Department and Solano County Public Health Department reported two presumptive cases of COVID-19, pending confirmatory testing by the Centers for Disease Control (CDC), prompting Alameda County to declare a local health emergency.

On March 11, 2020, the City Manager, in her capacity as Director of Emergency Services, proclaimed a local emergency due to the spread of COVID-19, including several confirmed cases in Alameda County and many more in the San Francisco Bay Area.

The City Manager is empowered to proclaim a local emergency pursuant to California Government Code Section 8630 and Hayward Municipal Code Section 3-2.12. When a local emergency is proclaimed by the Director of Emergency Services, the Council must ratify the

proclamation within seven (7) days or the proclamation has no further effect. This item requests that the City Council ratify the resolution for the Proclamation of Local Emergency due to COVID-19.

A Proclamation of Local Emergency allows the Director of Emergency Services to make rules and regulations related to the protection of life and property, obtain vital supplies and equipment needed for the protection of life and property, and require emergency services of City officers and employees in their roles as designated Disaster Services Workers.

#### **FISCAL IMPACT**

This resolution enables the City to request certain emergency funds from State and Federal sources as they become available and enables the City Manager and assigned staff to efficiently allocate resources due to the ongoing and imminent threat to public safety.

WHEREAS, in accordance with authority granted under the above provisions of state and local law, the Director of Emergency Services beginning on March 11, 2020 did proclaim the existence of a local emergency caused by epidemic in the form of the global spread of a severe acute respiratory illness caused by a novel (new) coronavirus ("COVID-19"), including confirmed cases in the San Francisco Bay Area and Alameda County prompting the County to declare a local health emergency; and

NOW, THEREFORE BE IT RESOLVED by the Council of the City of Hayward that it is hereby proclaimed and ordered that the Proclamation of Local Emergency, issued by the Director of Emergency Services, is hereby ratified and confirmed; and

BE IT FURTHER RESOLVED that during the existence of this local emergency the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law, and the Charter, ordinances, resolutions and approved plans of the City of Hayward.

BE IT PROCLAIMED by the Director of Emergency Services of the City of Hayward as follows:

WHEREAS, the California Emergency Services Act, Government Code sections 8558(c) and 8630 authorize the proclamation of a local emergency when conditions of disaster or extreme peril to the safety of persons and property within the territorial limits of a city exist; and

WHEREAS, pursuant to Government Code section 8630 such an emergency may be proclaimed by the governing body or by an official designated by ordinance adopted by the governing body; and

WHEREAS, Hayward Municipal Code section 3-2.12 provides that the City Manager, serving as the Director of Emergency Services, may request the City Council to proclaim the existence of a local emergency; and

WHEREAS, under provision of local law, if the City Council cannot be convened and, in the judgment of the Director of Emergency Services, the circumstances warrant it, she may issue a proclamation of local emergency which must be ratified or nullified by the City Council within seven days of issuance; and

WHEREAS, in accordance with my authority under the above provisions of state and local law as Director of Emergency Services; and

WHEREAS, the circumstances of extreme peril to public safety described below are so severe and require immediate remedial action that there is not sufficient time to call an emergency meeting of the City Council; and

WHEREAS, as Director of Emergency Services, I have determined that the proclamation of a local emergency is warranted by virtue of the extreme peril to the safety of persons and property in the City caused by epidemic in the form of the global spread of a severe acute respiratory illness caused by a novel (new) coronavirus ("COVID-19"), including several confirmed cases in Alameda County and dozens more in the San Francisco Bay Area, prompting the County to declare a local health emergency.

BE IT FURTHER PROCLAIMED that this proclamation shall be in effect for a period of seven days, by which time it must be ratified by the Council of the City of Hayward, pursuant to Government Code section 8630.

NOW, THEREFORE, I HEREBY PROCLAIM that, effective immediately, a local emergency now exists in the City as a result of the circumstances described above.

BE IT FURTHER ORDERED THAT all City officers and employees take all steps requested by the City Manager to prevent the spread of COVI D-19 and to prevent or alleviate illness or death due to the virus; and

BE IT FURTHER ORDERED THAT all City officers and employees take all steps requested by the City Manager to qualify the City for reimbursement from the Federal Emergency Management Agency and for other state and federal relief as may be available to reimburse the City for the expenses it incurs in addressing this emergency.

Proposed FY 2020 mid-year expenditures net a total increase of \$5.7 million in General Fund expenses. Of this amount, \$5.1 million is related to previously authorized and approved appropriations, and proposed FY 2020 mid-year expenditure requests total increase of \$0.6 million. The proposed FY 2020 mid-year expenditures are largely one-time in nature. # **BACKGROUND**

On May 21, 2019, Council adopted the FY 2020 Operating Budget projecting a net positive position at fiscal year end and an increase to the General Fund Reserves of \$0.3 million¹. Since the time of adoption of the FY 2020 Budget, the City's projected fiscal position has changed significantly. As a result of additional Council approved appropriations and proposed mid-year requests, the City's General Fund net position decreased, projecting a use of \$1.9 million in reserves to balance the budget. The largest of these appropriations is related to demolition expenses for the recently acquired City Center building. In December, Council authorized a General Fund appropriation of \$4.4 to fund hazardous materials abatement and demolition of the City Center building². Demolition of the City Center building is considered a one-time expense. It is expected that expenses related to the acquisition and demolition of the City Center building could potentially be fully recovered upon the sale of the property. The Council has approved an additional \$0.7 million in other appropriations related to contract services and grant appropriations since the adoption of the FY 2020 Operating Budget.

On January 15, 2020, an update to the General Fund Long Range Financial Model was presented to the Council Budget and Finance Committee for review and feedback.

This report includes an update to the model as part of the FY 2020 mid-year review, reflecting the proposed changes in revenue projections and expenditure adjustments.

### DISCUSSION

### **GENERAL FUND REVENUES**

FY 2020 General Fund revenues are projected to be \$3.5 million higher than originally projected. This is primarily attributed to projected increases in sales tax revenues and Cannabis Tax revenue projections.

The following analysis highlights key revenue variances as it pertains to FY 2020 mid-year projections and the impact on future year projections as outlined in the model.

<u>Sales Tax (increase of \$3.7 million)</u> – The amount projected at the time of adoption did not anticipate continued growth in the economy. Previous forecasts projected a slowing of the economy in FY 2020. Preliminary projections also did not account for significant short-term growth in the transportation industry.

<u>Cannabis Tax (decrease of \$250,000)</u> – The FY 2020 Adopted Budget projected Cannabis Tax revenue at \$250,000. Many of the approved cannabis business operators are still working to complete the entitlement process. This adjustment is to reflect actual Cannabis Tax receipts received thus far.

FY 2020 General Fund total adjustments include FY 2019 carryforwards, previous Council authorized and approved appropriations, and mid-year requests. FY 2020 General Fund expenditures, including proposed mid-year requests and previous Council authorized and approved appropriations are projected to be \$5.7 million higher than anticipated at the time the City adopted its budget. Of this amount, \$5.1 million is related to previously authorized and approved appropriations, and proposed FY 2020 mid-year expenditure requests total an increase of \$0.6 million. The proposed FY 2020 mid-year requests are largely one-time in nature. FY 2019 budget carryforwards total \$1.4 million and were approved with the FY 2019 Operating Budget. The following analysis highlights key expenditure variances as it pertains to FY 2020 mid-year projections and the fiscal impacts on future year projections, as illustrated in the model.

# Staffing Expense

Overall, the staffing expense budget will increase by a net total of \$246,268. The following provides detail on the changes in the staffing expense budget:

• Staffing Changes (decrease of \$6,474) – A net change of 0.0 FTE in the Finance Department is included as part of the mid-year review. In order to better serve the business needs of the department, staff proposes that one (1.0) Finance Technician position be deleted and replaced by one (1.0) Administrative Secretary position. Table 3 below summarizes the fiscal impact. This change results in a net salary savings.

- Overtime Expense (increase of \$9,703) Appropriation to increase overtime expenses for activities related to illegal tobacco sales enforcement, offset by a California State Department of Justice grant.
- <u>Salary Plan Update (increase of \$243,039)</u> An update to the Salary Plan was approved by Council on December 17, 2019. The Salary Plan update included equity adjustments per the SEIU MOU on a recent salary survey completed in accordance with the terms as outlined in the negotiated agreement with SEIU, and additional adjustments to other specific job classifications.

### Operating Expenses

A number of adjustments are needed at mid-year to fund necessary and/or unanticipated expenditures, and to appropriate prior year carried forward requests into FY 2020.

# <u>Carryforward Requests (increase of \$1.4 million)</u>:

A carryforward is unspent budget that is linked to a commitment such as a contract, requisition, or purchase order. The carryforward of commitment to a new fiscal year carries with it the unspent budget associated with the balance of the commitment. Carryforward represent budget amounts that were previously authorized and approved by Council during the prior fiscal year.

# <u>Previous Council Approved Appropriations - FY 2020 (increase of \$4.8 million)</u>:

City Council previously authorized and approved appropriations totaling \$4.8 million. Previously authorized and approved appropriations are as follows:

- City Center Demolition (increase of \$4,401,150);
- City parking enforcement vehicle/equipment (increase of \$95,000);
- Security measures/services at Maple/Main development project site (increase of \$142,000);
- Byrne Grant Award allocation (increase of \$42,492)
- Delinquency Prevention Network (DPN) contract award appropriation (increase of \$8,950); and
- Contract Services for Strategic Planning Services (increase of \$108,881)

# Proposed FY 2020 Mid-Year Requests – New (Increase of \$646,577):

- <u>Transfer In/Out (increase of \$110,000)</u>: \$12,000 transfer-out to Hayward Area Shoreline JPA fund (HASPA); \$70,000 transfer-out to Facilities Management Fund for unanticipated PG&E costs for the Library; and \$28,000 transfer-out to Facilities Capital for Space Planning project
- PERB Settlement (increase of \$7,393) Increase of \$7,393 for final PERB Settlement.
- Contract Services (net increase of \$467,000) Additional contract services are necessary in multiple departments. Development Services is requesting \$400,000 for consultant services for outside plan check, inspection, and permit technicians with anticipated offsetting revenue; a reduction of \$12,000 for annual HASPA contributions (General Fund); an increase of \$25,000 for executive search services for a key executive position vacancy in Human Resources; \$14,000 for consulting services for new technology pilot program in Human Resources; and \$40,000 for contract services related to additional audit work.
- Office/Operating Supplies (increase of \$62,184) The Police Department is requesting an increase of \$33,000 for latent print software previously approved by City Council (General Fund). The Human Resources department is requesting \$22,000 for the purchase of NeoGov performance management software (General Fund). Library is requesting an increase of \$7,184 in expenses to be reimbursed by the Literacy Council. All expenses related to Literacy Council are fully reimbursable.

The amounts shown below in Table 4 demonstrate the General Fund impact of the changes being proposed as part of the City's FY 2020 Mid-Year Budget Review from the time that Council adopted the City's Operating Budget in May of 2019. In total, the changes presented for consideration will require the projected use of \$1.8 million in General Fund reserves.



# GENERAL FUND LONG RANGE FINANCIAL MODEL UPDATE

**Attachment V** is an updated version of the model that includes projected changes in revenue and expenses impacting the City's projected year-end fiscal position for FY 2020. The FY 2020 Adopted Budget assumed an increase in General Fund Reserves of \$0.3 million by the end of the fiscal year. The model projected that General Fund Reserves would remain above 20% of the City's budgeted General Fund expenditures until the end of FY 2022, at which time reserve levels would dip to 15.9% of expenditures.

As part of the mid-year review process, the model has been updated to include current revenue projections, mid-year expenditure requests, and previous Council approved appropriations as discussed in this report. The updated model projects the use of \$1.8 million in General Fund Reserves. The significant change is primarily attributed to the Council approved appropriation of \$4.4 million for the City Center demolition. While the potential sale of the property could result in full cost recovery, the model does not include revenue assumptions should the sale of the property occur in the future.

Per current policy, General Fund Reserve should equal 20% of budgeted General Fund expenditures. Based on the updated model and current projections, the City is expected to fall short of compliance with the policy. Mid-year updates to the model project ending the fiscal year with a General Fund balance of 19.7% of FY 2020 General Fund expenditures. The graph below depicts revised General Fund revenues and expenditures based on updated FY 2020 projections.



# **MEASURE C FUND**

# Measure C Operating

The Council, as well as the ballot language for Measure C, established a number of spending priorities for these funds. These priorities include a mix of capital projects and funding allocations toward operating services. While Measure C revenues are to primarily be used to fund capital projects, operating activities, such as police services, addressing illegal dumping, litter control, and graffiti abatement also fulfill the promises of Measure C.

FY 2020 Measure C operating fund total adjustments include FY 2019 carryforwards, previous Council approved appropriations, and a mid-year request. Proposed FY 2020 Measure C expenditure related requests total an increase of \$83,518. Proposed FY 2020 Measure C revenue is projected to be approximately \$1.4 million higher than originally projected. The following details the additional requests:

- FY 2019 budget carryforwards (increase of \$8,152)
- Salary Plan Update (increase \$23,209)
- Transfer-Out to Measure C Capital Fund for EBRCS Radio Final Lease Payment (increase of \$52,157).

# Measure C Capital

While Measure C funds operating programs and related expenses, Measure C funds are primarily used to fund capital projects. FY 2020 Measure C capital total adjustments include prior year carryforwards.

FY 2020 Council adopted expenditure appropriations of \$30.9 million in the Measure C capital fund. Total adjustments included in the mid-year review are \$34.4 million. Included in these adjustments are:

- \$34.3 million in FY 2019 carryforwards; and
- \$52,157 in proposed mid-year request

The FY 2020 Measure C capital mid-year request is to make the final lease payment for EBRCS radios.

Attachment VI is an update to the Measure C 20-Year Financial Forecast that includes projected changes in revenue and expenses impacting the projected year-end fiscal position for FY 2020.

# OTHER FUNDS

Total adjustments for FY 2020 Other Funds include FY 2019 carryforwards, previous Council approved appropriations, and mid-year requests. Expenditure increases in Other Funds total \$21.4 million. Of this total, FY 2019 budget carryforwards total \$15.1 million; and appropriations previously approved by City Council total \$5.7 million. Increase in expenditure requests at mid-year amount to \$0.6 million. Detail of mid-year requests are as follows:

# Proposed Mid-Year Requests (increase of \$0.6 million)

- Staffing Changes (net-zero impact): A net change of 0.0 FTE in the Information Technology Department is included as part of the mid-year review. In order to better serve the business needs of the department, it is proposed that one (1.0) IT Analyst position be deleted and replaced with one (1.0) Programmer Analyst position.
- Water and Sewer Funds (decrease of \$200,000): Administrative cleanup to remove transfers completed in the prior fiscal year to complete the safety-gap analysis;
- Maintenance Operations (increase of \$265,000): Increase of \$45,000 for contract services
  for temporary staffing to support the ongoing janitorial needs at the library during
  operational hours (Facilities Management Fund); \$70,000 for unanticipated PG&E
  expenses at the library (Facilities Management Fund); and \$150,000 vehicle replacement
  of two patrol vehicles totaled in recent accidents;
- PERB settlements (increase of \$10,632): Water Fund (\$6,941) and Sewer Fund (\$3,691);
- Police Department (increase of \$43,000): Increase of \$38,000 in Asset Forfeiture fund for the purchase of schedule express software, and \$5,000 for CNOA conference attendance;
- City Manager (net increase of 35,769): a reduction of \$20,989 to match the FY 2020 Federal HOME award project allocation, a net zero impact between funds Measure B Paratransit, Federal Grants, Housing Authority, and Affordable Housing for personnel reallocation, and \$56,758 for CDBG Public Services Program with expenditures offset by congruent revenue.

- Hazmat Settlements (increase of \$410,365): Increase to appropriate prior year fund balances from hazmat settlements.
- Hayward Area Shoreline JPA (increase of \$12,000): Appropriation of the City's contribution to the Hayward Area Shoreline JPA.

# **CAPITAL IMPROVEMENT FUNDS**

Total adjustments for FY 2020 Capital Improvement Funds include FY 2019 carryforwards, previous Council approved appropriations, and mid-year requests. The FY 2020 Capital Improvement Budget adjustments total a net increase of \$188.7 million. Of this amount, FY 2019 carry forwards total \$168.4 million; and prior Council authorized and approved appropriations total \$10.2 million. Proposed mid-year adjustments reflect an increase in projected expenditures in the amount of \$10.1 million. **Table 5** provides detail of the proposed FY 2020 CIP mid-year changes.

# COUNCIL SUPPORTED FISCAL STRATEGIES - LONG-TERM FINANCIAL OUTLOOK:

On January 15, 2020³, staff presented the Council Budget and Finance Committee with an update to the General Fund model. Despite the successful passage of Measure T, the long-term projection showed a significant continued structural deficit. In response to the review of the model, staff reviewed the strategies presented to the City Council during the Fiscal Sustainability work session held in October 2017. During the work session, staff unveiled the updated Model, and Council discussed various strategies in four categories to address the City's structural budget deficit, which included (1) revenue generating strategies, (2) cost shifting strategies, (3) expenditure control strategies, and (4) changes in provision of services that Council could implement to assist in closing the City's long-term structural budget gap.

Table 6 is a summary of Council supported strategies at the October 2017 fiscal sustainability work session. A status of each strategy is included to provide Council with an update on strategies that have yet to be implemented and may be reviewed and recommended for the full Council to assist with closing the projected structural budget gap.

The long-term financial projections show a continued structural deficit. To address this issue, there are two remaining supported strategies that can be deployed to positively impact the long-term fiscal health of the City. Staff solicited feedback from the Committee on the remaining two revenue generating strategies - an increase to the City's TOT and/or an overhaul of the City's Business License Tax Ordinance. During the presentation of these two strategies, the Committee recommended that staff proceed with presenting an increase to the City's TOT to the full Council for consideration to include on the November 2020 ballot.

The City of Hayward's TOT rate of 8.5 percent is the twelfth lowest among sixteen Bay Area cities of 100,000 or more residents, according to analysis provided by Management Partners for the October 2017 work session. Staff analysis performed in 2018 estimated that an increase in TOT to a new rate of 12.0 percent would generate an additional \$986,000 annually. Assuming the passage of a ballot measure in 2020, the Model estimates that a 12.0 percent TOT rate will generate an additional \$519,240 in FY 2021 and an average of \$859,900 annually through FY 2030. Analysis of additional strategies and updates to the Model will be provided to Council on an ongoing basis for their continued policy leadership in helping to ensure fiscal sustainability for the City while ensuring the highest level of service availability to the Hayward community.

Based on the Committee's recommendation, staff is seeking Council's direction as to whether it would recommend the placing of the increase to the City's TOT on the November 2020 ballot. To assist in Council deliberations and a final decision on whether to proceed to the ballot with an increase in the TOT, staff have requested a proposal from the City's preferred public-opinion research firm, Fairbanks, Maslin, Maullin, Metz & Associates (FM3) for a survey, or poll, to gauge voter support and attitudes on the subject. FM3 is prepared to work with staff to draft a survey that could administered in April with results presented later that month or in early. Depending on survey length (15 or 20 minutes) and sample size (400 or 600 respondents), the survey cost would range from \$29,500 to \$37,500.

In addition to gauging voter support and attitudes about a potential TOT-rate increase, the survey also affords the City to test opinion on related and other fiscal matters. Staff recommends that Council proceed with the polling at this time to further inform decision making on a possible ballot measure.

Project 1, Part 1.a.: Evaluate an increase in the Transient Occupancy Tax

### FISCAL IMPACT

The overall fiscal impact of the proposed mid-year adjustments is an increase to General Fund revenue of \$3.5 million, and an increase to General Fund expenditures of \$7.1 million (\$5.1 million in previously approved appropriations, \$0.6 million in proposed new requests; and \$1.4 million in carryforwards). All Other Funds (including Measure C) proposed adjustments will result in an increase of \$0.7 million in newly requested expenditures; and Capital Improvement Funds will result in a proposed net increase in expenditures of \$10.1 million in newly requested expenditures.

# **SUSTAINABILITY FEATURES**

The actions in this report do not have an impact on sustainability. Sustainability elements are more directly identified with specific projects as they are carried out.

# PUBLIC CONTACT/NEXT STEPS

Upon approval by Council of the recommendations contain herein, staff will post the budget amendments per the approved resolution. Staff will continue to refine the General Fund Long Range Model as part of the upcoming FY 2021 budget process. Staff will also proceed with polling on a potential November 2020 ballot measure, if directed by City Council to do so.



#### **BACKGROUND**

Hayward, like other cities in the Bay Area, is experiencing rising housing prices, severe housing instability for its most vulnerable populations, displacement of existing residents, and increasing homelessness. The increase in Hayward's and the Bay Area's population, absent a corresponding increase in housing units, has caused rents and prices to rise as supply has failed to meet demand. *Figure 1* illustrates the disparity between job growth in the region and housing production, which has increased demand for housing throughout the Bay Area and the low housing production rates for moderate-income households<sup>1</sup>.

The City has been actively pursuing policies and programs to help alleviate the issues facing the Hayward community due to the housing crisis. Over the past three years, the City Council

has subsidized the development of 259 units of affordable housing, adopted a new Residential Rent Stabilization and Tenant Protection Ordinance, updated the Affordable Housing Ordinance, and approved numerous residential developments that include on-site affordable units or are exclusively affordable.

On February 25, 2020<sup>2</sup>, Council held a work session to discuss the proposed financing model that supports the development and/or preservation of middle-income housing. Council was generally supportive of the items, but identified topics for further review including:

- Add limitations to the City Manager's authority to ensure periodic review of the program by Council.
- Ensure that there is a mechanism to prevent displacement of the existing tenants if the program is used to acquire occupied rental housing.
- Ensure that FPI Property Management will not be responsible for managing properties acquired utilizing the financing.
- Ensure that, when the City exercises its option to purchase, that it evaluates the possibility of transferring ownership to existing residents.

On March 3, 2020, Council approved a workplan to incentivize housing production in the City of Hayward, which included a proposal to pilot a moderate-income affordable housing financing model. This model would utilize tax-exempt bonds to finance the development and/or acquisition of essential middle income housing and would require that the City join the newly formed CalCHA, support CalCHA's issuance of tax-exempt bonds for the production, preservation and protection of essential middle-income housing, and authorize the City Manager to execute purchase option agreements with CalCHA for each housing project.

The purpose of this staff report is to discuss items posed by Council for further review and seek authorization to participate in the financing model.

#### Housing Element Compliance and Progress Reports.

Local jurisdictions report their progress meeting their RHNA goals. *Table 1* (below) reflects the progress made towards meeting Hayward's RHNA goal as of the last report year (2018), estimated progress based on number of units entitled, and progress based on projects seeking approval, for the period between 2015-2023. *Table 2* provides the income limits associated with each income category for Alameda County. Permits to construct the units must be issued in order to count toward the City's RHNA goals.

Hayward's progress towards meeting the current RHNA goals identifies the need to incentivize housing for very low-, low-, and moderate-income households. The City has the lowest compliance rate for moderate income households. Over the last Housing Element cycle, most cities did not meet their RHNA goals. In order to meet the RHNA goals, the City will have to approve a mix of 100% affordable housing properties and large mixed-income properties. Small mixed-income properties will not provide enough units to meet the goal. Additionally, the City needs to explore new financing mechanisms that can be used to fund moderate income housing to incentivize housing for the missing middle.

#### California Community Housing Authority (CalCHA)

In January 2019, the County of Kings and the Housing Authority of Kings County formed the CalCHA under the Joint Exercise of Powers Act. The purpose of CalCHA is to issue tax exempt bonds to finance affordable housing developments. Specifically, CalCHA has the authority to

acquire, construct, improve, operate, and dispose of real property. A copy of the original Joint Exercise of Powers Agreement can be found in Attachment III. To date, the cities of Burlingame, Fairfield, Larkspur, Menlo Park, Mountain View, Napa, and Santa Rosa, and the County of Marin, have joined as members of CalCHA.

#### DISCUSSION

The purpose of this staff report is to address comments from the City Council from the February 25, 2020³ work session about the proposed financing model and to seek authorization to participate in the financing model to support the development of middle-income housing. A brief summary of the proposed financing model follows. More information can be found in the February 25, 2020 staff report.

# Summary of Proposed Financing Model

The proposed financing model will use Essential Housing Revenue Bonds to fund the development of rental housing or acquisition of existing housing. The use of these bond funds reduces the projects financing costs and eliminates property tax burden. This enables the owner to charge lower rents and target middle income households. However, to utilize these bond funds, the owner must provide a public benefit.

<u>Public Benefit.</u> Public benefit is achieved through the execution of a regulatory agreement which restricts the use of the property, and by granting all surplus project revenues to the City. The regulatory agreement that restrict use of the property will

- Restrict the occupancy to low-income, median-income, and moderate-income households,
- Limits rent increases to the lesser of the applicable rent limits or 4% of tenants rent, and
- Prevents displacement of existing residents that do not meet the income eligibility requirements.

<u>City's Role</u>. The City's participation in the project is required to create a public benefit. In order for Catalyst to use the proposed financing model in the City of Hayward, the City would need to:

- Become a member of CalCHA;
- Approve CalCHA's issuance of tax-exempt bonds for the acquisition of existing rental properties or development of new housing as a means towards the preservation and protection of essential middle-income rental housing within City limits;
- Enter into a Purchase Option Agreement with CalCHA; and
- Accept any surplus cash or sales proceeds generated by the property to ensure its use as a public benefit.

<u>Terms of the Purchase Option Agreement</u>. To formalize the City's participation in the project and ensure that these public funds will be used for public benefit, the City will need to enter into a Purchase Option Agreement for each property. The terms of the Purchase Option Agreement include:

- **Purchase Option:** Grants the City the right to purchase the property 15 years after the acquisition of a property or at any time thereafter for the remaining term of the 30-year bond. The City can transfer the option to an affordable housing provider with approval from the owner. Entering into this agreement does not obligate the City to purchase the property at any time.
- **Option Price:** The future acquisition price shall be the sum of the amount sufficient to pay all project debt, encumbrances, amounts due to other parties to the transaction, and transaction costs. The price can be reduced by assuming existing project debt or applying project revenue.
- **Surplus Cash:** Any surplus cash will be held by the trustee and then distributed to the City upon acquisition/transfer of ownership.
- **Terms of Conveyance:** City to purchase the property in as is condition with all faults.

Under the CalCHA arrangement, the City is not a direct party to the real estate transaction nor financial transaction. The bonds to be issued by the CalCHA for the project will be the sole responsibility of CalCHA, and the City will have no financial, legal, moral obligation, liability, or responsibility for the project or the repayment of the bonds. The City will have no responsibility for managing or maintaining the property unless it chooses to exercise its options and acquire the property.

#### Comments from City Council

The Council was generally supportive of the financing model but identified topics for further review. The items identified by Council are listed below and staff's response is provided in italics.

• **Unlimited Authority.** Add limitations to the City Manager's authority to ensure periodic review of the program by the Council.

Staff has added language to the authorizing resolution that limits the City Manager's authority to enter into Purchase Option Agreements for up to four properties totaling no more than 1,000 units for essential middle-income housing during the next five years and excludes projects that received their certificate of occupancy after 2019. Additionally, the City Manager is to evaluate the location of the property to promote equitable access to affordable housing and community amenities. In the event that the financing model is successful, staff can request additional authority based on actual performance of the model.

• **Anti-displacement.** Ensure that there is a mechanism to prevent displacement of the existing tenants if the program is used to acquire occupied rental housing.

Catalyst provided sample recorded regulatory agreements that include language that states that at the time of admission to the project, no tenant shall be denied continued occupancy of a unit in the project because their income exceeds the qualifying limit. The authorizing resolution has been revised to require that prior to entering into a Purchase Option Agreement, the City Manager shall ensure that the corresponding regulatory agreement includes such language that enables existing residents to remain in the property even if their income exceeds the qualifying income limits.

• **Exclusion of FPI Property Management.** Ensure that FPI property management will not be responsible for managing any properties acquired utilizing the proposed financing model.

The authorizing resolution has been revised to require that prior to entering into a Purchase Option Agreement, the City Manager shall ensure that the corresponding regulatory agreement prohibits hiring FPI Property Management from managing the property.

• Ownership Opportunities for Existing Residents. Evaluate the possibility of transferring ownership to existing residents when the City exercises its option to purchase a property financed with this model.

The authorizing resolution has been revised to state that prior to exercising the option under the Purchase Option Agreement, Council will consider options to acquire the property, assign the City's option including transfer of ownership to the tenants, or to decline the option to purchase and determine use of any surplus revenues.

#### FISCAL IMPACT

While the project will stabilize much needed middle-income housing and has the potential for generating revenue from operating revenue or sales proceeds, the City will lose property tax revenue received from any existing rental properties acquired using this model. While the City does not wish to reduce its property tax base, it is the Council's goal to create housing units in the Hayward community. Staff feels that the benefit of being able to offer additional low- and moderate-income housing during the regional housing shortage and beyond is of greater value to the City. While there is no near-term fiscal impact for joining CalCHA or executing a future Purchase Option Agreement, future fiscal impact may arise out of executing a purchase agreement, which may be mitigated via the excess revenue fund. During the 15-year option period, the City would have to evaluate its capacity to acquire the property or explore the option of assigning its option to a nonprofit housing provider or transferring ownership to the tenants. The agreement does not create an obligation on the part of the City to purchase or acquire the property, in the event the City chooses not to purchase the property.

#### STRATEGIC ROADMAP

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAYWARD AUTHORIZING THE CITY TO BECOME A MEMBER OF THE CALIFORNIA COMMUNITY HOUSING AGENCY ("CALCHA"); SUPPORTING CALCHA'S ISSUANCE OF TAX-EXEMPT BONDS FOR THE PRODUCTION, PRESERVATION AND PROTECTION OF ESSENTIAL MIDDLE-INCOME RENTAL HOUSING; AND AUTHORIZING THE CITY MANAGER TO ENTER INTO PURCHASE OPTION AGREEMENTS WITH CALCHA FOR ESSENTIAL MIDDLE-INCOME RENTAL HOUSING CREATED WITHIN CITY LIMITS

WHEREAS, one of the primary goals of the City of Hayward (the "City") is to meet the growing housing needs of its residents by actively supporting the production, preservation and protection of market-rate and affordable rental housing for all; and

WHEREAS, no existing federal, state or local subsidies, programs or motivations currently exist to meaningfully address the growing shortfall of protected middle-income rental housing; and

WHEREAS, CalCHA is a Joint Powers Authority created specifically to produce, preserve and protect quality affordable rental housing made available to California's essential middle-income workforce; and

WHEREAS, CalCHA intends to develop rental housing or acquire existing rental properties within City limits and restrict future occupancy to middle-income households earning no more than 120% of area median income; and

WHEREAS, CalCHA will avoid the displacement of existing residents, implement regulatory agreements restricting the incomes and rents of future residents, and impose caps on the annual rent increases of qualified middle-income households; and

WHEREAS, CalCHA will finance its acquisitions through the issuance of tax-exempt bonds, and in order for CalCHA to issue tax-exempt bonds in Hayward, the City must be an Additional Member of CalCHA; and

WHEREAS, the City proposes to become an Additional Member of CalCHA pursuant to Section 12 of the Joint Exercise of Powers Agreement Relating to the California Community Housing Agency; and

WHEREAS, subsequent to becoming a member of CalCHA, any existing rental housing within City limits which CalCHA intends to acquire and finance with tax-exempt bonds must receive support and approval from the City; and

WHEREAS the City proposes to support and approve CalCHA's issuance of taxexempt bonds for the acquisition of existing rental properties as a means towards the preservation and protection of essential middle-income rental housing within City limits; and

WHEREAS, CalCHA's issuance of tax-exempt bonds will provide public benefit through the production, preservation and protection of below-market-rate rental housing, as well as the granting of all surplus project revenues to the City; and

WHEREAS, pursuant to one or more purchase option agreements (the "Purchase Option Agreements"), between CalCHA and the City, CalCHA will grant the City the option, but never the obligation, to purchase each essential middle-income rental housing property commencing on the date fifteen (15) years after CalCHA's acquisition of such property; and

WHEREAS, the City Manager will evaluate the location of the properties to promote equitable access to affordable housing and community amenities; and

WHEREAS, the Purchase Option Agreements will additionally provide the City with any surplus project revenues from each essential middle-income rental housing property at the time the City exercises its option or declines to purchase the property; and

WHEREAS, the City will maintain the option to exercise such Purchase Option Agreements for a period of fourteen (14) years following the commencement dates of the Purchase Option Agreements for each essential middle-income rental housing property; and

WHEREAS, prior to exercising the option under Purchase Option Agreements, Council will consider options to acquire the property, assign the City's option including transfer of ownership to tenants, or decline the option to purchase and determine use of any surplus revenues; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward hereby authorizes the City to become a member of CalCHA and authorizes the City Manager to execute the Joint Exercise of Powers Agreement Relating to the California Community Housing Agency, subject to approval as to form by the City Attorney.

BE IT FURTHER RESOLVED that the City Council of the City of Hayward hereby supports and approves CalCHA's issuance of tax-exempt bonds as a means towards the production, preservation and protection of essential middle-income rental housing within City limits.

BE IT FURTHER RESOLVED that the City Council of the City of Hayward hereby authorizes the City Manager to enter into Purchase Option Agreements , consistent with this resolution and its basic purpose, with CalCHA over the next five (5) years for no more than four (4) properties totaling no more than 1,000 units for essential middle-income housing created within City limits, excluding projects that received their certificate of occupancy after 2019, subject to approval as to form by the City Attorney.

BE IT FURTHER RESOLVED that prior to entering into a Purchase Option Agreement, the City Manager will ensure that the Regulatory Agreement for each property contains language allowing over-income tenants to remain housed at the property and prohibits FPI Property Management from managing the property.

# JOINT EXERCISE OF POWERS AGREEMENT RELATING TO THE CALIFORNIA COMMUNITY HOUSING AGENCY

THIS AGREEMENT, dated as of January 29, 2019, among the parties executing this Agreement (all such parties, except those which have withdrawn as provided herein, are referred to as the "Members" and those parties initially executing this Agreement are referred to as the "Charter Members"):

#### WITNESSETH

WHEREAS, pursuant to Title 1, Division 7, Chapter 5 of the California Government Code (in effect as of the date hereof and as the same may from time to time be amended or supplemented, the "Joint Exercise of Powers Act"), two or more public agencies may by agreement jointly exercise any power common to the contracting parties; and

WHEREAS, each of the Members is a "public agency" as that term is defined in Section 6500 of the Joint Exercise of Powers Act; and

WHEREAS, each of the Members is empowered by law to promote economic, cultural and community development, including, without limitation, the promotion of opportunities for the creation or retention of employment, the stimulation of economic activity, the increase of the tax base, and the promotion of opportunities for education, cultural improvement and public health, safety and general welfare; and

WHEREAS, each of the Members may accomplish the purposes and objectives described in the preceding preamble by various means; and

WHEREAS, each Member is also empowered by law to acquire, construct, improve, operate and dispose of real property for a public purpose; and

WHEREAS, the Joint Exercise of Powers Act authorizes the Members to create a joint exercise of powers entity with the authority to exercise any powers common to the Members, including but not limited to acquiring, constructing, improving, operating and disposing of real property for a public purpose, all as specified in this Agreement, and to exercise the additional powers granted to it in the Joint Exercise of Powers Act and any other applicable provisions of the laws of the State of California; and

WHEREAS, a public entity established pursuant to the Joint Exercise of Powers Act is empowered to issue or execute non-recourse debt, which may include bonds, notes, commercial paper or any other evidences of indebtedness, leases, installment sale or other financing agreements or certificates of participation therein (herein "Obligations"), and to otherwise undertake financing programs under the Joint Exercise of Powers Act or other applicable provisions of the laws of the State of California to accomplish its public purposes; and

WHEREAS, the Members have determined to specifically authorize a public entity authorized pursuant to the Joint Exercise of Powers Act to issue non-recourse Obligations pursuant to the Joint Exercise of Powers Act or other applicable provisions of the laws of the State of California; and

WHEREAS, it is the desire of the Members to use a public entity established pursuant to the Joint Exercise of Powers Act to undertake the financing and/or refinancing of projects that provide, preserve and support affordable local housing for low-income, moderate-income and middle-income families and individuals within the jurisdictions of the Members, including, but not limited to, capital or working capital projects, purchase or acquisition of property, receivables, commodities, bonds, other revenue streams or assets of any kind, liability or other insurance, or retirement programs, or facilitating Members use of existing or new financial instruments and mechanisms in the furtherance of this purpose; and

WHEREAS, by this Agreement, each Member desires to create and establish the "California Community Housing Agency" for the purposes set forth herein and to exercise the powers provided herein;

NOW, THEREFORE, the Members, for and in consideration of the mutual promises and agreements herein contained, do agree as follows:

## Section 1. Purpose.

This Agreement is made pursuant to the provisions of the Joint Exercise of Powers Act. The purpose of this Agreement is to establish a public entity for the joint exercise of powers common to the Members and for the exercise of additional powers given to a joint powers entity under the Joint Powers Act or any other applicable law, including, but not limited to, the issuance of non-recourse Obligations for any purpose or activity permitted under the Joint Exercise of Powers Act or any other law; provided, however that such purpose shall be solely for the acquisition, construction, rehabilitation, ownership, operation, maintenance, administration and/or financing of multifamily housing for low-income, moderate-income and middle-income families and individuals (the "Purpose"). Such Purpose will be accomplished and said power exercised in the manner hereinafter set forth.

#### Section 2. Term.

This Agreement shall become effective in accordance with Section 17 as of the date hereof and shall continue in full force and effect until such time as it is terminated in writing by all the Members; provided, however, that this Agreement shall not terminate or be terminated until all Obligations issued or caused to be issued by the Agency (defined below) shall no longer be outstanding under the terms of the indenture, trust agreement, resolution or other instrument pursuant to which such Obligations are issued.

# Section 3. Agency.

#### A. CREATION AND POWERS OF AGENCY.

Pursuant to the Joint Exercise of Powers Act, there is hereby created a public entity to be known as the "California Community Housing Agency" (the "Agency"), and said Agency shall be a public entity separate and apart from the Members. Its debts, liabilities and obligations do not constitute debts, liabilities or obligations of any Members, and the Obligations of the Agency shall only be non-recourse obligations.

#### B. BOARD.

The Agency shall be administered by the Board of Directors (the "Board," or the "Directors" and each a "Director") whose members shall be, at all times, members of the Board of Supervisors (the "Board of Supervisors") of Kings County, California, with each such Director serving in his or her individual capacity as Director of the Board. The term of office as a member of the Board shall terminate when such member shall cease to be a member of the Board of Supervisors and the successor to such member of the Board of Supervisors shall become a member of the Board.

Notwithstanding the preceding paragraph, the Board may by resolution or bylaws provide for changes in the qualifications, composition and number of Directors, the appointment of Directors, successors, their respective terms of office and any other provisions relating to the qualification and office of the Directors, including provision for alternative Directors (in which case all references in this Agreement to any Director shall be deemed to refer to and include the applicable alternate Director, if any, when so acting in place of a regularly appointed Director).

The Board shall be the administering agency of this Agreement and, as such, shall be vested with the powers set forth herein, and shall administer this Agreement in accordance with the purposes and functions provided herein.

Directors shall not receive any compensation for serving as such, but shall be entitled to reimbursement for any expenses actually incurred in connection with serving as a Director, if the Board shall determine that such expenses shall be reimbursed and there are unencumbered funds available for such purpose.

# C. OFFICERS; DUTIES; OFFICIAL BONDS.

The officers of the Agency shall be the Chair, Vice-Chair, Secretary and Treasurer (defined below). The Board, in its capacity as administering agent of this Agreement, shall elect a Chair, a Vice-Chair, and a Secretary of the Agency from among Directors to serve until such officer is re-elected or a successor to such office is elected by the Board. The Board shall appoint one or more of its officers or employees to serve as treasurer, auditor, and controller of the Agency (the "Treasurer") pursuant to Section 6505.6 of the Joint Exercise of Powers Act to serve until such officer is re-elected or a successor to such office is elected by the Board.

Subject to the applicable provisions of any resolution, indenture, trust agreement or other instrument or proceeding authorizing or securing Obligations (each such resolution, indenture, trust agreement, instrument and proceeding being herein referred to as an "Indenture") providing for a trustee or other fiscal agent, and except as may otherwise be specified by resolution of the Board, the Treasurer is designated as the depositary of the Agency to have custody of all money of the Agency, from whatever source derived and shall have the powers, duties and responsibilities specified in Sections 6505, 6505.5 and 6509.5 of the Joint Exercise of Powers Act.

The Treasurer of the Agency is designated as the public officer or person who has charge of, handles, or has access to any property of the Agency, and such officer shall file an official bond with the Secretary of the Agency in the amount specified by resolution of the Board but in no event less than \$1,000.

The Board shall have the power to appoint such other officers and employees as it may deem necessary and to retain independent counsel, consultants and accountants.

The Board shall have the power, by resolution, to the extent permitted by the Joint Exercise of Power Act or any other applicable law, to delegate any of its functions to one or more of the Directors or officers, employees or agents of the Agency and to cause any of said Directors, officers, employees or agents to take any actions and execute any documents or instruments for and in the name and on behalf of the Board or the Agency.

#### D. MEETINGS OF THE BOARD.

# (1) Ralph M. Brown Act.

All meetings of the Board, including, without limitation, regular, adjourned regular, special, and adjourned special meetings shall be called, noticed, held and conducted in accordance with the provisions of the Ralph M. Brown Act (commencing with Section 54950 of the Government Code of the State of California), or any successor legislation hereinafter enacted (the "Brown Act").

#### (2) <u>Regular Meetings</u>.

The Board shall provide for its regular meetings; provided, however, it shall hold at least one regular meeting each year. The date, hour and place of the holding of the regular meetings shall be fixed by resolution of the Board. To the extent permitted by the Brown Act, such meetings may be held by telephone conference.

# (3) Special Meetings.

Special meetings of the Board may be called in accordance with the provisions of Section 54956 of the Government Code of the State of California. To the extent permitted by the Brown Act, such meetings may be held by telephone conference.

### (4) Minutes.

The Secretary of the Agency shall cause to be kept minutes of the regular, adjourned regular, special, and adjourned special meetings of the Board and shall, as soon as possible after each meeting, cause a copy of the minutes to be forwarded to each Director.

#### (5) Quorum.

A majority of the Board shall constitute a quorum for the transaction of business. No action may be taken by the Board except upon the affirmative vote of a majority of the Directors present at the meeting, except that less than a quorum may adjourn a meeting to another time and place.

#### E. RULES AND REGULATIONS.

The Agency may adopt, from time to time, by resolution of the Board such bylaws, policies or rules and regulations for the conduct of its meetings and affairs as may be required.

#### Section 4. Powers.

The Agency shall have the power, in its own name, to exercise the common powers of the Members and to exercise all additional powers given to a joint powers entity under any of the laws of the State of California, including, but not limited to, the Joint Exercise of Powers Act, for the Purpose authorized under this Agreement. Such powers shall include the common powers specified in this Agreement and may be exercised in the manner and according to the method provided in this Agreement. The Agency is hereby authorized to do all acts necessary for the exercise of such power, including, but not limited to, any of all of the following: to make and enter into contracts; to employ agents and employees; to acquire, construct, improve, own, maintain and operate, or provide for maintenance and operation, and sell, lease, pledge, assign, mortgage or otherwise dispose, of any property, improvements, commodities, leases, contracts, receivables, bonds or other revenue streams or assets of any kind relating to the Purpose; to exercise the power of condemnation; to incur debts, liabilities or obligations; to receive gifts, contributions and donations of property, funds, services, and other forms of assistance from person, firms, corporations and any governmental entity; to sue and be sued in its own name; to establish and collect fees; to form public benefit nonprofit corporations or other affiliate entities to accomplish any of its Purposes; to make grants, loans or provide other financial assistance to governmental, nonprofit and for profit organizations to accomplish any of its Purposes; and generally to do any and all things necessary or convenient to accomplish its Purposes. The boundaries of the Agency shall encompass the boundaries of all the Members and the powers of the Agency may be exercised anywhere within those boundaries or to the extent permitted by the laws of the State of California, including, but not limited to the Joint Exercise of Powers Act, outside of those boundaries, which may be outside of the State of California, provided that the power of condemnation may only be exercised within the jurisdictional boundaries of the Charter Members.

Without limiting the generality of the foregoing, the Agency may issue or cause to be issued Obligations, and pledge any property, contracts or revenues as security to the extent permitted under the Joint Exercise of Powers Act, or any other applicable provision of law.

The manner in which the Agency shall exercise its powers and perform its duties is and shall be subject to the restrictions upon the manner in which a California county could exercise such powers and perform such duties. The manner in which the Agency shall exercise its powers and perform its duties shall not be subject to any restrictions applicable to the manner in which any other public agency could exercise such powers or perform such duties, whether such agency is a party to this Agreement or not.

#### Section 5. Fiscal Year.

For the purposes of this Agreement, the term "Fiscal Year" shall mean the fiscal year as established from time to time by resolution of the Board, being, at the date of this Agreement, the period from July 1 to and including the following June 30, except for the first Fiscal Year which shall be the period from the date of this Agreement to June 30, 2019.

# Section 6. Disposition of Assets.

At the end of the term hereof or upon the earlier termination of this Agreement as set forth in Section 2, after payment of all expenses and liabilities of the Agency, all property of the Agency both real and personal shall automatically vest in the Members in the manner and amount determined by the Board in its sole discretion and shall thereafter remain the sole property of the Members; provided, however, that any surplus money on hand shall be returned in proportion to the contributions made by the Members.

### Section 7. Obligations.

From time to time the Agency shall issue Obligations, in one or more series, for the purpose of exercising its powers and raising the funds necessary to carry out its Purposes under this Agreement, including but not limited to acquiring, constructing, improving, operating and disposing of real property for a public purposes.

The services of bond counsel, financing consultants and other consultants and advisors working on the projects and/or their financing or refinancing or on post-issuance compliance or administration may be used by the Agency. The expenses of the Board shall be paid from the proceeds of the Obligations, payments made by Obligation obligors or other third parties, or any other unencumbered funds of the Agency available for such purpose.

# Section 8. Obligations Only Limited and Special Obligations of Agency.

The Obligations, together with the interest and premium, if any, thereon, shall not be deemed to constitute a debt of any Member or pledge of the faith and credit of the Members or the Agency. The Obligations shall be only special non-recourse obligations of the Agency, and the Agency shall under no circumstances be obligated to pay the Obligations except from revenues and other funds pledged therefor. Neither the Members nor the Agency shall be obligated to pay the principal of, premium, if any, or interest on the Obligations, or other costs incidental thereto, except the Agency from the revenues and funds pledged and available therefor, and neither the faith and credit nor the taxing power of the Members nor the faith and credit of the Agency shall be pledged to the payment of the principal of, premium, if any, or interest on the Obligations nor shall the Members or the Agency in any manner be obligated to make any appropriation for such payment.

No covenant or agreement contained in any Obligation or related document shall be deemed to be a covenant or agreement of any Director, or any officer, employee or agent of the Agency in his or her individual capacity, and neither the Board of the Agency nor any Director or officer thereof executing the Obligations shall be liable personally on any Obligation or be subject to any personal liability or accountability by reason of the issuance of any Obligations.

# Section 9. Accounts and Reports.

All funds of the Agency shall be strictly accounted for. The Agency shall establish and maintain such funds and accounts as may be required by good accounting practice and by any provision of any Indenture (to the extent such duties are not assigned to a trustee of Obligations). The books and records of the Agency shall be open to inspection at all reasonable times by each Member.

The Treasurer of the Agency shall cause an independent audit to be made of the books of accounts and financial records of the Agency by a certified public accountant or public accountant in compliance with the provisions of Section 6505 of the Joint Exercise of Powers Act. In each case the minimum requirements of the audit shall be those prescribed by the State Controller for special districts under Section 26909 of the Government Code of the State of California and shall conform to generally accepted auditing standards. When such an audit of accounts and records is made by a certified public accountant or public accountant, a report thereof shall be filed as a public record with each Member and also with the county auditor of each county in which a Member is located; provided, however, that to the extent permitted by law, the Agency may, instead of filing such report with each Member and such county auditor, elect to post such report as a public record electronically on a website designated by the Agency. Such report if made shall be filed within 12 months of the end of the Fiscal Year or Years under examination.

The Treasurer is hereby directed to report in writing on the first day of July, October, January, and April of each year to the Board and the Charter Members which report shall describe the amount of money held by the Treasurer for the Agency, the amount of receipts since the last such report, and the amount paid out since the last such report (which may exclude

amounts held by a trustee or other fiduciary in connection with any Obligations to the extent that such trustee or other fiduciary provided regular reports covering such amounts.)

Any costs of the audit, including contracts with, or employment of, certified public accountants or public accountants in making an audit pursuant to this Section, shall be borne by the Agency and shall be a charge against any unencumbered funds of the Agency available for that purpose.

In any Fiscal Year the Board may, by resolution adopted by unanimous vote, replace the annual special audit with an audit covering a two-year period.

### Section 10. Funds.

Subject to the applicable provisions of any Indenture, which may provide for a trustee or other fiduciary to receive, have custody of and disburse Agency funds, the Treasurer of the Agency shall receive, have the custody of and disburse Agency funds pursuant to the accounting procedures developed under Sections 3.C and 9, and shall make the disbursements required by this Agreement or otherwise necessary to carry out any of the provisions of purposes of this Agreement.

#### Section 11. Notices.

Notices and other communications hereunder to the Members shall be sufficient if delivered to the clerk of the governing body of each Member; provided that, to the extent permitted by law, the Agency may provide notices and other communications and postings electronically (including, without limitation, through email or by posting to a website).

#### Section 12. Additional Members/Withdrawal of Members.

Qualifying public agencies may be added as parties to this Agreement and become Charter Members upon: (1) the filing by such public agency with the Agency of an executed counterpart of this Agreement, together with a copy of the resolution of the governing body of such public agency approving this Agreement and the execution and delivery hereof; and (2) adoption of a resolution of the Board approving the addition of such public agency as a Charter Member. Upon satisfaction of such conditions, the Board shall file such executed counterpart of this Agreement as an amendment hereto, effective upon such filing.

Qualifying public agencies may also be added as Non-Charter Members ("Additional Members") of the Agency upon: (1) the filing by such public agency with the Agency of a resolution of the governing body of such public agency requesting to be added as an Additional Member of the Agency, and (2) adoption of a resolution of the Board approving the addition of such public agency as an Additional Member. An Additional Member may limit in the aforementioned resolution the scope of its Additional Membership to what is necessary or appropriate to facilitate the financing or refinancing of one or more specified projects or programs.

A Member may withdraw from this Agreement upon written notice to the Board; provided, however, that at least one Member shall be a Charter Member and no such withdrawal shall result in the dissolution of the Agency so long as any Obligations remain outstanding. Any such withdrawal shall be effective only upon receipt of the notice of withdrawal by the Board, which shall acknowledge receipt of such notice of withdrawal in writing and shall file such notice as an amendment to this Agreement effective upon such filing.

# Section 13. <u>Indemnification</u>.

To the full extent permitted by law, the Board may authorize indemnification by the Agency of any person who is or was a Director or an officer, employee or other agent of the Agency, and who was or is a party or is threatened to be made a party to a proceeding by reason of the fact that such person is or was such a Director or an officer, employee or other agent of the Agency, against expenses, including attorneys fees, judgments, fines, settlements and other amounts actually and reasonably incurred in connection with such proceeding, if such person acted in good faith in a manner such person reasonably believed to be in the best interests of the Agency and, in the case of a criminal proceeding, had no reasonable cause to believe the conduct of such person was unlawful and, in the case of an action by or in the right of the Agency, acted with such care, including reasonable inquiry, as an ordinarily prudent person in a like position would use under similar circumstances. The Board may purchase a policy or policies of insurance in furtherance of any indemnification obligation created or otherwise in protection of Directors, officers, employees or other agents.

# Section 14. Contributions and Advances.

Contributions or advances of public funds and of the use of personnel, equipment or property may be made to the Agency by the Members for any of the Purposes of this Agreement. Payment of public funds may be made to defray the cost of any such contribution or advance. Any such advance may be made subject to repayment, and in such case shall be repaid, in the manner agreed upon by the Agency and the Member making such advance at the time of such advance. It is mutually understood and agreed to that no Member has any obligation to make advances or contributions to the Agency to provide for the costs and expenses of administration of the Agency, even though any Member may do so. The Members understand and agree that a portion of the funds of the Agency that otherwise may be allocated or distributed to the Members may instead be used to make grants, loans or provide other financial assistance to governmental units and to nonprofit organizations to accomplish any of the governmental unit's or nonprofit organization's purposes.

#### Section 15. Immunities.

All of the privileges and immunities from liabilities, exemptions from laws, ordinances and rules, and other benefits which apply to the activity of officers, agents or employees of Members when performing their respective functions within the territorial limits of their respective public agencies, shall apply to the same degree and extent to the Directors, officers, employees, agents or other representatives of the Agency while engaged in the performance of any of their functions or duties under the provisions of this Agreement.

#### Section 16. Amendments.

Except as provided in Sections 3B and 12 above, or to cure any error, omission or ambiguity in this Agreement, this Agreement shall not be amended, modified, or altered except with (i) written consent of all holders of any outstanding bonds of the Agency, (ii) written consent of each of Charter Member, and (iii) negative consent of each Additional Member. To obtain the negative consent of each such Additional Member, the following negative consent procedure shall be followed: (a) the Agency shall provide each such Additional Member with a notice at least sixty (60) days prior to the date such proposed amendment is to become effective explaining the nature of such proposed amendment and this negative consent procedure; (b) the Agency shall provide each such Additional Member who did not respond a reminder notice with a notice at least thirty (30) days prior to the date such proposed amendment is to become effective; and (c) if no such Additional Member objects to the proposed amendment in writing within sixty (60) days after the initial notice, the proposed amendment shall become effective with respect to all Members.

#### Section 17. Effectiveness.

This Agreement shall become effective and be in full force and effect and a legal, valid and binding obligation of each of the Members on the date that the Board shall have received from two of the Charter Members an executed counterpart of this Agreement, together with a certified copy of a resolution of the governing body of each such Charter Member approving this Agreement and the execution and delivery hereof.

#### Section 18. Partial Invalidity.

If any one or more of the terms, provisions, promises, covenants or conditions of this Agreement shall to any extent be adjudged invalid, unenforceable, void or voidable for any reason whatsoever by a court of competent jurisdiction, each and all of the remaining terms, provisions, promises, covenants and conditions of this Agreement shall not be affected thereby, and shall be valid and enforceable to the fullest extent permitted by law.

#### Section 19. Successors.

This Agreement shall be binding upon and shall inure to the benefit of the successors of the parties hereto. Except to the extent expressly provided herein, no Member may assign any right or obligation hereunder without the consent of the other Members.

#### Section 20. <u>Miscellaneous</u>.

This Agreement may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.

The section headings herein are for convenience only and are not to be construed as modifying or governing the language in the section referred to.

Wherever in this Agreement any consent or approval is required, the same shall not be unreasonably withheld.

This Agreement shall be governed under the laws of the State of California.

This Agreement is the complete and exclusive statement of the agreement among the Members, which supercedes and merges all prior proposals, understandings, and other agreements, whether oral, written, or implied in conduct, between and among the Members relating to the subject matter of this Agreement.

# **Background:**

Hayward, CA is the third largest city in Alameda County and is surrounded by the Unincorporated Areas: Cherryland, Hayward Acres, Ashland, Fairview, San Lorenzo, El Portal Ridge, Fairmont, Fairmont Terrace, Five Canyons and Hillcrest Knolls. These areas are not governed by a municipality, rather by the Board of Supervisors of Alameda County. Some unincorporated areas have fought hard to develop a local body, such as a municipal advisory council, in an effort to have more local control of neighborhoods. Many reports suggest that the unincorporated area is most vulnerable to displacement, need of emergency services, fees, higher taxes, lack of control over zoning, and much more.

Primarily, by becoming a part of Hayward, the unincorporated areas would benefit by having more control over land use and development, revitalization of residential and commercial areas, tax equity, improved community identity, local advocates for an improved quality of life, a stronger voice in the public safety and other services they receive, and even more (higher minimum wage, rent stabilization, tenant protections, etc.).

It is recommended that the City of Hayward begin an analysis of the potential impacts of annexation, transparently explain the process, and annex the area.

#### The benefits of annexation for the unincorporated area:

- Receive a higher minimum wage
- Receive permanent tenant protections, just cause evictions, and rent control (unlike AB1482 that is binding for only 10 years)
- Regular maintenance (infrastructure), public safety (police and fire), and other city-provided services

# Benefits to the City of Hayward:

- Larger influence in Alameda County due to increased size
- Larger revenue base for the City of Hayward
- Neighboring areas are uniform to City standards

Unincorporated areas also receive less maintenance on roads, sidewalks, and many of the other services that a traditional city provides to neighborhoods. This often leads to slower response times, streets needing repairs, and much more. The best option for unincorporated areas is to become a city or in this case, become a part of a current city.

#### **Annexation Considerations (but not limited to):**

- Assessment of the boundaries of the Cherryland and Hayward Acres neighborhoods and consideration of other areas that could be included in a potential annexation
- Cost/Benefit (revenue and expenditure) analysis of the impact of annexation on both the City of Hayward and the residents and businesses in the annexation area.
- Analysis of benefits to residents of the unincorporated areas such as: emergency services, housing, economic development, and safety nets (rent control, tenant protections, just cause eviction, minimum wage and other benefits) to the unincorporated residents
- Transparency of the process of annexation

**Timeline:** 30-60 days

**Stakeholders**: Alameda County Board of Supervisors, Alameda County Municipal Advisory Councils, Local Agency Formation Commission, residents, business owners, other organizations, etc.

# **Background:**

Hayward, CA is the third largest city in Alameda County and is the "Heart of the Bay". The current Coronavirus Disease 2019 or COVID-19 is just one example of how important it is to respond efficiently and effectively to an emergency, whether it be a natural disaster or a respiratory illness first identified across the world. Many residents will feel direct impacts to their daily life such as schools shutting down, job loss, wage loss, business closures, and other health and economic impacts.

# **Referral Request:**

It is recommended that the City of Hayward prepare a policy that provides a temporary moratorium on evictions/foreclosures in the City of Hayward to all residents where a failure to pay rent/mortgage is a result from wage loss during an emergency. We must avoid an even greater emergency that would result from displacing thousands of residents from their homes.

This policy should be effective at any time when:

• The City, County, State, or Federal Authority declares a state of emergency.

#### Actions to Consider:

- The moratorium shall remain in effect for a period of 30 days from the Council resolution, and be brought back to the Council for consideration of extending the duration if the situation demands it.
- The affected resident must demonstrate loss of income due to the emergency through documentation. Examples: job loss, reduction of compensated hours, business/office closure, missing work due to care for another (parent, child, etc.), etc.
- Residents must notify landlord, banks, etc. of substantial wage loss (layoffs, closure, etc.)
- The City shall support landlords and home and business owners in advocating with organizations (banks, city, service providers, etc.) for temporary relief from property taxes, utility charges, and foreclosures.
- Evaluation of such policy after 90-120 days.

**Timeline:** As soon as possible, at the discretion of the City Manager – no longer than 30-60 days

Tuesday, February 25, 2020

The Joint City Council/Hayward Geologic Hazard Abatement District Board meeting was called to order by Board Chair Halliday at 7:02 p.m., followed by the Pledge of Allegiance led by Board member Zermeño.

#### **ROLL CALL**

Present: BOARD MEMBERS Zermeño, Márquez, Mendall, Lamnin, Wahab, Salinas

and Chair Halliday

#### **MINUTES**

1. Accept the Minutes of the May 7, 2019 meeting of the GHAD Board of Directors. It was moved by Board Member Lamnin and seconded by Board Member Márquez, to approve the Minutes of the May 7, 2019 meeting of the GHAD Board of Directors; the motion carried unanimously (7-0-0).

#### **PUBLIC HEARING**

2. GHAD Manager Eric Harrell provided the staff report regarding the Board's consideration to accept transfer of the Hayward GHAD's Plan of Control responsibilities for certain eligible parcels from The Reserve development (Tract 7620) to the Hayward GHAD. La Vista, LP, the developer of The Reserve, applied to the GHAD Manager for transfer of certain parcels within the development. The GHAD Manager recommended the Board approve the transfer of 206 parcels for monitoring, maintenance, and/or ownership responsibilities.

A condition of approval of the La Vista development required the developer to form a Lighting and Landscape Assessment District ("LLD"). The developer formed and annexed to Benefit Zone No. 14 of LLC No. 96-1. Some LLD improvements within the 13 parcels eligible for transfer to the GHAD will be required to be maintained by the City so GHAD staff also recommended the Board consider granting a right of entry to the City of Hayward in connection with this LLD. The Board directed that consideration of the Right of Entry be continued to the next scheduled Board meeting to allow time for the City Attorney to work with GHAD Counsel to finalize the Right of Entry.

Board member Márquez requested confirmation that Parcels A and P were located within the open space/park area of The Reserve and that the detention basin within the open space/park area would be maintained by the GHAD. GHAD Manager confirmed the detention basin would be maintained by the GHAD.

GHAD staff noted corrections be made to Resolution No. 20-01 related to the GHAD's name and the LLD.

It was moved by Board member Zermeño and seconded by Board member Márquez to approve Resolution No. 20-01, with amendments to correct the GHAD name and to remove text references to the LLD, to accept transfer of Plan of Control responsibilities for 13 parcels within The Reserve development (Tract 7620); motion carried unanimously (7-0-0).

3. GHAD Manager provided a brief staff report regarding changing the designation of the GHAD Treasurer from "Watermark Asset Management, Inc.", to "GHAD Treasurer, Inc." and introduced Mark Miller and Dave Fernandez with GHAD Treasurer, Inc. to the Board. The change in designation is necessary since Watermark Asset Management was acquired by CAPTRUST in 2019 warranting a separation in treasurer services versus investment management services. GHAD Manager also recommended that a formal contract for Treasurer services be approved by the Board.

Board member Lamnin requested the contract for services be modified to reflect the mileage rate be adjusted according to the IRS's mileage rate and Mr. Miller responded he was amenable to the proposed modification.

Board member Márquez inquired whether the Treasurer would be providing monthly, quarterly, and annual reports directly to the Board and Mr. Miller responded the Treasurer would be providing those reports directly to the Board. Mr. Miller also reported the Board members will each have on-line access to the GHAD account to monitor revenue and expense activities and daily balances.

It was moved by Board member Márquez and seconded by Board member Lamnin to approve Resolution No. 20-02 to change the Treasurer designation to GHAD Treasurer, Inc., and to approve a contract for Treasurer services; motion carried unanimously (7-0-0).

4. GHAD Manager provided the staff report regarding approval of the GHAD budget for the remainder of the 2019-2020 fiscal year since the Board has now accepted transfer of monitoring, maintenance, and/or ownership responsibilities of 206 of The Reserve parcels. GHAD Manager proposed a budget for these activities for the remainder of the 2019-2020 fiscal year in the amount of \$36,650.

Board member Mendall asked whether there was a spending limit on the GHAD Manager. GHAD Manager responded that he would return to the Board to request authority to exceed the budget in the event of the GHAD's need to respond to an emergency and costs in excess of \$36,500 were incurred.

It was moved by Board member Mendall and seconded by Board member Márquez to approve Resolution No. 20-03 to approve the budget for the remaining fiscal year; motion carried unanimously.

#### **BACKGROUND AND DISCUSSION:**

A condition of approval for the La Vista development required the developer to form a Lighting and Landscape Assessment District ("LLD"). La Vista, LP formed and annexed the development to Benefit Zone No. 14 of LLD No. 96-1. On February 25, 2020, the GHAD Board of Directors approved Resolution No. 20-01, accepting ownership of, and Plan of Control responsibilities for, 13 parcels within Tract 7620. Eight of the 13 parcels require the City to access GHAD-owned parcels in order to undertake the work of LLD No. 96-1. The GHAD Board, therefore, is granting a Right of Entry to the City of Hayward to allow the LLD work to be undertaken on GHAD property. Table 1 identifies which GHAD-owned open space parcels will require the City to enter in order to undertake work.

If the Right-of-Entry agreement for the parcels listed in Table 1 is approved by the GHAD Board of Directors by resolution, the GHAD will execute an agreement with the City to allow access for LLD No 96-1's landscape, lighting, and maintenance responsibilities on the identified parcels.

#### **FISCAL IMPACT:**

LLD No. 96-1 is funded by property assessments from homeowners within Benefit Zone No. 14. There is no fiscal impact on the GHAD.

#### **NEXT STEPS:**

Future GHAD-owned Parcels "B" and "P" within The Reserve development are not currently eligible for the transfer of GHAD responsibilities, but do include LLD-maintained improvements. At a later date, when transfer of GHAD maintenance responsibilities and ownership are brought before the GHAD Board of Directors for these two parcels, a separate Right-of-Entry agreement for these two parcels will be included for Board consideration.

WHEREAS, on February 25, 2020, the Hayward GHAD approved the transfer of ownership, monitoring, and maintenance responsibilities for GHAD activities from the developer of the La Vista (The Reserve) development to the GHAD; and

WHEREAS, a condition of approval of the La Vista development required the developer to form a Lighting and Landscape Assessment District ("LLD") which is required to enter GHAD property in order to undertake the maintenance and repair work of LLD No. 96-1. The GHAD Board, therefore, is granting a Right of Entry to the City of Hayward to allow the LLD work to be undertaken on GHAD property.

NOW, THEREFORE, BE IT RESOLVED that the Hayward GHAD Board of

### Directors hereby orders that:

- 1. A Right-of-Entry Agreement between the City of Hayward and the Hayward Geologic Hazard Abatement District (GHAD) Authorizing the City to Access GHAD-Owned Property to Maintain Lighting and Landscape District No. 96-1 Improvements be approved.

#### RIGHT OF ENTRY AND AGREEMENT REGARDING OPEN SPACE PROPERTY

This Right of Entry and Agreement Regarding Open Space Property (the "Agreement") is entered into as of March 17, 2020 (the "Effective Date"), by and between the CITY OF HAYWARD, a municipal corporation ("CITY") and HAYWARD GEOLOGIC HAZARD ABATEMENT DISTRICT, a California district organized and existing under the laws of the State of California ("GHAD").

#### **RECITALS**

This Agreement is made with reference to and reliance upon the following:

**WHEREAS**, the City approved a 179-lot residential subdivision by and through Final Map, Subdivision 7620, filed on May 3, 2016, in Book 339 of Maps, at pages 46 through 69, all in the Official Records of Alameda County, California (the "La Vista Development" or "Development").

**WHEREAS**, Condition of Approval #84 of the Subdivision 7620 required the formation of the GHAD to include the Development. Condition of Approval # 35 required the Development to form a Lighting and Landscape Assessment District ("LLD"). La Vista formed and annexed the Development to Benefit Zone No. 14 of LLD No. 96-1.

**WHEREAS,** the GHAD is the owner of real property consisting of parcels C, D, N, O, U, V and APN 083-075-002-15 and more particularly described in <u>Exhibit A</u> hereto (the "<u>Property</u>"). GHAD is the sole owner in fee simple of the Property.

**WHEREAS**, GHAD therefore desires to allow the City and its representatives, employees, agents, consultants, contractors, and subcontractors (collectively, "City's Agents"), to enter upon and to undertake any and all actions on the Property that are necessary to perform the work required of LLD 96-1 and which is consistent with the GHAD Plan of Control.

**WHEREAS**, the City and GHAD have agreed to execute this Agreement in order to establish the rights, duties and obligations of the City and the GHAD with regard to the Property.

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the mutual promises, covenants, terms and conditions, and restrictions contained herein, CITY and GHAD hereby agree as follows:

- 1. **Right of Entry.** GHAD hereby grants to CITY and to CITY's Agents the perpetual right to enter onto the Property at any time and from time to time, without prior notice to GHAD, in order to conduct any and all activities necessary for the performance of the CITY Work described below in Section 2 (the "Right of Entry").
- 2. <u>CITY's Duties and Obligations</u>. CITY will have the following rights and obligations with respect to the Property:
- 2.1 City shall be solely responsible to maintain and service the following on GHAD property including firebreak landscaping, groundcover, shrubs, trees, and weed abatement in planted area, upkeep and servicing of the irrigation system; graffiti removal, renovations and replacements; and maintenance of bioswales and tree filters.
- 2.2 CITY shall be solely responsible for all costs associated with performing the CITY Work, including payment of any and all water and utility bills.
- 2.3 CITY shall, at its sole expense, repair any damage done to the Property or to any improvements thereon that are in any manner whatsoever damaged, destroyed, or removed in connection with the exercise by CITY or CITY's Agents of the rights herein granted.
- 3. **GHAD's Duties and Obligations.** GHAD will have the following rights and obligations with respect to the Property:
- 3.1 GHAD shall be solely responsible for managing the Property consistent with the terms of the Plan of Control and shall have all rights accruing from its ownership of the Property.
- 3.2 GHAD shall take no action, with the exception of the prevention, mitigation, abatement, or control of geologic hazards as provided in the GHAD Plan of Control, which will interfere with or adversely affect the performance of the CITY Work. If such interference or adverse effect occurs due to actions or events caused by or within the control of GHAD, GHAD shall take all actions necessary to correct such interference or adverse effect.
- 4. <u>Indemnification by CITY</u>. CITY shall defend (with counsel acceptable to GHAD), indemnify, protect, and hold harmless GHAD, its officers, directors, employees, officials, agents, representatives and contractors and the heirs, personal representatives, successors, and assigns of each of them (collectively "GHAD Indemnified Parties") from and against all liabilities, penalties, costs, losses, damages, expense, cause of action, claims, demands or judgments, including without limitation reasonable attorneys' fees, arising from or in any way connected with: (a) any activities of CITY or of any of CITY's Agents on the Property or under this Agreement, including without limitation CITY's failure to pay when due all claims for labor or materials furnished or alleged to have been furnished to CITY at, or for use on, the Property; (b) any injury to, or death of, any person, or physical damage to the Property or to any personal

property thereon, resulting from any act by CITY or CITY's Agents occurring on the Property, except to the extent such injury, death or damage is caused by the negligent act or intentional misconduct of any of the GHAD Indemnified Parties; (c) the breach of any of the terms of this Agreement by CITY.

- 5. Indemnification by GHAD. GHAD shall defend (with counsel acceptable to CITY), indemnify, protect, and hold harmless CITY, its officers, directors, employees, officials, agents, representatives and contractors and the heirs, personal representatives, successors, and assigns of each of them (collectively "CITY Indemnified Parties") from and against all liabilities, penalties, costs, losses, damages, expense, cause of action, claims, demands or judgments, including without limitation reasonable attorneys' fees, arising from or in any way connected with: (a) any activities of GHAD or of any of GHAD's Agents on the Property or under this Agreement, including without limitation GHAD's failure to pay when due all claims for labor or materials furnished or alleged to have been furnished to GHAD at, or for use on, the Property; (b) any injury to, or death of, any person, or physical damage to the Property or to any personal property thereon, resulting from any act by GHAD or GHAD's Agents occurring on the Property, except to the extent such injury, death or damage is caused by the negligent act or intentional misconduct of any of the CITY Indemnified Parties; (c) the breach of any of the terms of this Agreement by GHAD; or (d) any conditions existing on the Property as of the Effective Date.
- 6. <u>Successors</u>. The covenants, terms, conditions, rights and obligations of GHAD under this Agreement shall run with the land and shall be binding upon and inure to the benefit of GHAD and its respective successors and assigns. The successors and assigns of GHAD's interest in the Property shall have the right to enforce the terms of the Agreement against CITY and/or CITY's successors and assigns. CITY shall likewise have the right to enforce the terms of the Agreement against GHAD and its and/or GHAD's successors and assigns.
- 7. Notice and Cure. In the event of a default by either party under this Agreement, the non-defaulting party shall provide thirty (30) days written notice of such default to the defaulting party, during which time the defaulting party shall be entitled to cure said default. In the event that the default cannot reasonably be cured within thirty (30) days, the defaulting party shall be entitled to diligently pursue cure of the default until finally cured. If the default by either party remains uncured at the end of the thirty (30) days cure period, or, in the event that the default cannot reasonably be cured within thirty (30) days, if the defaulting party fails to continue diligently to cure such default, the non-defaulting party shall be entitled to exercise all rights or remedies available at law or in equity.

### 8. **Miscellaneous**

8.1 <u>Entire Agreement</u>. This Agreement, and the Exhibits attached hereto, which are incorporated herein by this reference, embodies the entire agreement between CITY and GHAD relative to the subject matter hereof, and there are no oral agreements existing between CITY and GHAD relative to the subject matter hereof that are not expressly set forth herein and covered hereby.

- 8.2 <u>Headings</u>. The headings contained in this Agreement are for reference purposes only and shall not in any way affect the meaning or interpretation hereof.
- 8.3 <u>Controlling Law.</u> This Agreement shall be governed by and interpreted in accordance with the laws of the State of California.
- 8.4 <u>Attorney's Fees</u>. In any proceeding between the parties hereto seeking enforcement of or attempting to construe any of the terms and provisions of this Agreement, including without limitation any litigation seeking legal, declaratory or other relief, the prevailing party in such action shall be awarded, in addition to damages, injunctive, or other relief, its reasonable costs and expenses and reasonable attorneys' fees.
- 8.5 <u>Notices</u>. Any notice required or permitted to be delivered hereunder shall be in writing and personally delivered or sent by United States mail, postage prepaid, certified or registered mail, return receipt requested; by facsimile transmission; or by Federal Express, UPS or similar nationally recognized overnight courier service. Notice shall be deemed received upon personal delivery to the party to whom the notice is directed; or, if sent by mail, two (2) Business Days following its deposit in the United States mail, postage prepaid; or, if sent by facsimile, upon transmission; or one (1) Business Day following deposit with Federal Express, UPS or similar nationally recognized overnight courier service, addressed to CITY or GHAD, as the case may be, at the address set forth below (or at such other address as CITY or GHAD may specify by notice given pursuant to this Paragraph):

- 8.6 <u>Business Days</u>. The term "Business Day" as used in this Agreement shall mean any day other than: (a) a Saturday, Sunday or a public holiday in the State of California; or (b) a day on which state, federal or municipal offices are closed for the conduct of business. If the time period for the performance of any act called for under this Agreement expires on a day other than a Business Day, said act may be performed on the next succeeding Business Day.
- 8.7 <u>Severability</u>. In case any one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision hereof, and the

remainder of the provisions of this Agreement shall continue in full force and effect without impairment.

- 8.8 <u>Time of the Essence</u>. Time is of the essence in this Agreement.
- 8.9 <u>Waiver</u>. The waiver by either party of a breach of any provision of this Agreement shall not be deemed a waiver of any subsequent breach whether of the same or another provision of this Agreement.
- 8.10 <u>Counterparts and Duplicate Originals</u>. The Parties may execute this Agreement in two or more counterparts, which shall, in the aggregate, be signed by all parties. Each counterpart shall be deemed an original instrument as against any party who has signed it. This Agreement may be executed in any number of duplicate originals, all of which shall be of equal force and effect.
- 8.11 <u>Amendments in Writing</u>. The provisions of this Agreement may not be amended or altered except by a written instrument duly executed by each of the parties hereto.
