#### **CALL MEETING TO ORDER**

Council Member (CM) Salinas called the meeting to order at 5:30 p.m. with CM Wahab. CM Zermeño was excused.

#### **PUBLIC COMMENTS**

None.

## **REPORTS/ACTION ITEMS**

## 1. Approval of Minutes for January 23, 2020

A motion was made by Council Member Wahab and seconded by CM Salinas. The motion passed unanimously with Council Member Zermeño absent; minutes approved as submitted.

## 2. The Effect of COVID-19 on Airport Operations and Financial Performance.

Airport Manager Doug McNeeley presented the report, which demonstrated the impact of COVID-19 on operations and finances for general aviation.

Council Member Salinas queried as to who is at the airport during the Shelter in Place. Mr. McNeeley responded that the airport is open as it was deemed an "essential business". Both the Air Traffic Controllers and City of Hayward staff are working on a limited basis, and the control tower has reduced their operating hours.

#### **Public Comments**

None.

## 3. Consideration of Hangar Rent Increase for Fiscal Year 2021

Airport Manager McNeeley presented the report which included three options regarding fiscal year 2021 rent increases for council members to consider.

There was a discussion about what the deferment of rent means to the tenants, the Airport budget, and the possible continued impacts of the COVID-19 pandemic.

Council Member Salinas asked, in terms of City staff and operations, what actions would be necessary for the Airport to be back at 100%. Mr. McNeeley answered that a change to the Alameda County Public Health Officer's order is needed for City staff to cease working from home and return to the Airport full-time. As for airport operations, staff is already seeing a rebound after the initial Shelter in Place order from March 2020.

A motion was made by Council Member Wahab and seconded by CM Salinas to defer the rent increase to October 1, 2020 and recommended this item to City Council. The motion passed.

### **Public Comments**

None.

## 4. Cancelation of Airport Open House for 2020

Mr. McNeeley presented the report describing impacts of the COVID-19 pandemic to Airport Open House 2020. Staff recommended that the 2020 Airport Open House be canceled.

A motion was made by Council Member Wahab and seconded by CM Salinas to cancel Airport Open House 2020. The motion passed.

#### **Public Comments**

## 5. Oral Presentation of the Sulphur Creek Mitigation Design Project

Airport Manager McNeeley presented an update on the design phase of the Sulphur Creek Mitigation project. In July, Airport Staff was informed by the FAA that due to the uncertainty

surrounding the timing of the project, funding for the Sulphur Creek Mitigation Project will not happen in FY2021 and it will be deferred to FY2022.

Council Member Wahab asked if the Friends of the San Lorenzo Creek know about the updated status of the project. Mr. McNeeley answered that they know about the agencies and the mitigation opinions but not about the recent change of the FAA Grant.

Council Member Salinas asked if a mitigation project could be done at either Skywest Golf Course or on the other end of Sulphur Creek. Airport Manager McNeeley responded negatively. The mitigation cannot be done on the golf course due to the proximity of the Airport. FAA regulations state that wildlife attractants cannot be in a 10,000 ft radius of the runways. Kimley-Horn & Associates' consultant Bob Hamilton said that he examined the 18 sites which Friends of San Lorenzo Creek suggested for mitigation, and many sites do not have 1,200 linear feet of restorable area to compensate for the Airport's project. The SoHay development is the only space of this size and, unfortunately, this site is not likely to be approved by all three agencies.

## 6. Oral Presentation of the Annual Evaluation of Airport Noise Program

Airport Operations Specialist Ara Balian presented the report. He provided charts that illustrated: 1) Total Complaints vs Exceedances, 2) Total Operations vs. Total Complaints, 3) Total Operations vs. Exceedances, and 4) Total Complaints by Household.

The committee discussed the amount of complaints and process of notifying pilots of exceedances of the Noise Ordinance. Mr. Balian invited the committee to the Airport's Noise Office to see the equipment used and the procedures he follows when responding to noise complaints.

CM Salinas suggested that the Airport host a meeting with homeowners and realtors to educate people on the existence of the airport and the types of community services the airport provides.

#### **SUMMARY**

In November 2017, the City entered into a lease agreement with a developer to build two new hotels on vacant airport parcels. The first hotel, which is a Home2Suites property, will be built on the parcel located on Hesperian Boulevard.

Within the past year, the following items have taken place and have allowed the project to commence construction:

- Preparation and approval of plans and specifications.
- FAA determinations that the proposed structures were not a hazard to air navigation
- FAA verification that the leasehold had been released for non-aeronautical use
- Issuance of building permits and payment of fees
- Installation of perimeter fencing, and
- Commencement of grading at site

Due to the nature of this project, which utilizes prefabricated rooms built off-site, construction should be completed within just one year, with completion in the Fall of 2021.

#### **BACKGROUND**

Over the past several years, staff developed a plan to market non-aeronautical parcels on Airport property. A developer expressed interest in three parcels for the potential development of two hotels. This interest culminated in an agreement between the two parties, and on November 14, 2017, Council approved ground lease agreements between the City and both Ramesta Hospitality, LLC (for the Home2Suites hotel on Hesperian Boulevard),

and Mahabal Hospitality, LLC (for the Hyatt Place hotel at the corner of West A Street and Skywest Drive). In October 2018, a First Amendment was approved by Council to finalize financing requirements with the developer's lender for each lease. In October 2019, a Second Amendment was approved by Council that extended the Hyatt Place construction period from November 2019 to November 2020.

#### **DISCUSSION**

Since the last update approximately one year ago, the following actions have taken place:

- The developer prepared plans and specifications for the first hotel, which will be a Home2Suites on Hesperian Boulevard near the corner of Skywest Drive. The plans were subsequently approved by the City.
- The FAA determined the proposed structures were not a hazard to air navigation, thereby officially allowing construction to occur.
- The FAA verified that the leasehold had been released for non-aeronautical use.
- The building permits were issued, and all applicable fees were paid by the developer.
- Perimeter fencing has been placed around both the Home2Suites site and the Hyatt Place site (located on the corner of Skywest Drive and West A Street).
- Grading has commenced at the site.

Construction has now commenced and will take approximately one year, with completion anticipated in the Fall of 2021. After grading is completed and a slab is poured on the site, the prefabricated rooms will be installed. This process can save the developer some construction time, thereby allowing the hotel to be built in about one year versus up to two years for a more traditional "stick built" design.

As noted in prior reports, each leasehold is approximately 160,000 square feet and will contain the following features and amenities:

- 120 rooms;
- One banquet facility that seats approximately 150 persons, and can be subdivided into smaller rooms;
- A swimming pool;
- A nationally branded, stand-alone restaurant at the Hyatt that is approximately 6,000 square feet in size; and
- A small, ancillary retail store at Home2Suites

### **ECONOMIC IMPACT**

The hotel developments will generate work for skilled and unskilled tradespeople during the construction phase, and retail/service sector jobs after the hotels are built.

#### FISCAL IMPACT

Once the hotels are operational, the Airport Operating Fund will realize a revenue increase of approximately \$210,000 per year from each hotel, or an annual total of \$420,000. Additional annual economic impact from transient occupancy tax, sales tax, and property tax will be approximately \$500,000 per site, which will benefit the City's General Fund.

#### STRATEGIC ROADMAP

The construction of the Home2Suites Hotel indirectly supports one of the goals contained in the Strategic Roadmap, which is Improve Organizational Health (Fiscal Sustainability). Furthermore, the project promotes beneficial economic development in this portion of the City.

#### **SUSTAINABILITY FEATURES**

The Airport is strongly committed to developing projects that are environmentally responsible. Therefore, staff ensured that the approved plans incorporate features that are in line with the City's sustainability guidelines.

#### PUBLIC CONTACT

This topic was discussed at the Council Airport Committee meeting of October 12, 2017, with unanimous support expressed for the project. Furthermore, the projects were approved by Council on November 14, 2017. The First Amendment for both developments was reviewed and approved by Council on October 16, 2018. The Second Amendment was reviewed and approved by Council on October 1, 2019.

## **NEXT STEPS**

Airport staff will keep the Committee updated and apprised of the construction progress over the next year.

#### RECOMMENDATION

#### **SUMMARY**

Aviation company Set Jet has proposed charter flights serving the Bay Area from the Hayward Executive Airport. The airport is designated as a "national" general aviation airport by the Federal Aviation Administration, and this service will bring additional travel options for the public flying throughout the west.

#### **BACKGROUND**

Based Commercial Tenant APP Jet Center (APP) was approached several months ago by Set Jet, a privately held aviation company based in Scottsdale, Arizona, about the availability of space and support services for the commencement of charter services at the Hayward Executive Airport. A commercial aviation sublease was executed by both parties at the conclusion of negotiations and Set Jet anticipates the beginning of service on January 5, 2021. Prior to initiation of service, Set Jet will apply for the appropriate City and airport permits.

#### DISCUSSION

According to the corporate website <a href="www.setjet.com">www.setjet.com</a>, Set Jet is a membership based private jet charter program, available for security pre-screened and approved members. A limited number of memberships are available in each city that it serves. Charges include a one-time security check fee of \$99.95, a monthly membership fee of \$99.95, and one-way fares averaging \$450. Set Jet uses existing FAA Part 135 charter operators to crew and manage the aircraft in their fleet. Set Jet is not a regularly scheduled FAA Part 121 air carrier like United or Southwest Airlines. They currently serve the Bay Area from San Francisco International

Airport, but APP is anticipating that Set Jet will relocate from SFO. Set Jet currently serves destinations in the west such as Los Angeles, Las Vegas, San Diego, and Denver.

Set Jet proposes up to three daily flights from Hayward, initially using a Challenger 850 aircraft. This is a familiar regional jet with the airline interior replaced with a 15-seat executive interior comparable to other corporate jets. A freight version of this aircraft has operated at Hayward with no issues. In the summer of 2021, Set Jet proposes the use of an Embraer Lineage 1000 jet, essentially the proven Embraer 195 regional jet. This aircraft is a newer design incorporating features that allow it to operate from general aviation airports with shorter runways.

Service is tentatively planned to begin on January 5, 2021. Set Jet's initial publicity will include appearances on local television channels.

#### **ECONOMIC IMPACT**

This new service will generate work for those in the aviation industry, such as pilots and ground crews.

#### **FISCAL IMPACT**

The Airport's commission from fuel sales is five cents per gallon of products delivered or an amount equal to 3% of the gross receipts, whichever amount is greater. This new charter service will generate up to an additional 1 million gallons per year in sales, which is estimated to increase annual fuel flow revenues by \$50,000. This revenue will be dedicated to the Airport Fund and help make the airport more financially self-sufficient.

#### STRATEGIC ROADMAP

Due to the increase in fuel flow revenue, this service indirectly supports one of the goals contained in the Strategic Roadmap, which is Improve Organizational Health (Fiscal Sustainability).

### **SUSTAINABILITY FEATURES**

This report is informational in nature and does not pertain to any sustainability features.

#### PUBLIC CONTACT

The agenda and staff report for this item have been posted on the City's website and distributed to interested parties.

## **NEXT STEPS**

CAC members have raised the desirability of additional travel options from the airport, and this new charter service will provide such an option. Staff will continue to work with APP Jet Center to facilitate the new service.
