Public Outreach and Response

- Public hearing notices sent to all property owners, tenants, and bill payers of record (Proposition 218 only requires notification of owners)
- Proposed rates published twice in newspaper
- 30 written protest notices received as of close of business on June 19
 - > 11 cited financial hardship
 - City responded with information on low-income discount for water service charge
 - > The rest provided no specific reason
- Council cannot adopt rates if protests are received from a majority of property owners (about 19,000 protests)
- Proposed connection fee information distributed to developers, Building Industry Association, and the Chamber of Commerce Government Relations Council

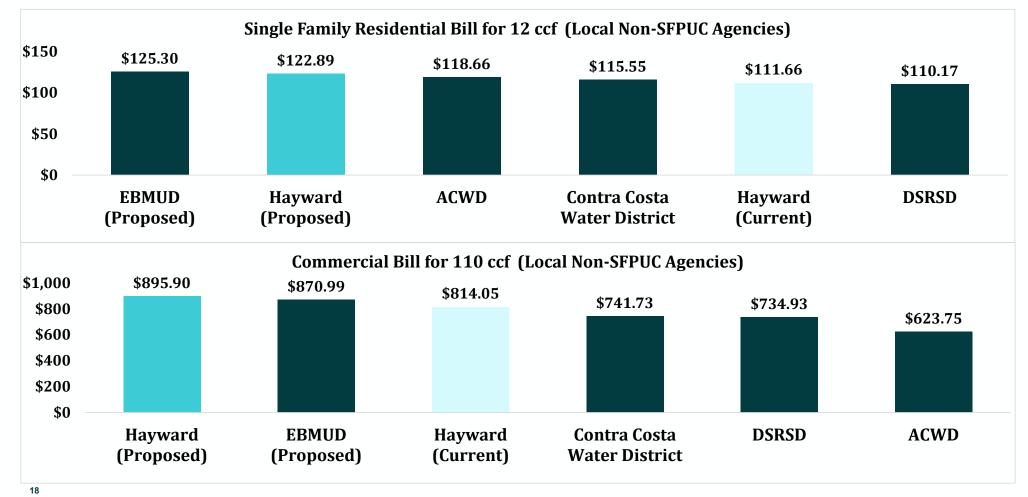

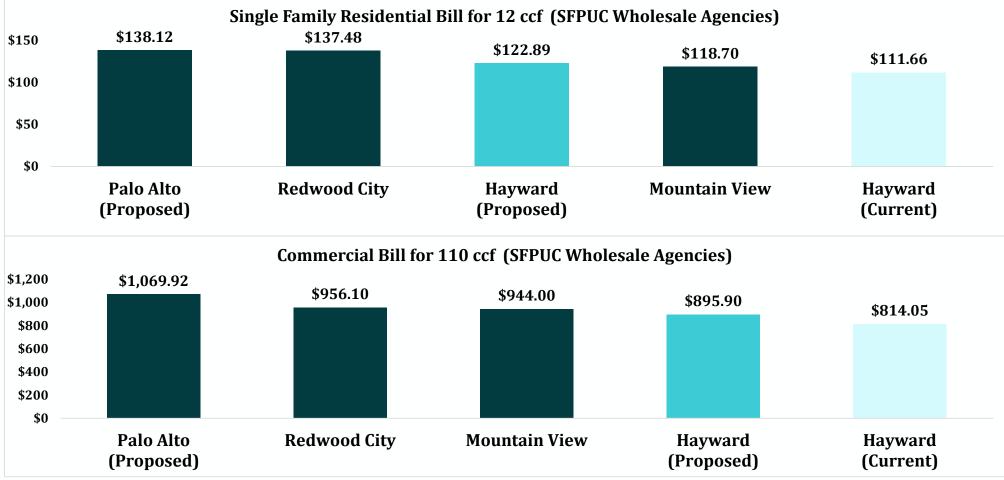

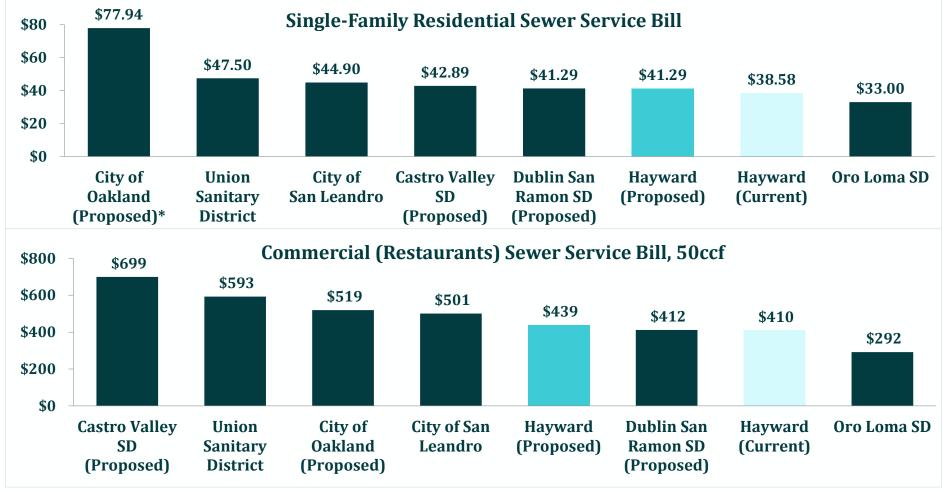

Sewer Bill Comparison

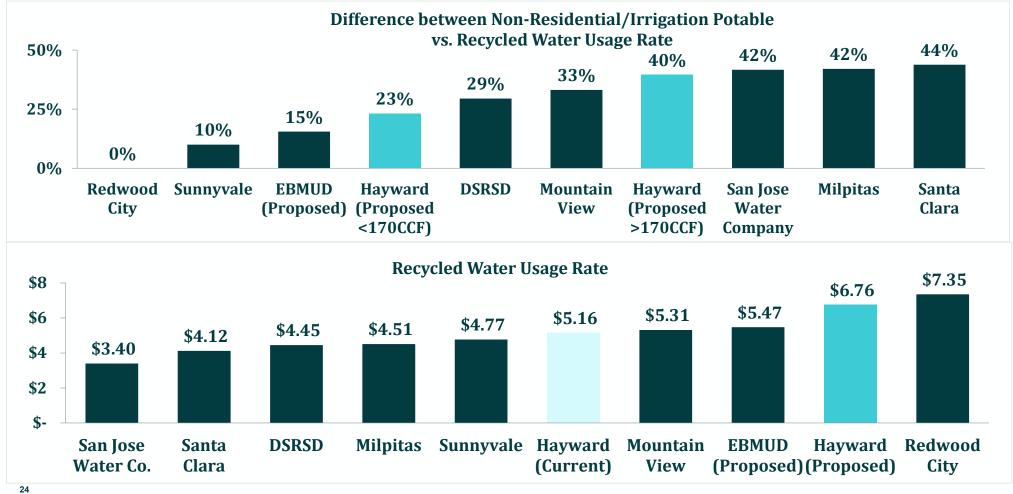

Hybrid Method (Water and Sewer)



- Focuses on the summation of existing capacity and any necessary expansion to serve growth
- Typically used where some capacity is available, but additional expansion is necessary to accommodate new growth
- Capital costs associated with repair and replacement of the existing system should not be included in the calculation

Capacity Buy-In Method (Recycled Water)



- Focuses on additional capacity provided by improvements planned to accommodate growth
- Agency calculates charge based on amount of capacity needed to serve specific development coming online
- Used for recycled water since it is a new system and Master Plan is planned for next year

2023 AB481 Military Equipment Annual Report to Council

Purpose

- Provide information regarding Assembly Bill No. 481.
- Present the Hayward Police Department's FY 2023 AB No. 481 Annual Report, including the funding, acquisition, and use of the equipment considered "Military equipment."
- Discuss future acquisitions needed to continue to provide vital public safety services to our community.

Background

- AB No. 481, which became effective on January 1, 2022, was created to address transparency issues in the funding, acquisition, and use of law enforcement equipment that lawmakers have designated as "military equipment."
- AB No. 481, codified in Government Code section(s) 7070 through 7075, requires law enforcement agencies to obtain approval of the applicable governing body (City Council), by adoption of a written Military Equipment Use Policy, via ordinance, at a public hearing, before law enforcement agencies may take certain actions relating to the funding, acquisition, or use of military equipment, as defined by the legislature.
- Once approval is granted, AB No. 481 requires law enforcement agencies to submit an annual Military Equipment Use Report to the City Council, summarizing the use of each type of equipment, complaints received, internal audits and information about violations of the Military Equipment Use Policy, the cost of military equipment, and other similar information.
- On an annual basis, the City Council must review the Military Use Policy and ordinance as well as the Military Equipment Use Report and vote on whether to renew the ordinance.

Use of "Military Equipment"

Below is a list of HPD's "Military Equipment" and usage (July 2022 – March 2023):

- 1. Robot 3
- 2. UAS 70
- 3. Armored Personnel Carrier 9
- 4. Command Vehicle 3
- 5. Noise Flash Diversionary Device 12
- 6. Chemical Agents "Tear Gas" 1

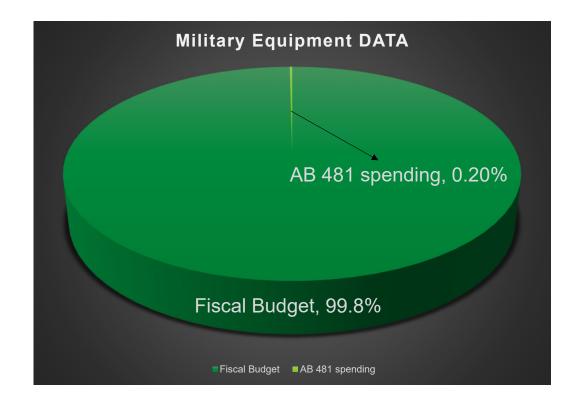

Fiscal Impact





Projected Acquisitions for FY 2024

- Some purchases and acquisitions can be anticipated
- Unanticipated replacement of existing AB No. 481 equipment may be necessary due to damage beyond that of repair, unanticipated usage, etc. (handled on a case-by-case basis depending on operational needs)
- Consumable equipment acquisitions in the next 12 months will remain consistent with current department replenishment schedules.

Consumables are as follows:

- Ammunition- all calibers
- Diversionary Devices
- Chemical Agents
- Specialty Munitions (40mm and Less Lethal Munitions)

Federal 10-33 Program

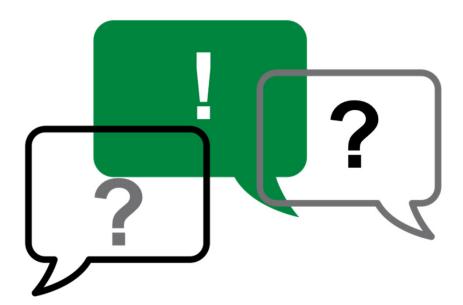
- Law Enforcement Support Office (LESO) Program administered by Cal OES – referred to as the 10-33 Program
- Allows for local agencies (including HPD) to acquire equipment purchased by Dept of Defense (DoD)
 - Equipment has already been paid for by taxpayers
 - Equipment is in excess or no longer needed by DoD
 - Equipment is primarily clothing, office supplies/furniture, rescue equipment, vehicles, etc.
 - Less than 2% of statewide requests involve small arms or tactical vehicles
- HPD does not intend to acquire weapons or tactical vehicles through this program (would need Council approval)

Recommendation

- 1. Renew the City Ordinance related to the Use of Military Equipment by the HPD (No changes)
- 2. Renew HPD Policy 706 (No changes)
- 3. Approval of equipment replacement/acquisition in FY 24
- 4. Remain enrolled in the 10-33 (LESO) Program

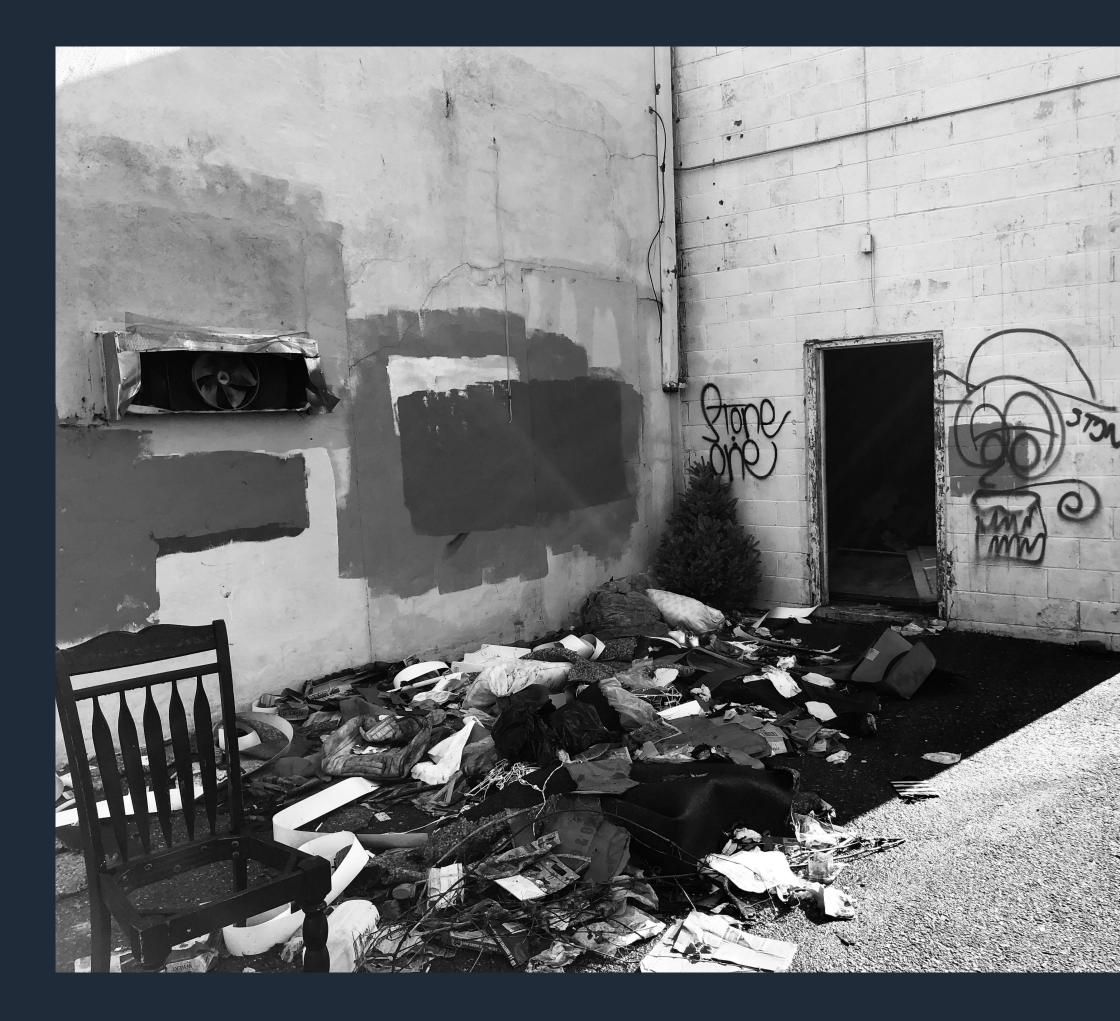

BACKGROUND Chapter 5, Article 7 – Community Preservation Ordinance



Information

The Community Preservation Ordinance (as summarized in the Staff Report) was initially created to respond to and address general neighborhood blight. Conditions such as graffiti, lawn parking, junk and debris and other general property nuisances were the initial focus. There are an average of 2,492 of these case types per year.

PROBLEM DEFINED



With the increasing complexity of violations related to community preservation, the utilization of the Community Preservation Ordinance and its enforcement program has grown, contributing to an average annual increase of 32 percent (1,208 cases per year). This is primarily due to the flexibility inherent in the ordinance and the established policies. Nevertheless, in order to ensure a consistent response to these evolving requirements and address any administrative shortcomings in the current code, updates are necessary to guarantee the ongoing effectiveness of the ordinance.

In alignment with the City's Strategic Roadmap aimed at enhancing community safety and improving quality of life, the proposed revisions (as detailed in the provided Staff Report) to the Community Preservation Ordinance have been developed. These updates aim to address the growing range of nuisance categories, enhance the ordinance's effectiveness in combating blight and promoting livability, and bring greater clarity to the administrative procedures involved.

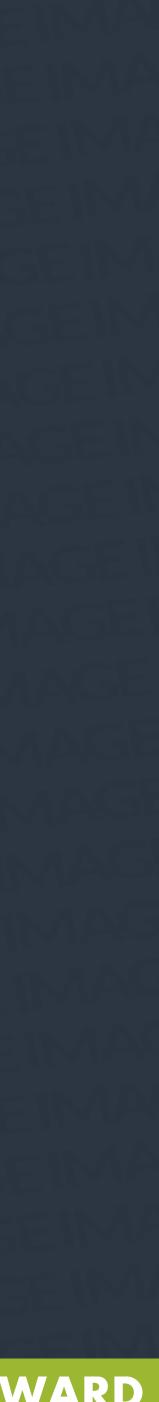

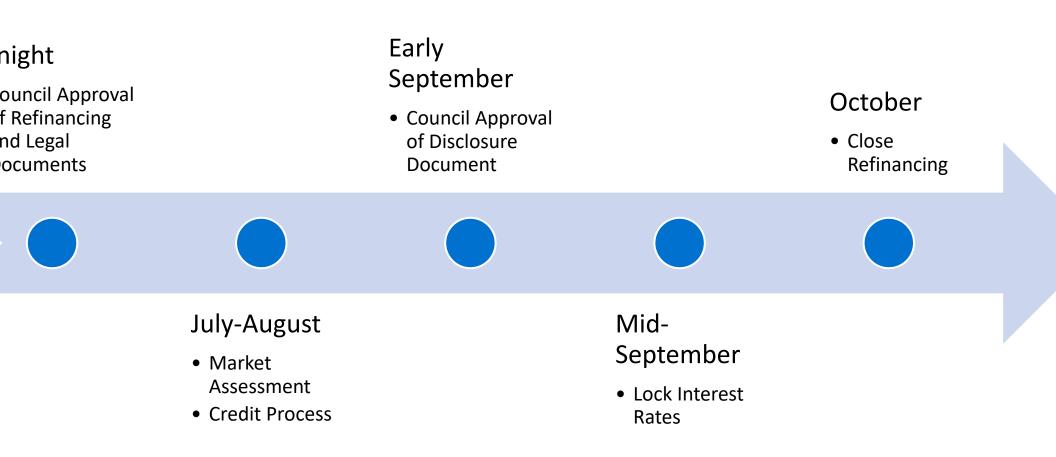
