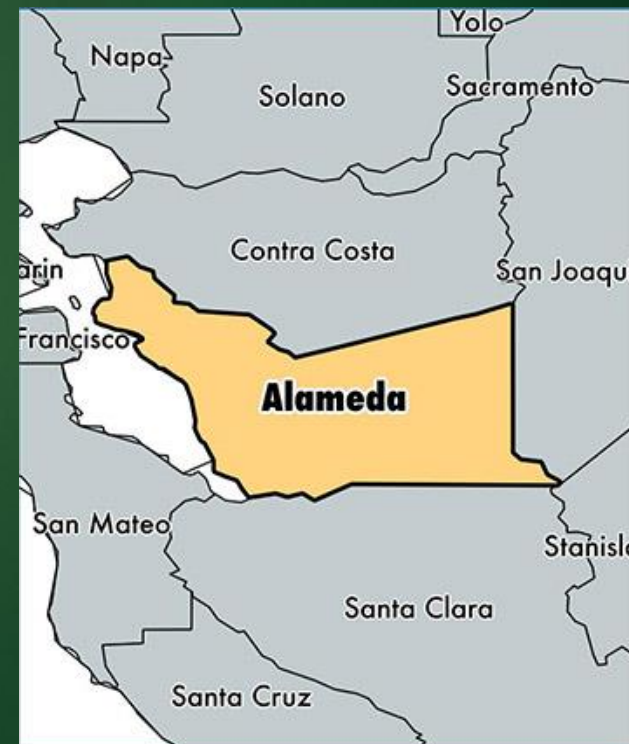

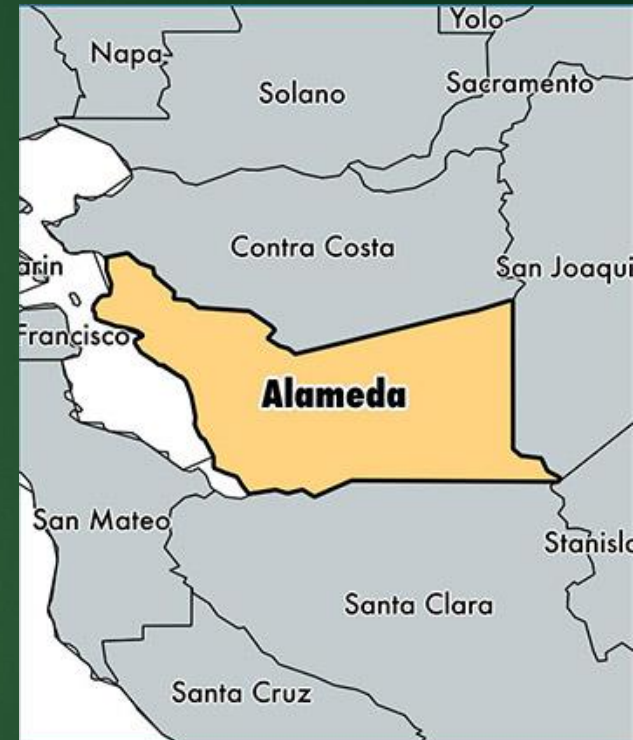




# East Bay Community Energy

  - ▶ Develop local renewable energy in Alameda County



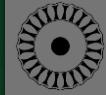
# Questions Addressed in Paper

# Possible Scenarios



1. CCA does not offer any ratepayer-funded energy efficiency programs.
2. CCA does not offer its own energy efficiency programs, but supports other organizations' programs.
3. CCA provides ratepayer-funded energy efficiency programs only to fill gaps in current programming.
4. CCA offers ratepayer-funded energy efficiency programs that absorb, compete with, or replace existing East Bay programs.
5. CCA offers non-ratepayer-funded energy and GHG reduction programs.
6. EBEW takes on a formal coordination role among local governments, utilities and CCAs in the East Bay.
7. EBEW splits into two partnerships, with one covering MCE's jurisdictions and the other covering EBCE's jurisdictions.

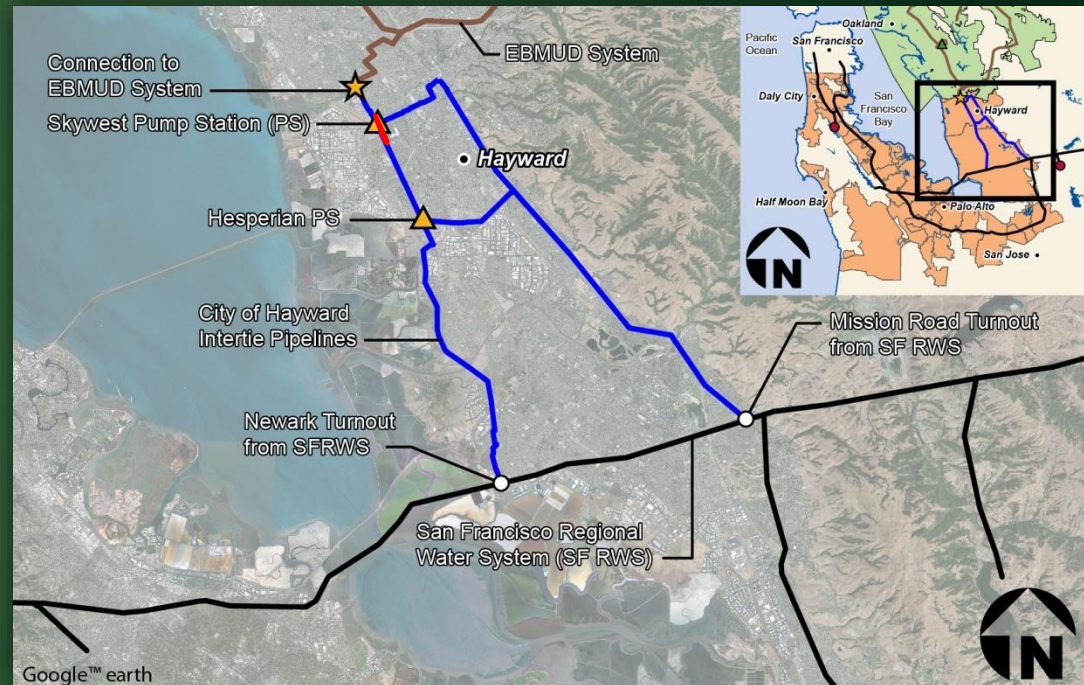

# SFPUC/Hayward/EBMUD Regional Intertie



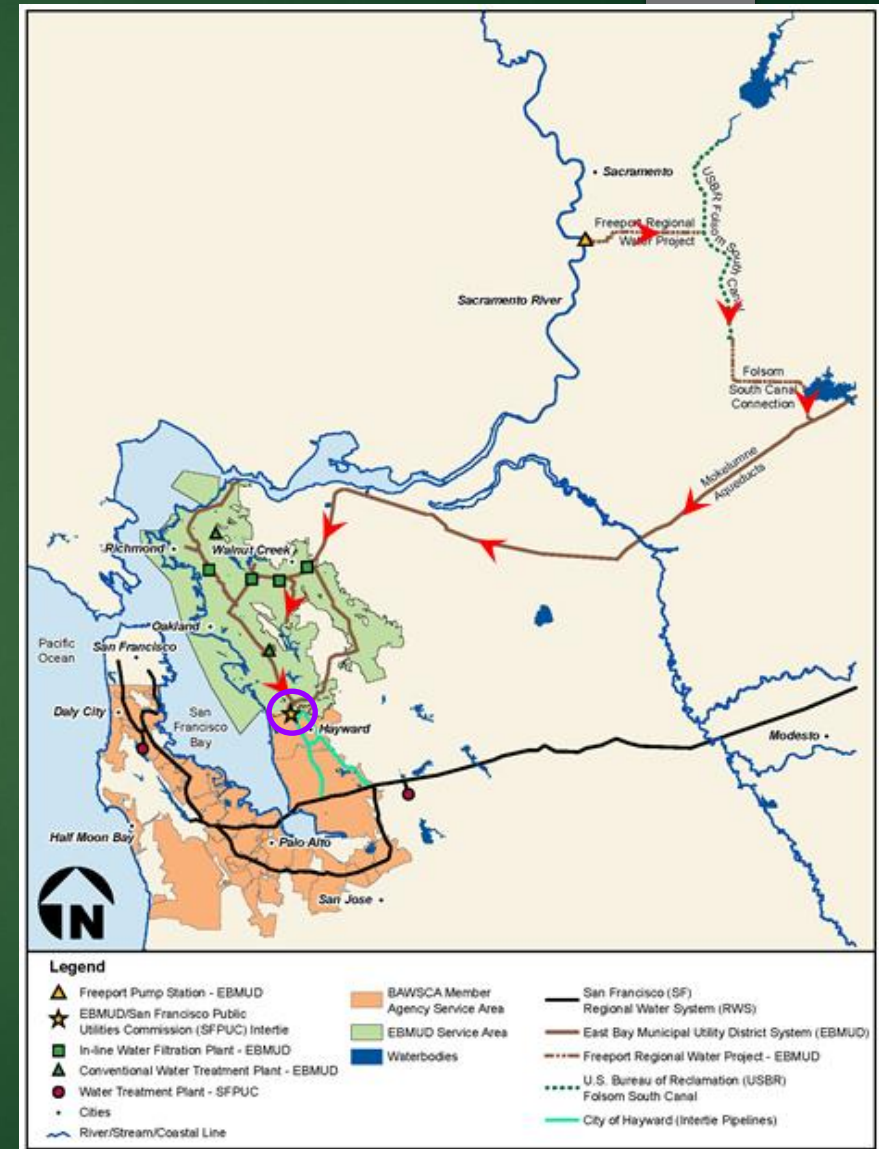
- ▶ Connects EBMUD and SFPUC systems through City of Hayward
- ▶ 30 MGD
- ▶ Emergencies and planned critical maintenance work





# Pilot Water Transfer

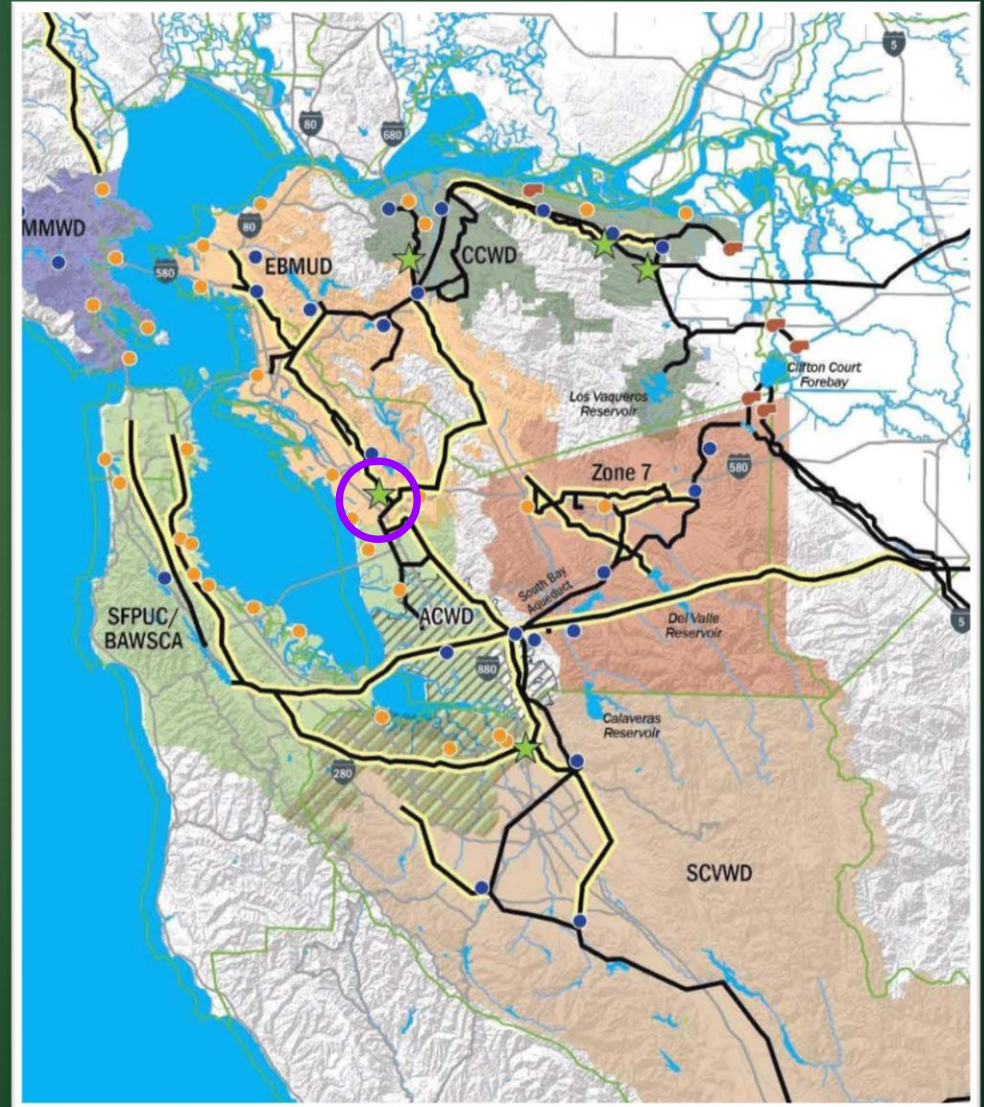
- ▶ BAWSCA interested in piloting water transfer using Regional Intertie
- ▶ Potential water quality and operational impacts to Hayward
- ▶ Initial plans to implement pilot transfer during 2018-2019 Mountain Tunnel shutdown
- ▶ Schedule uncertainty due to changed conditions



# Bay Area Regional Reliability



- ▶ Eight largest Bay Area water agencies
- ▶ Regional solutions to improve water supply reliability
- ▶ Grant funding to develop Regional Water Market Program
- ▶ Potential to implement BAWSCA pilot transfer as part of grant effort

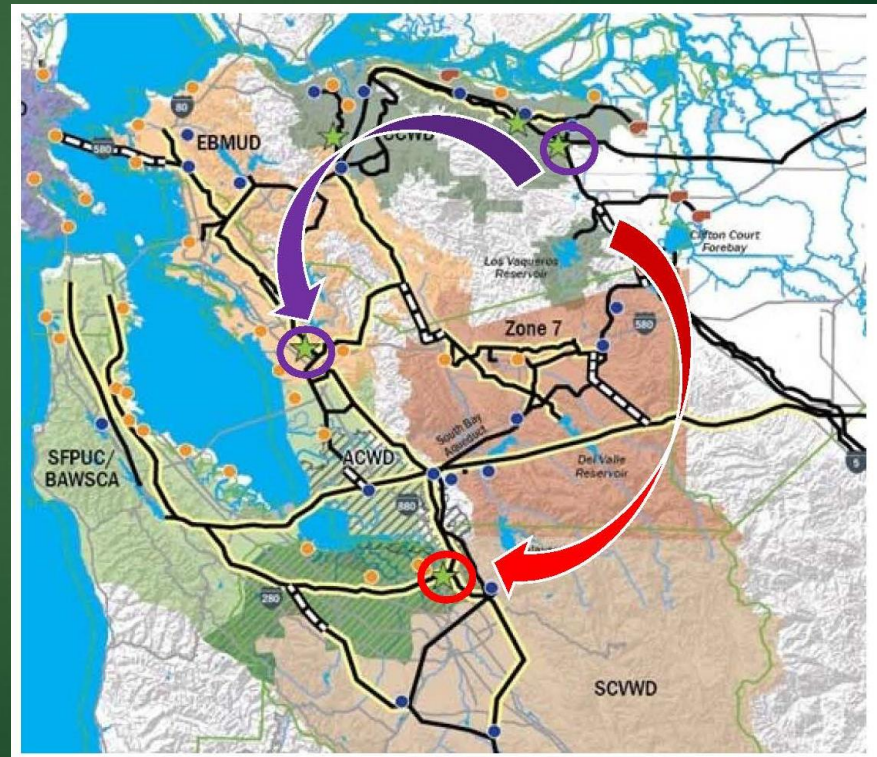




# Los Vaqueros Expansion



- ▶ Contra Costa Water District considering expanding reservoir from 160,000 acre-feet to 275,000 acre-feet
- ▶ SFPUC and BAWSCA identified as potential partners
- ▶ Potential supply alternative could include use of Regional Intertie

- ▶ Continue to work cooperatively with SFPUC and BAWSCA on Mountain Tunnel shutdowns
- ▶ Monitor and participate in regional reliability efforts
- ▶ Keep Committee apprised of progress

- Hayward = Goal of 75% Diversion by 2010, and  
80% Diversion by 2018

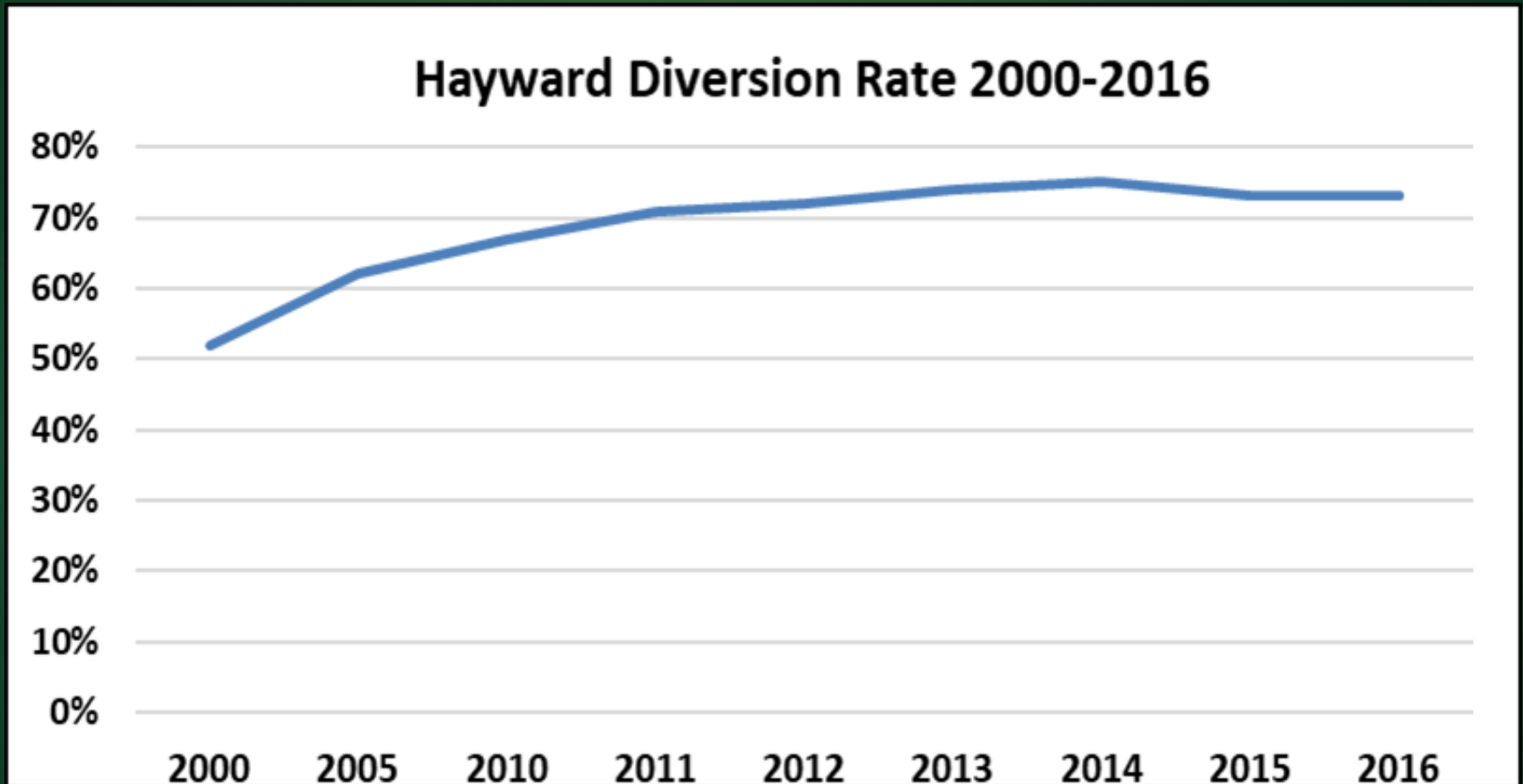
## Mandatory Recycling Ordinance

Diversion 2016 = 73%

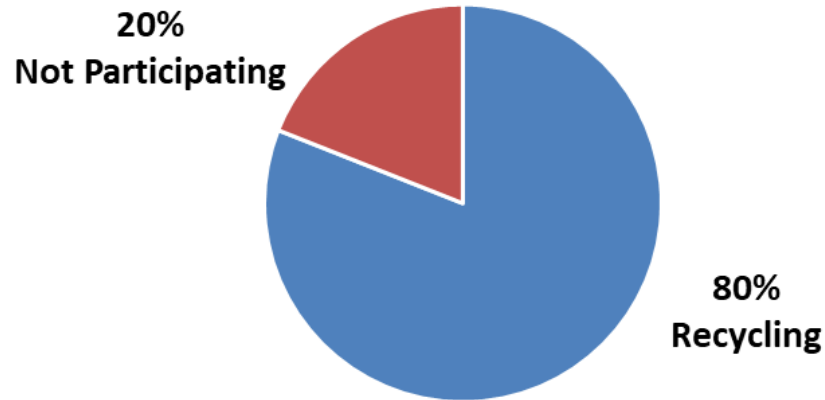

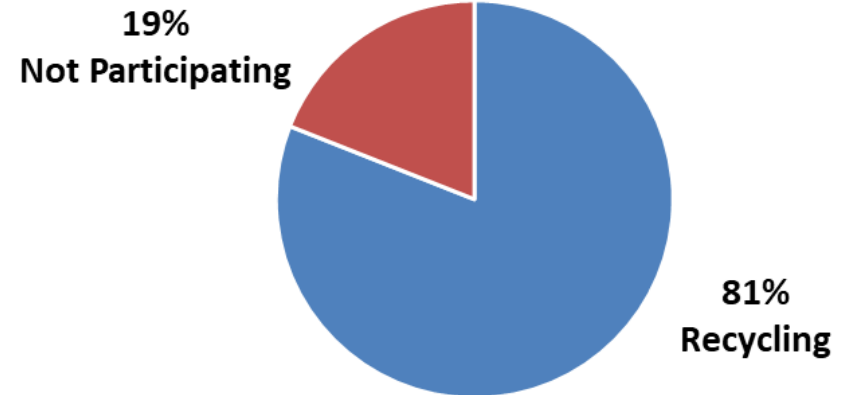


## Businesses Recycling

**Total Businesses Recycling - Dec 2017**

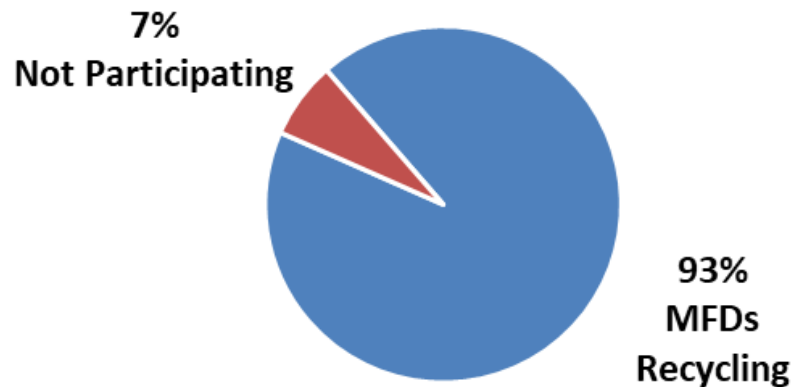

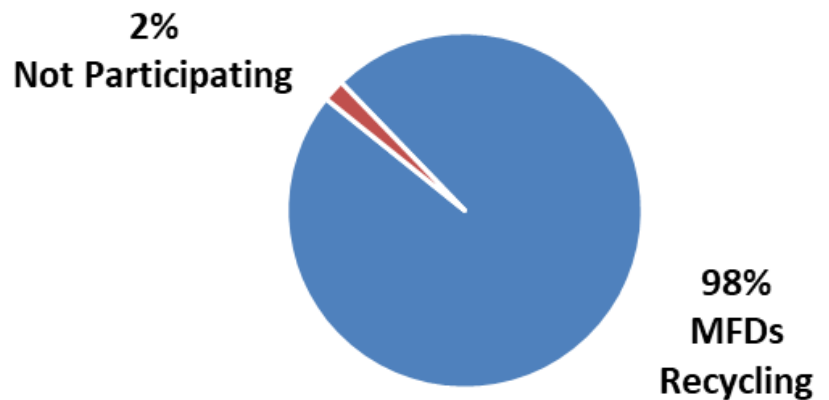


## Multi-Family Recycling

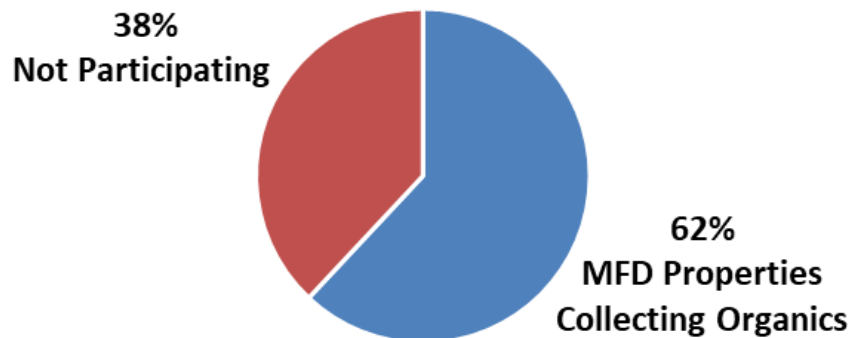

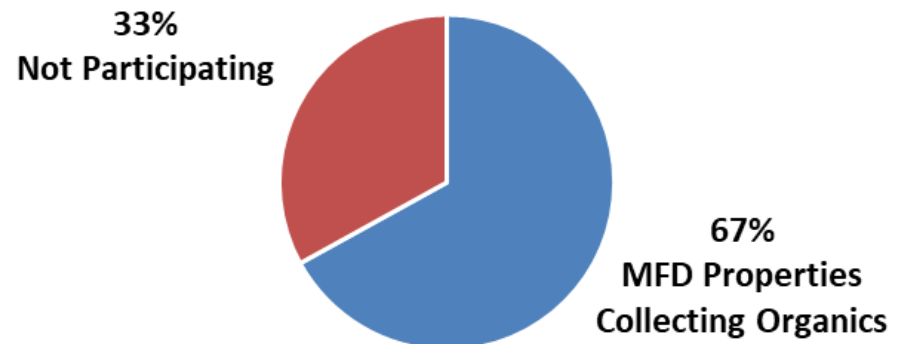


## Multi-Family Organics

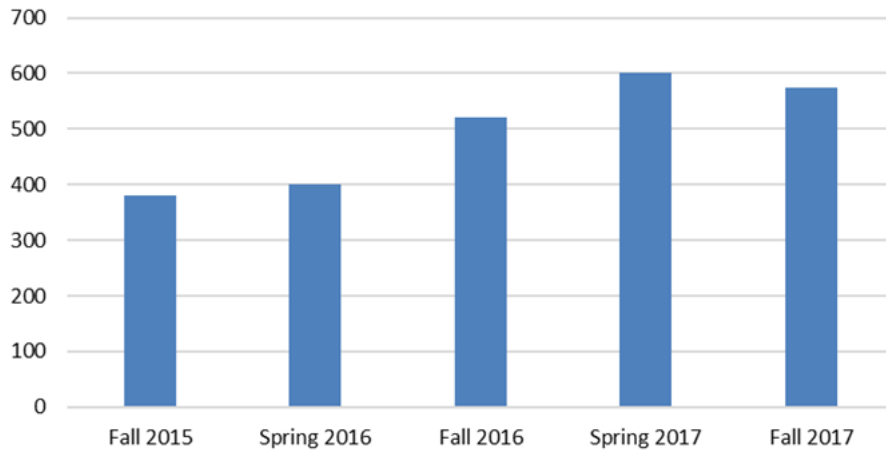

**Compost Giveaway Attendance**

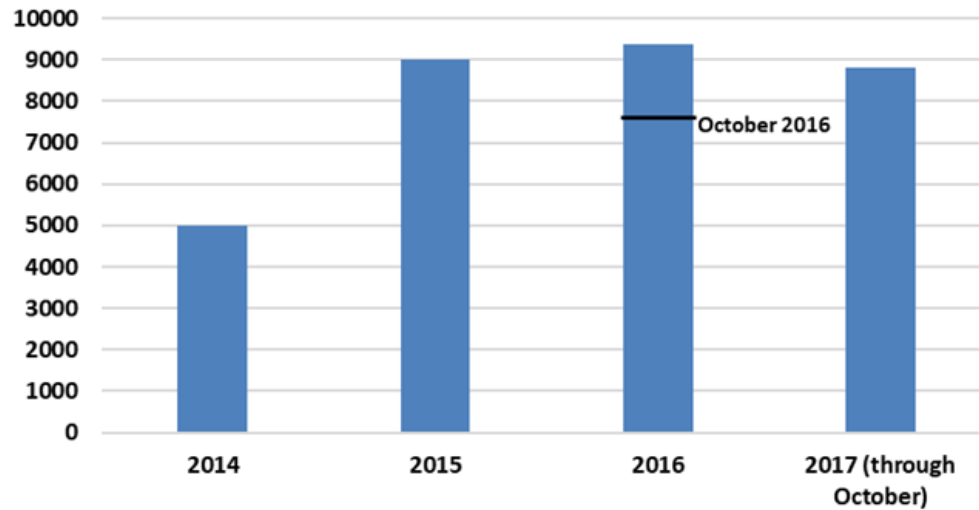

# WMAC Performance



- ▶ Franchise Recovery Rate – contractual benchmark
  - ▶ About 39% in October 2017 - goal 54% for 2017
