Landscape Improvements

- ▶ Completed updates to the landscape surrounding the South Hayward BART Station.
- ▶ Began upgrade to medians on the eastern end of the Corridor.
- ▶ Will continue to upgrade medians throughout FY19.

Downtown Streets Team Tennyson Pilot

- ▶ Cleaning Tennyson Rd every Wednesday-Friday from 8am-12pm
- ▶ 18,275 gallons of debris removed
- ▶ 31 Team Members, 10 people beyond 90-day employment, 17 people from homeless to housed

Façade Improvement Program

- ▶ Outreach conducted to small businesses along Tennyson
- ▶ Thus far, 16 businesses have been approved for the program, at \$10,000 each

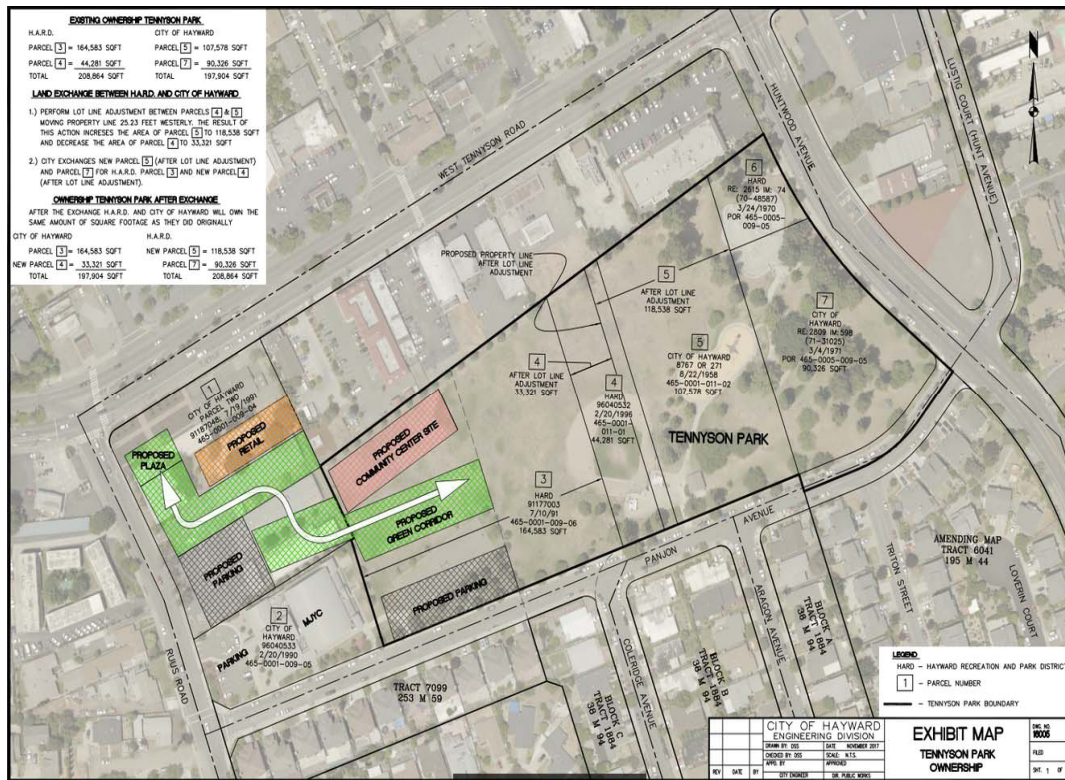

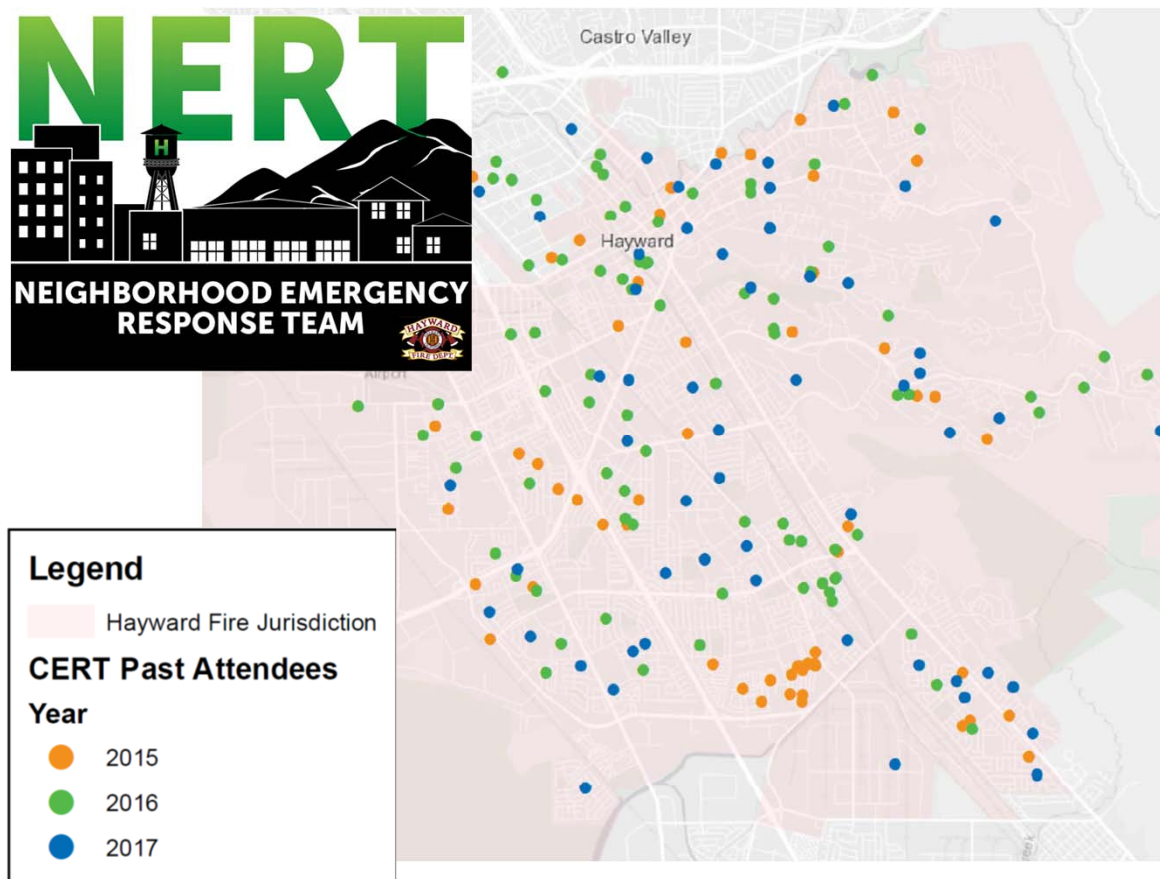


South Hayward Family Center

- ▶ Architect selection (September 27)
- ▶ Mia's Dream Park
 - Current status: 90% Construction documents
 - Community Meeting: September
 - Bid & Award: August - Oct 2018
 - Construction: Nov 2018 - Nov 2019

NERT Program Launched

- Established abbreviated 4 hour curriculum for neighborhood-based trainings in South Hayward

www.hayward-ca.gov/NERT

- FY19 Goals:**
 - Train 240 people through at least 12 groups
 - Engage 6-10 CERT grads to help with the program

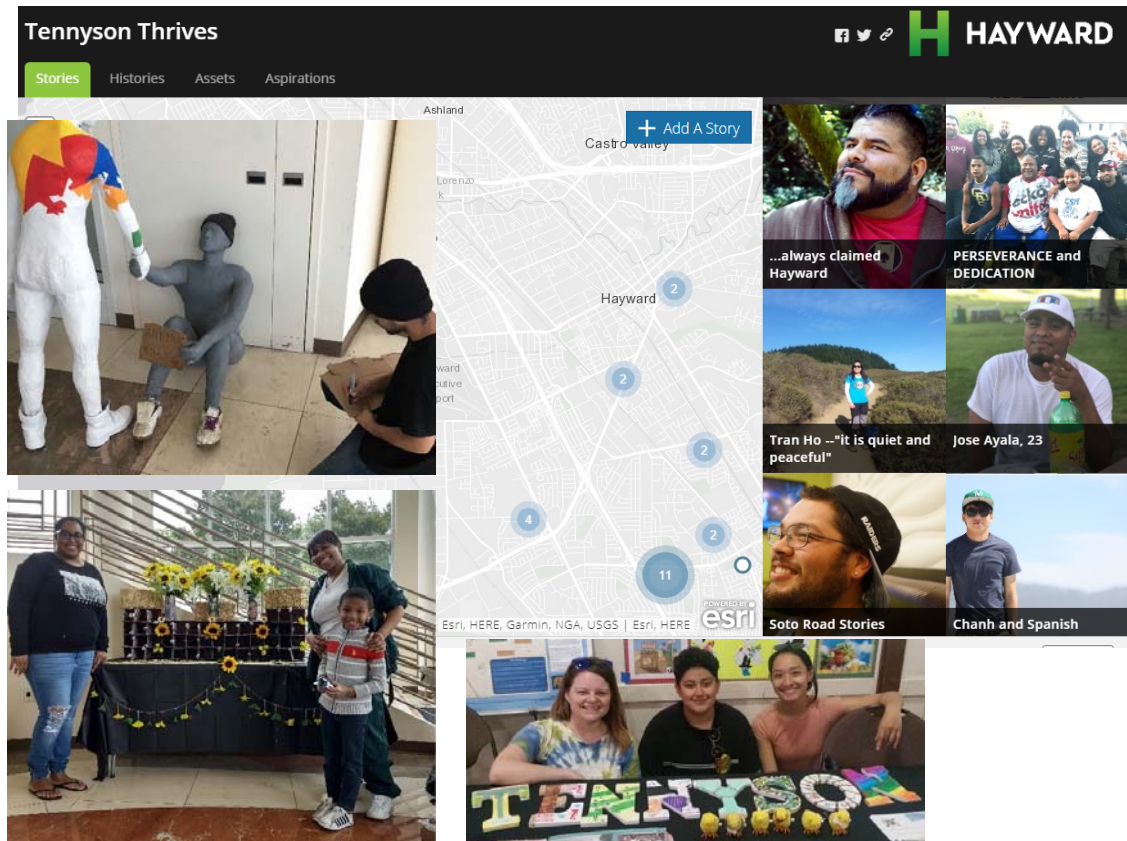
Tennyson Corridor – Resiliency



Energy/Water Efficiency

- ▶ East Bay Energy Watch's Smart Light Program visited 199 businesses and conducted 34 energy audits
- ▶ Grant funding to hire additional California Youth Energy Specialists for summer 2018

Vision Plan Work FY18

- ▶ Partnered with the Chabot College Student Initiative Center to interview over 200 community members
- ▶ Launched a website, online survey, and interactive map: www.Hayward-ca.gov/TennysonThrives
- ▶ Needles in the HayStack Art Exhibit at City Hall
- ▶ Trended results into Opportunity Areas

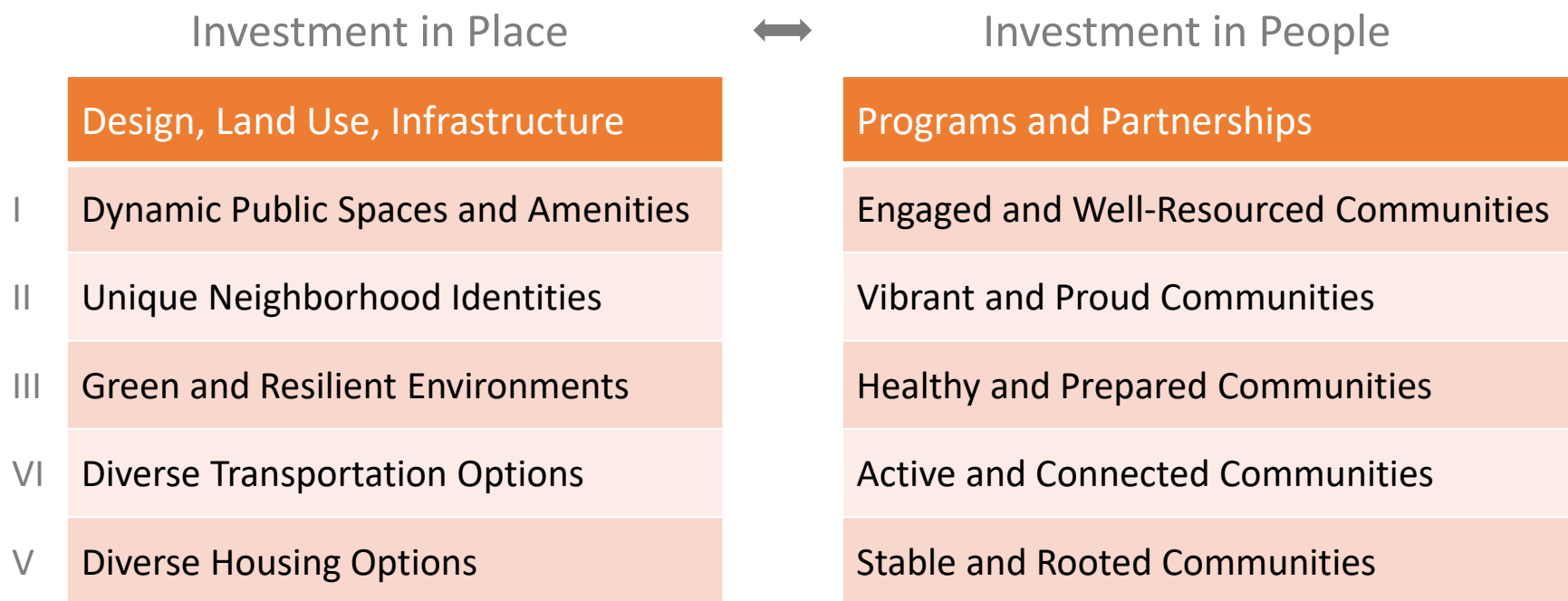


Vision Plan Work FY19

- ▶ Conduct idea-generating sessions and participatory small grant giving
Palma Ceia Fest – July 2018
- ▶ Chabot will focus on testing program and partnership solutions
- ▶ Exploring Cal Poly partnership to create physical design solutions
- ▶ Presentation to Council in June 2019 and final adoption in fall 2019

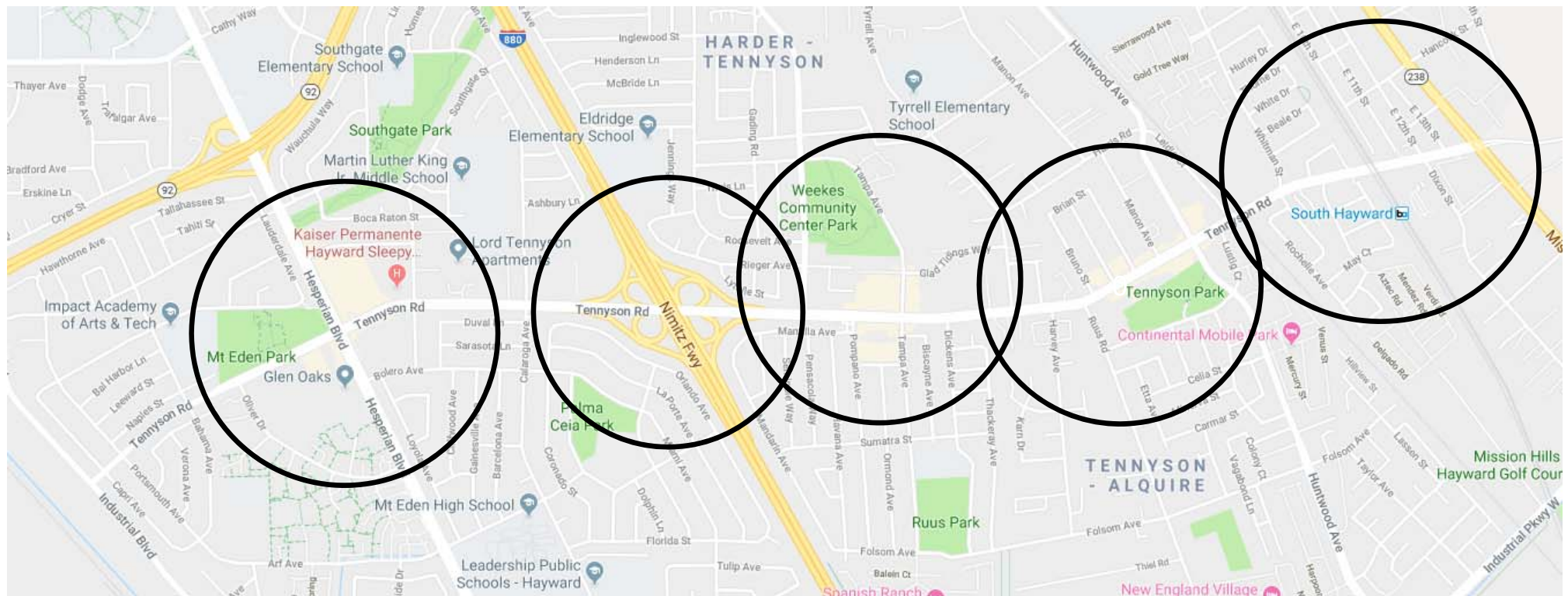

Complete Communities – Housing

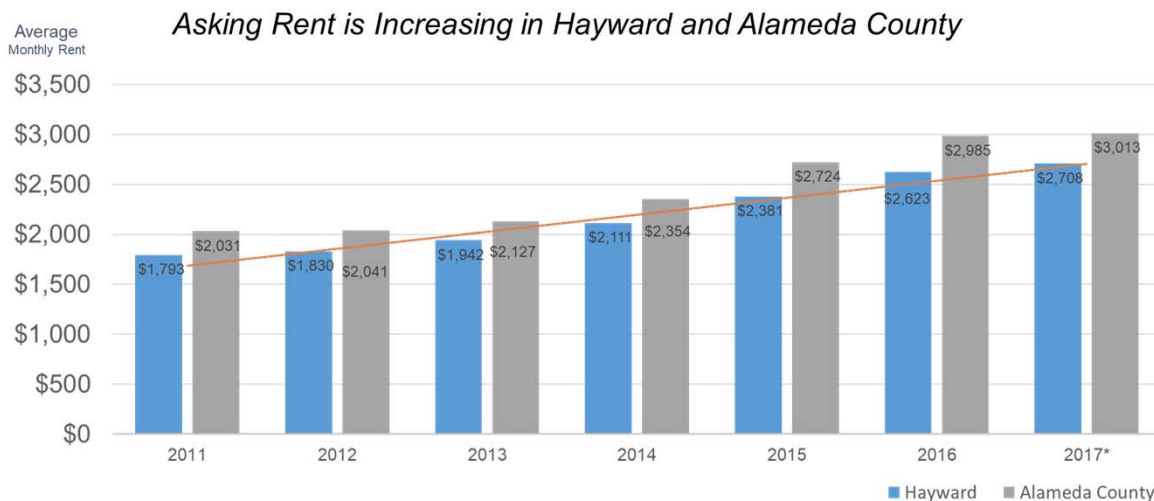


Notice of Funding Availability (NOFA)

- ▶ NOFA released on April 30, 2018
- ▶ Accepted loan applications for affordable rental and supportive housing development
- ▶ Staff will make recommendations to Council in October 2018

Complete Communities – Housing

Housing Data



Rent Stabilization

- ▶ Council approved amendment to the RRSO to clarify that eviction for cause provisions apply to all units covered by the ordinance.
- ▶ Council approved 18-month on vacancy decontrol moratorium in May 2018.
- ▶ Staff will release RFP in September to find consultant to evaluate the vacancy decontrol process.
- ▶ Staff will return to Council with an update in February 2019.

Park In-Lieu Fee Review

- ▶ RFP issued for nexus study in March 2018
- ▶ Community Attributes Inc was chosen to prepare the nexus study
- ▶ Work began in May 2018 and is expected to conclude by March 2019

Complete Communities – Regulatory Toolkit



Form Based Code

- ▶ Lisa Wise Consulting was selected as the consultant to prepare the update
- ▶ Contract approved by the City Council on May 22, 2018
- ▶ Kickoff meeting held in July 18th

Complete Communities – Regulatory Toolkit



Shoreline Master Plan

- ▶ City received a Caltrans grant for \$509,000 to complete the study
- ▶ Project will kick-off in October, including hiring of a consultant
- ▶ Estimated completion in February 2021

Complete Communities – Regulatory Toolkit



Industrial District Regulations

- ▶ Draft regulations being reviewed by staff
- ▶ Upcoming study sessions with Planning Commission in October and City Council in early 2019

Complete Communities – Regulatory Toolkit



Vacant Property Ordinance & Registration Program

- ▶ Establishes enforcement processes to protect neighborhoods from distressed vacant buildings
- ▶ Ordinance final draft is under review
- ▶ Presenting to Council in winter 2018

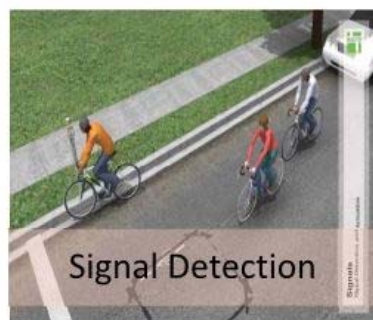

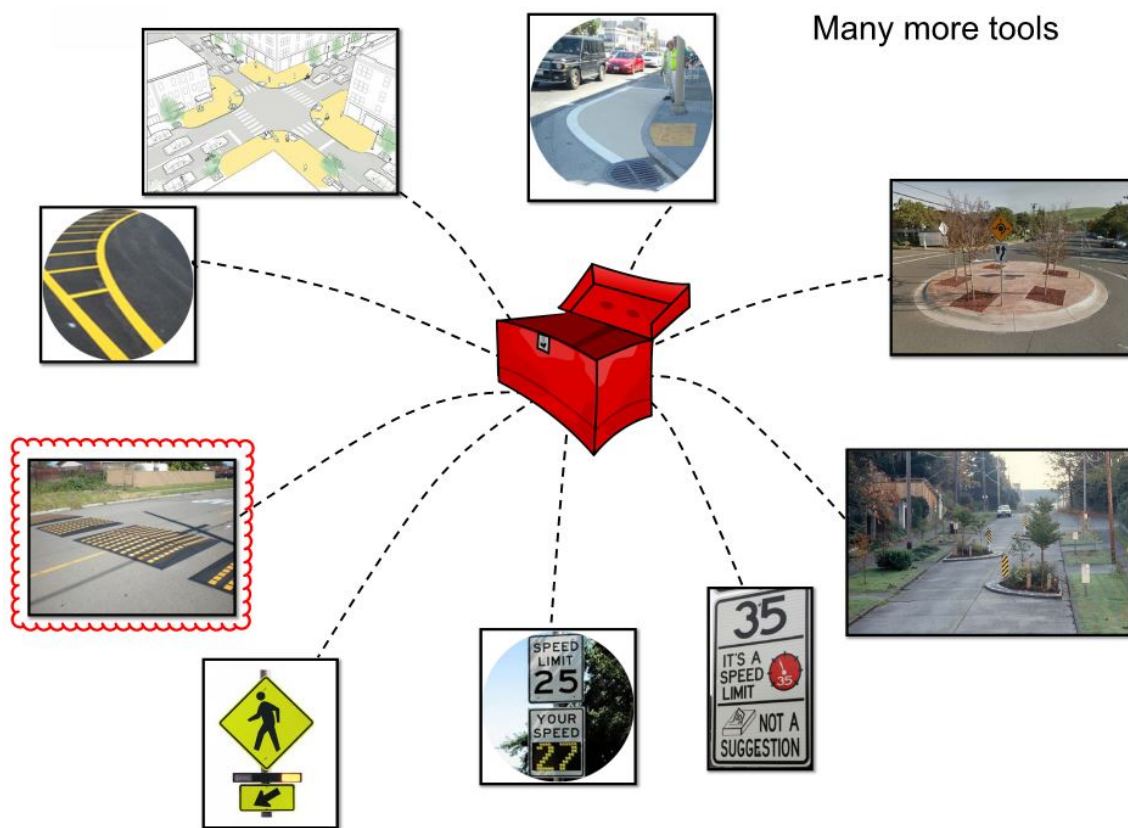
Complete Streets



Bicycle and Pedestrian Master Plan

- ▶ The kick-off meeting for the Citywide Bicycle and Pedestrian Master Plan Update took place in January 2018
- ▶ Existing conditions analysis currently underway
- ▶ Initial outreach efforts have begun
- ▶ CIC Presentation – January 2019
- ▶ Draft Plan completion – July 2019

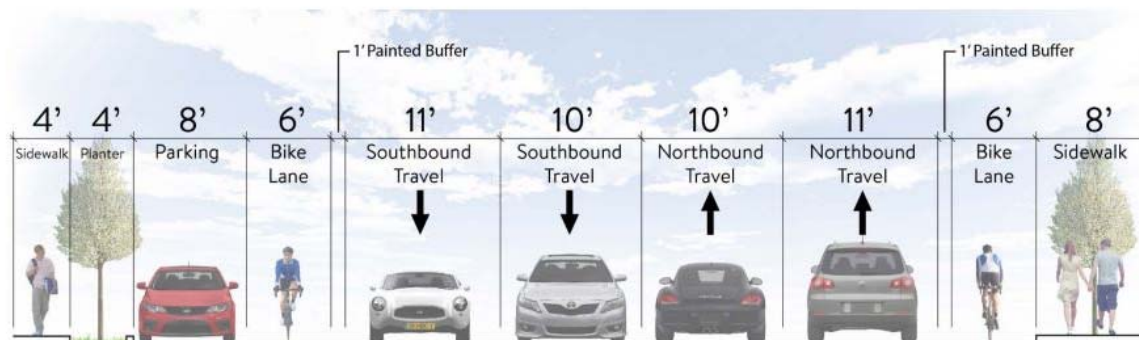
Complete Streets



Neighborhood Traffic Calming Program

- ▶ Staff developed a robust program to address speeding and traffic safety
- ▶ City Council adopted the NTCP – July 3, 2018
- ▶ Website launch and media campaign – November 2018

Complete Streets



Mission Blvd Phase 2 & 3



Phase II

- Start construction – March 2018
- Complete construction–Sept 2019



Phase III

- Conceptual alt. selected by CIC
- Start design – July 2018
- Complete design – April 2019
- Begin construction – Sept 2019

Complete Streets



Complete Streets Project (Main Street)

- ▶ Conceptual plans and street sections have been developed
- ▶ Next Steps: engage residents and business owners
- ▶ Begin Design – Fall 2019
- ▶ Return to CIC – January 2020
- ▶ Begin Construction – Fall 2020

Complete Streets



Hayward Blvd Feasibility Study

- ▶ Develop conceptual design alternatives for Hayward Blvd to address speeding and pedestrian safety
- ▶ Kick-off of Feasibility Study – January 2019

Complete Streets



Citywide Intersection Study (Multi-modal Improvement Plan)

- ▶ Evaluate safety and operational improvements citywide
- ▶ Identify impacted intersections and roadway segments
- ▶ Develop measures to improve multi-modal infrastructure
- ▶ Identify funding mechanism
- ▶ CIC Presentation – October 2018
