WMAC Contractual Annual Rate Adjustments

Initial Year (2015):	9.23% residential increase and 6.15% commercial increase
Years Two & Three:	3% rate increase
Year Four:	5.004% (determined using cost-based analysis)
Years Five - Seven:	Calculation using CPI (min. 3%, max. 6%) 2.611% rate increase in Rate Year 5 3.186% rate increase in Rate Year 6

Rate Adjustment for 2020 – 2021

3.186% Adjustment Includes:

- Change in Consumer Price Index of 3.5%
- Recycling Worker Wage Increase of \$31,000
- Special Rate Adjustment for Residential Recycling (\$2.00 per household)






Recommendation
