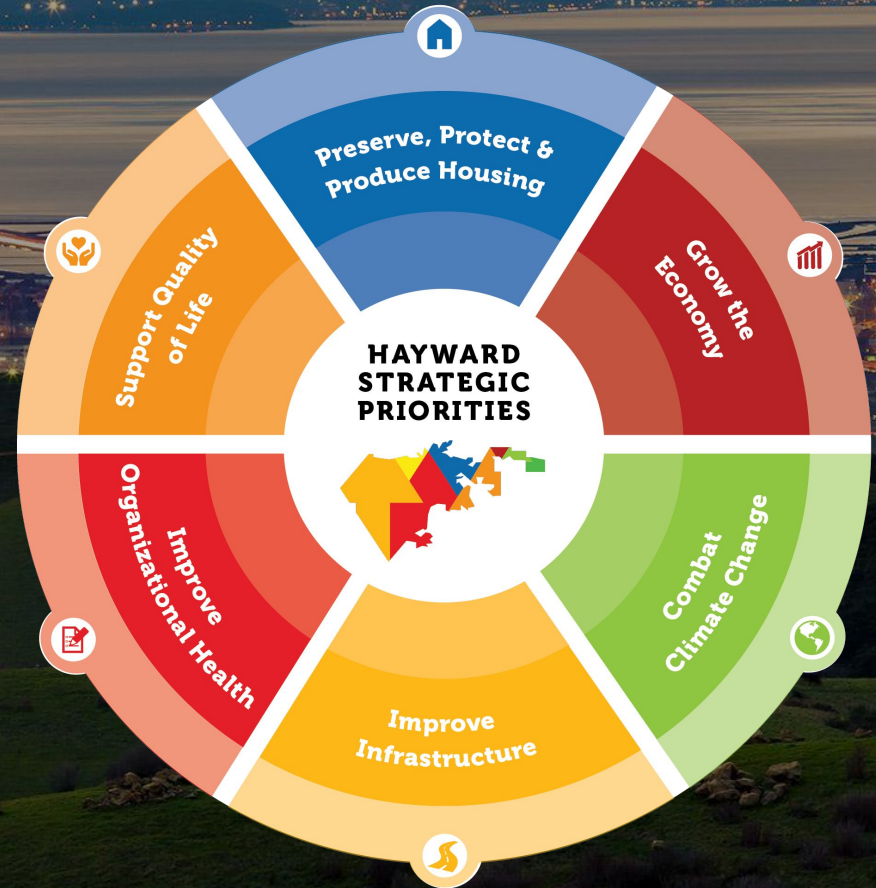

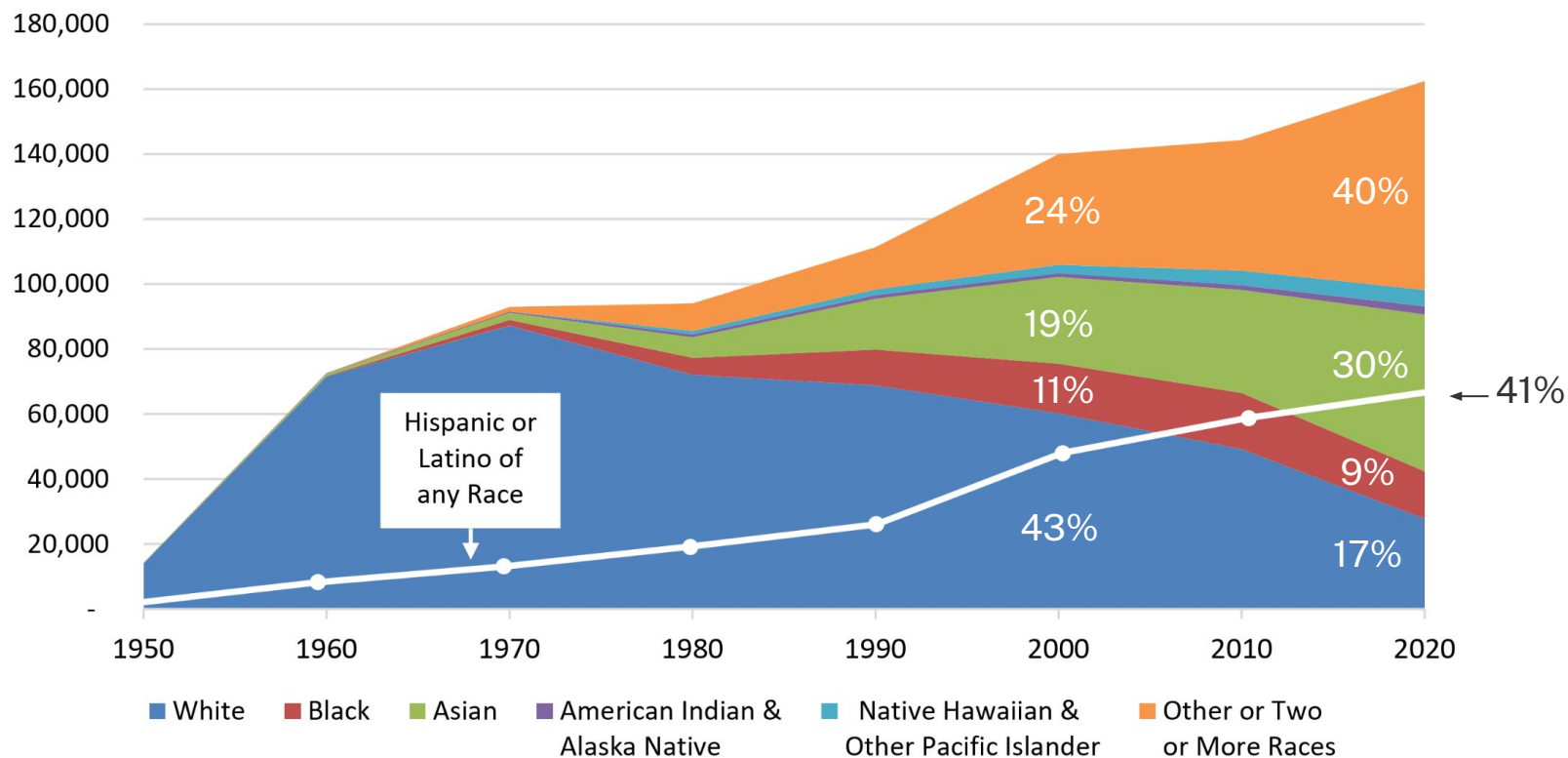

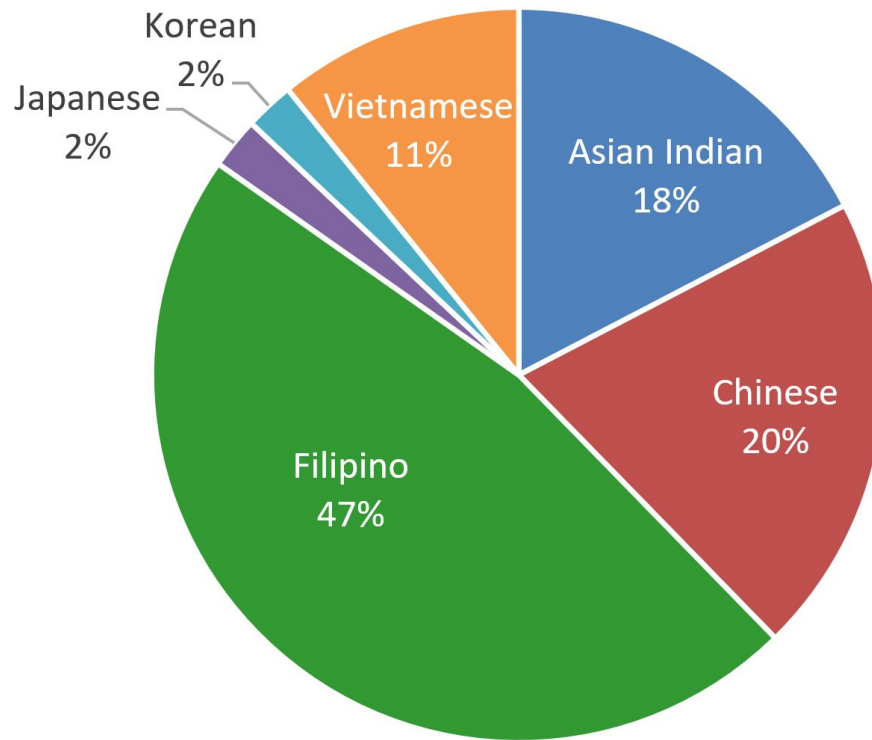
# 2020 Census Data

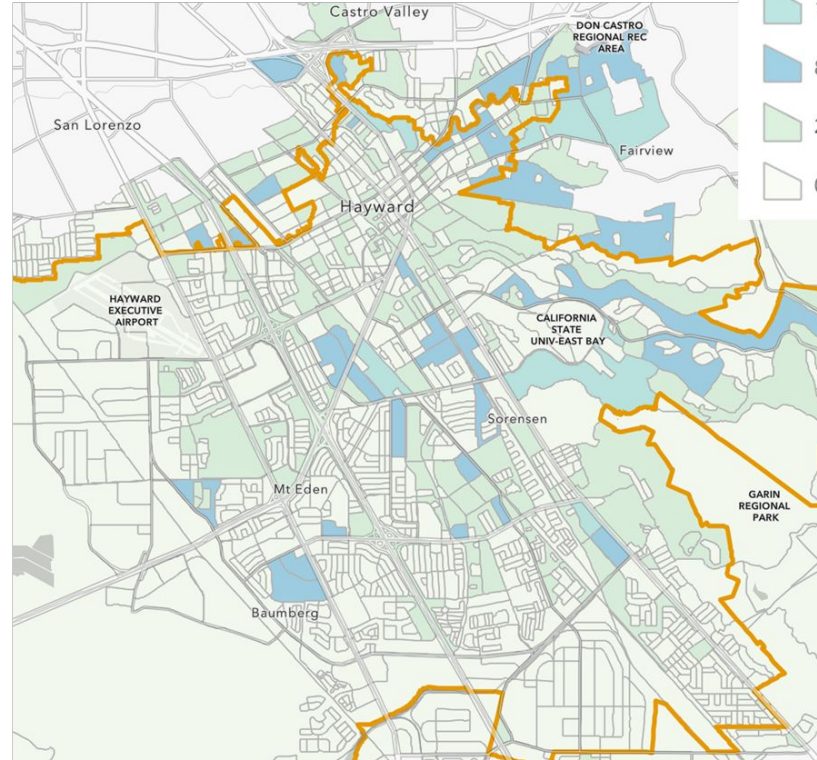
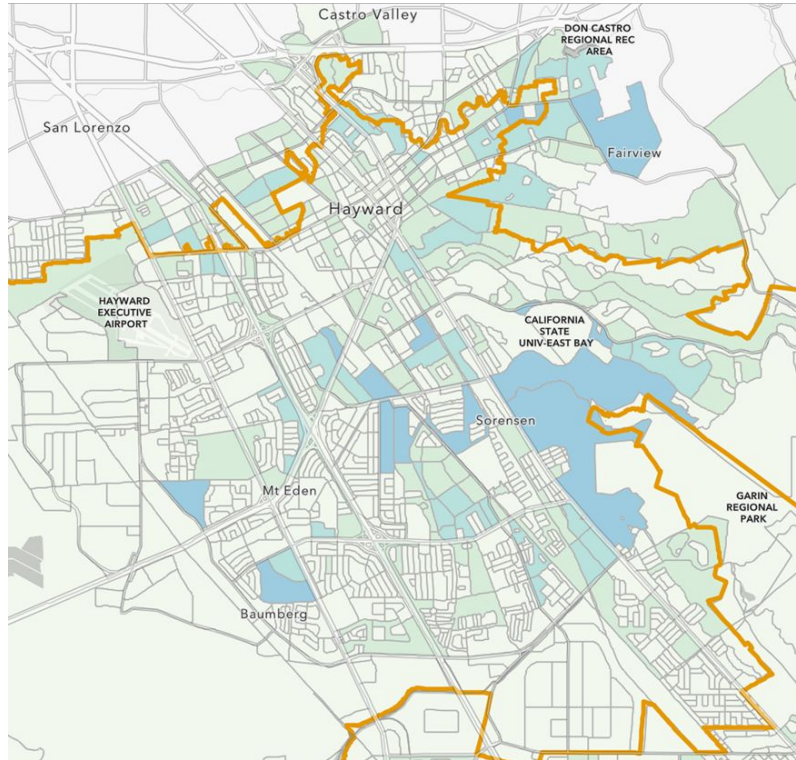

## Total Numbers of Residents Identifying as Black/African American Alone

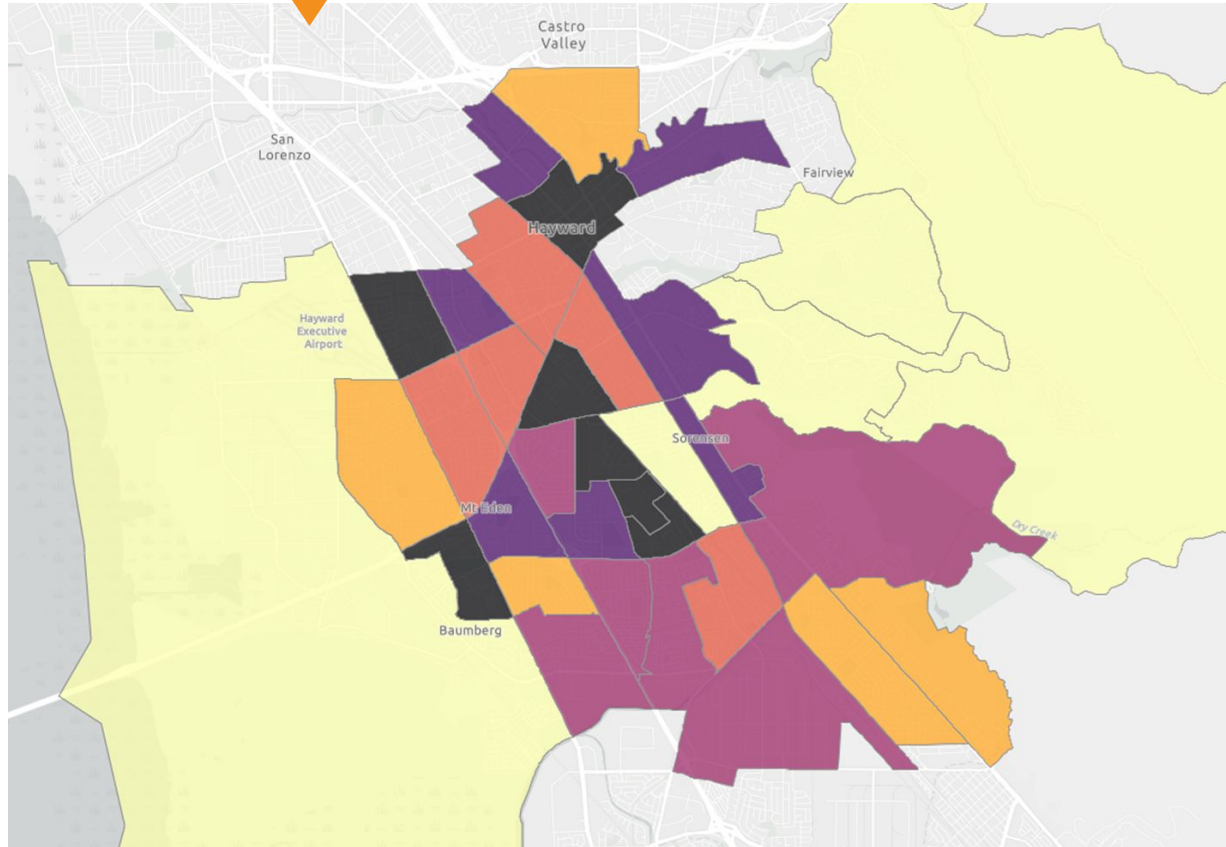

# 2019 American Community Survey Data - Income

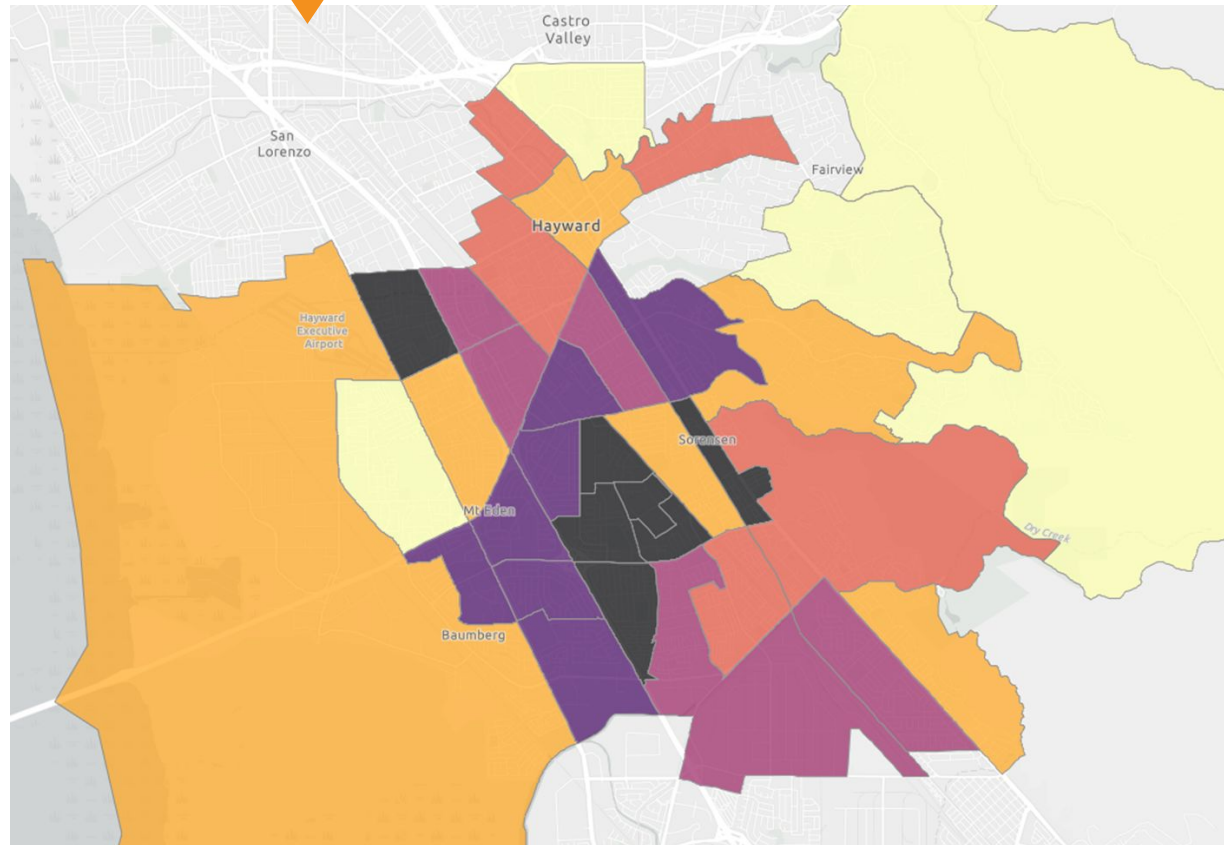


Mean Household

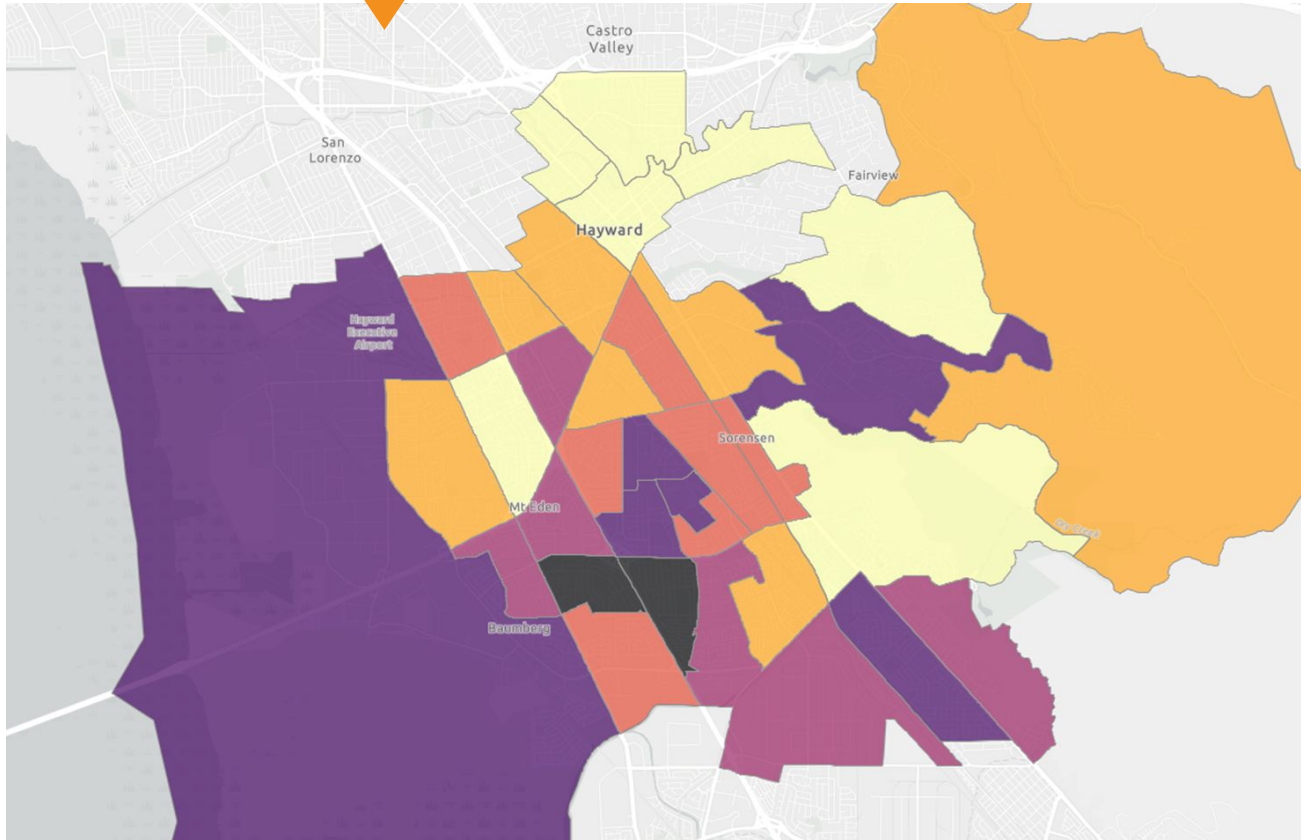


Per Capita Income

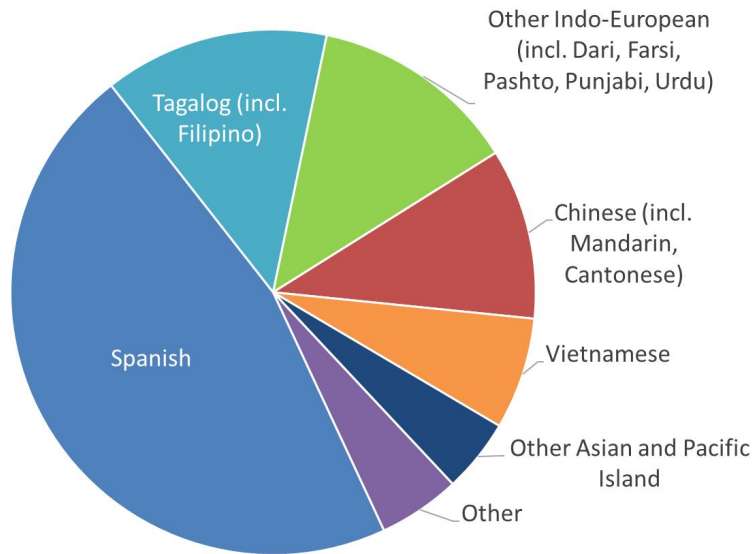

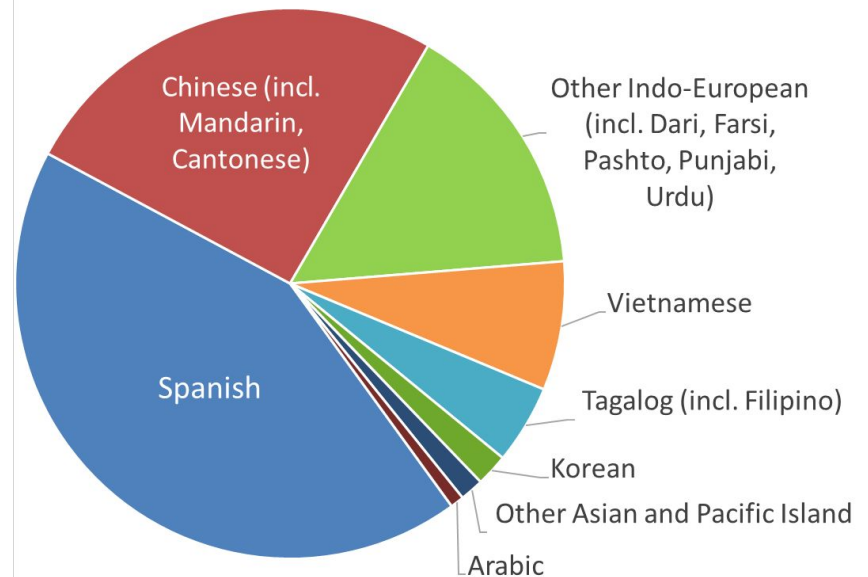


# 2019 American Community Survey Data - Language

# 2020 Census Data

## How is census data useful?

- Helps us track big demographic trends and understand which neighborhoods may have higher needs

## What challenges are there with using this data?

- The racial categories are limited and can be confusing
- Some items, like language, have a fairly large margin of error
- Undercounting challenges

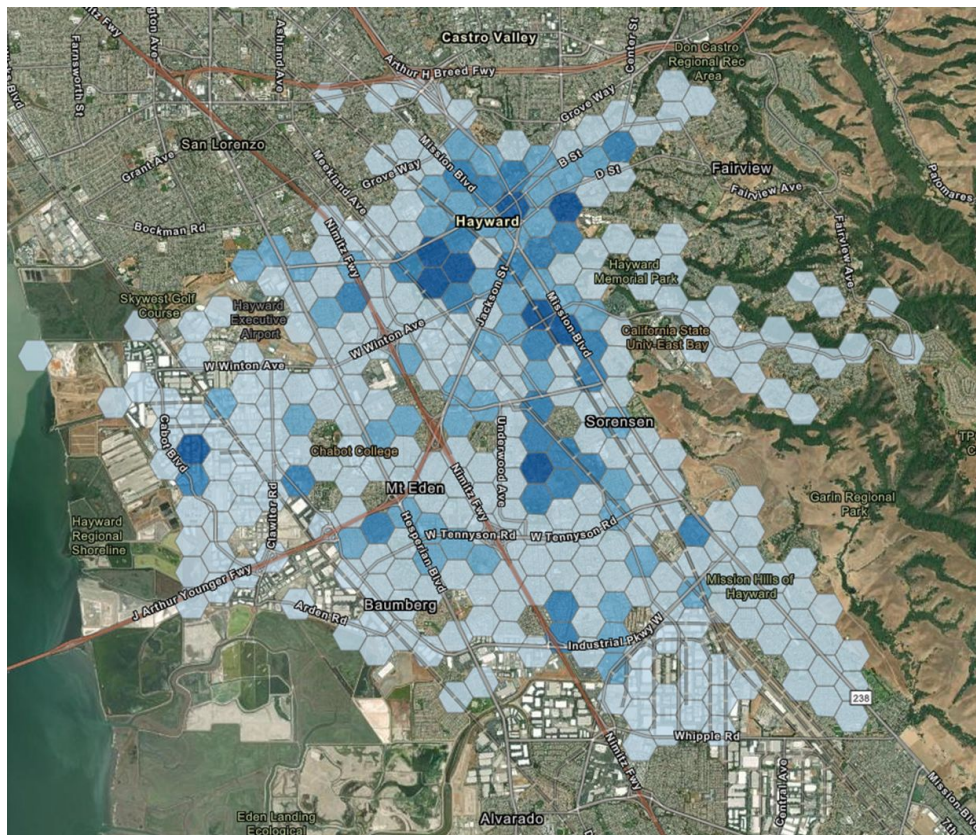


### Who is most impacted?

- Limitation of complaint based data - it doesn't reflect dumping that is not reported



## E-Team DEI Case Study: Illegal Dumping Pilot

### What barriers are there to accessing existing services?



Don't have means to haul to the dump

For renters, difficulty coordinating with property manager

Unaware of free services

**Illegal Dumping Pilots will test two hypothesis:**

Residents will dispose of items correct if -

- An option is available in their immediate neighborhood
- The option is free

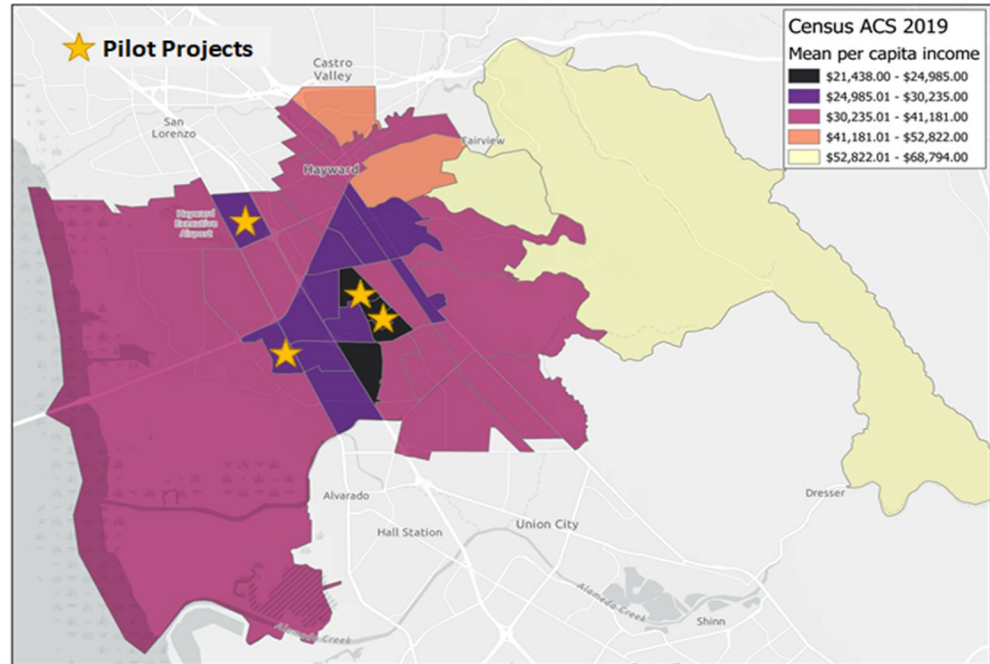

## E-Team DEI Case Study: Illegal Dumping Pilot

### Do you have any learnings to share?

- Doing the pilot will allow us to test success of different models in different neighborhoods
- The four lowest per capita income census tracts are close together and we wanted to have some geographic variation in the pilot, so we chose two that were slightly higher income but we know have high cases of dumping

## E-Team DEI Case Study: Housing Element

### What problem is this trying to address? Who is most impacted?

- The Housing Element is a policy document aimed at providing an analysis of a community's housing needs for all income levels.
- Historically, the City has not heard from all segments of the community when preparing these policy document updates which ultimately affect them.
- Generally the City hears from the same engaged members.

**GOAL:** Have well-attended engaging community conversations about housing, land use, and race, especially with underrepresented communities and/or those who do not typically engage in City processes.

## E-Team DEI Case Study: Housing Element

### What barriers are there to accessing existing services?

Some barriers to engagement include:

- Language
- Digital Divide/Technology Challenges
- Time/Capacity to engage
- Lack of human contact due to COVID

## E-Team DEI Case Study: Housing Element

### What is your approach? How will you know if you are successful?

Some of the strategies include:

- Hayward Housing Stories Social Media Campaign with Chabot (250+ interviews)
- Virtual Community Workshops
- Surveys (available through February)
- Gallery Walks (Library and City Hall)

Success = Strong attendance at workshops and response to surveys as well as more people in community feeling connected to the work we are doing and continue to engage and feel heard

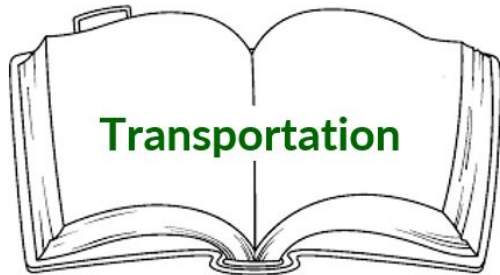
Staff's challenges:

- Lack of initial response from partners
- COVID impacting personal connections with community
- Trust Building



## E-Team DEI Case Study: Bookmobile

What barriers are there to accessing existing services? Who is the most impacted?



Lack of access to transportation keeps many in the community from visiting the library



Residents who cannot afford computing devices and internet service are at a significant disadvantage in a digital world



Language barriers prevent many in the community from accessing library services

## E-Team DEI Case Study: Book Mobile

### What is your approach to addressing these barriers?

- The bookmobile will function as a small branch library
- Initial focus on the communities in South Hayward
- Use the data we have from HPN to determine areas of need
- Partner with other agencies (HPN, HUSD, senior centers, etc.) to offer high quality supplemental educational programs
- Track number of people served, new library cards created, items checked out, and community feedback



# E-Team DEI Case Study: Book Mobile

How will you know if you are successful?

## Usage Data

In the first 6 weeks:

- 447 new library card sign-ups
- 2,617 people served
- 650 items checked out
- 1,690 books given away



## Qualitative Data

- Positive community feedback
- Increasing partnerships
- Requests for new bookmobile stop locations

## E-Team DEI Case Study: Book Mobile

### Do you have any learnings to share?

- Focus on the end user
- Additional funding and staffing are absolutely necessary for the long-term success of equity projects, including the bookmobile
- Interdepartmental support is critical
- Partnering with other agencies
- Be flexible – e.g. Despite our best intentions, COVID continues to impact the services we can provide



# Recommended Approach for Racial Equity Focus Projects

## Questions we ask when we apply a racial equity lens to a service or project:

- What problem is this service/project seeking to address?
- Who benefits from this service/project?
- Who does this service/project not benefit?
- Who is currently accessing this service?
- Who is not accessing this service? Are there barriers?
- How are we communicating about this service/project? What barriers are there for people to find up-to-date information?

## Overall support for the framework & projects; Some questions/suggestions:

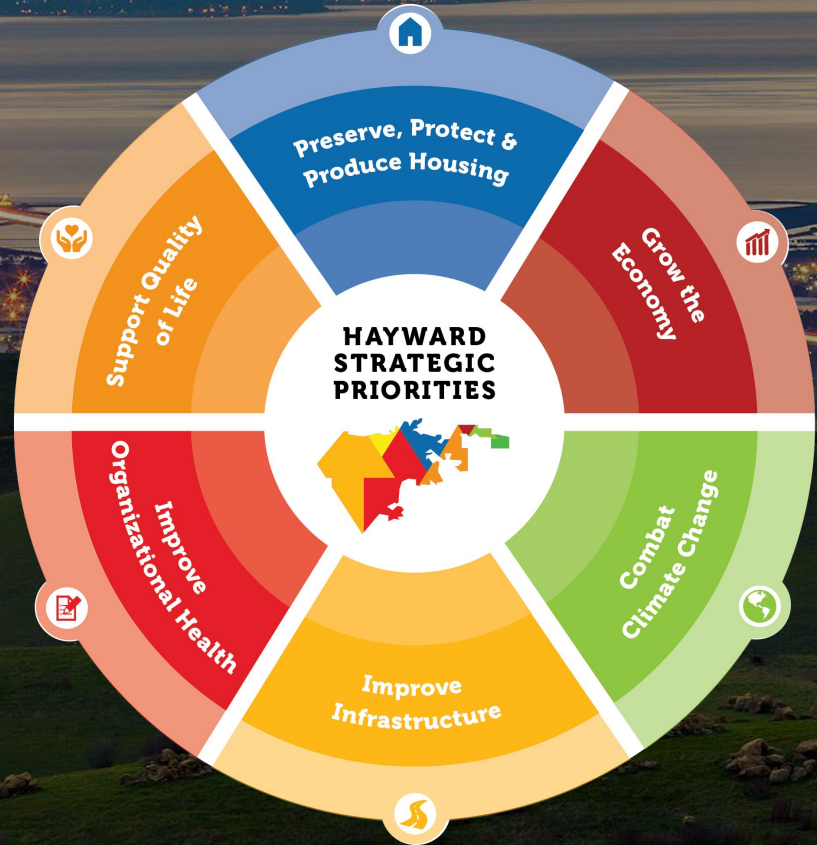
- Very **thoughtful approach** that [...] will lead to useful information [and] facilitate improved service to our residents.

# Quality of Life - Survey Responses

## General Comments/Questions

- The list is expansive and unrealistic
- Focus on: 1) launching the community safety innovation pilot projects, 2) Illegal dumping prevention pilot program, 3) On board GARE staff team
- Move the gun regulation item forward and suggest staff look into available grant funding
- Priorities: Revamping community preservation ordinance, HARD lease negotiation, Heritage Plaza art and Russell City restitution
- Need public art
- Hopefully the implementation of Q26 is folded into existing city beautification efforts
- Could be done a bit on an accelerated path - some items are completed or in progress
- Honor the Californios at Heritage Plaza through El Camino Real Bell

# Housing - Survey Results

## General Comments/Questions

- Priorities: Navigation Center, shallow subsidy program, safe parking site, housing element
- Let's execute these program before adding more
- Look at other uses for potential residential areas for housing
- H11g is part of H2b (and possibly also Q25) and should not be a separate item
- Has the need for pre-approved models for ADU's or a streamlined day for ADU applications been ameliorated with the state changes?
- Is continued work still needed to ensure that addressing homelessness in the city is a collaborative (not internal-working-group-only)?
- The ADU piece is important - We need to protect single family lots that may be abused by predatory purchases

# Climate Crisis - Proposed Changes

## General Comments/Questions

- Look for areas that NEED trees
- More EV charging stations for the community
- Does the environmental justice component of the housing element need to be reflected here (not as additional work, just a capture of work already underway that furthers this goal)?
- As we move to fossil-free power for housing, we likely need to evaluate how we encourage, facilitate, advocate for direct use of onsite power generation, microgrids, power storage, and similar so that we do not add to emergency situations as people lose cooking and hygiene capabilities with power outages
- Should be more aggressive

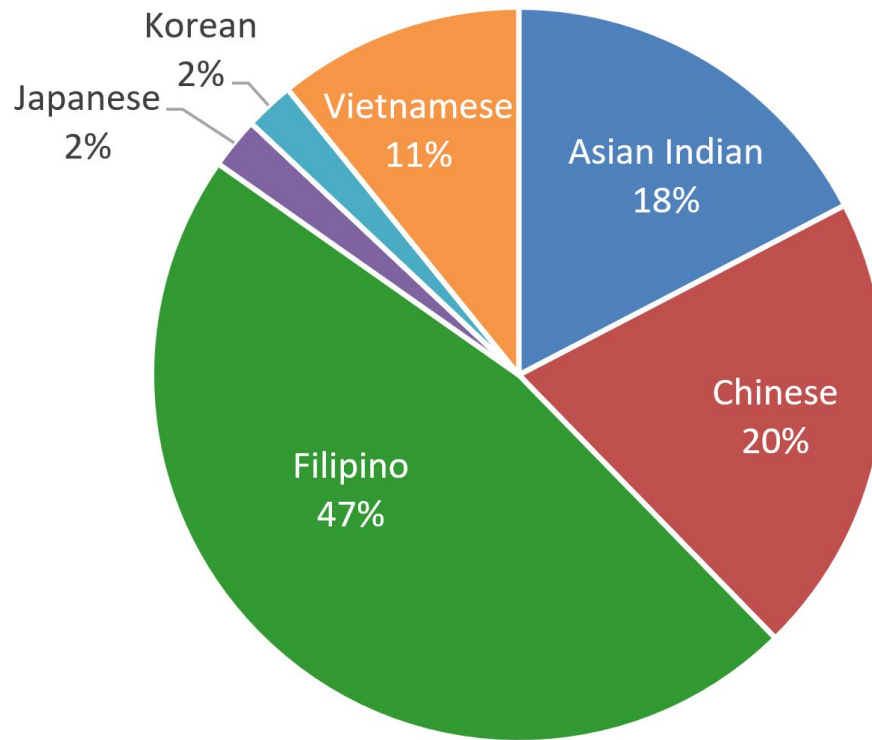
# 2020 Census Data

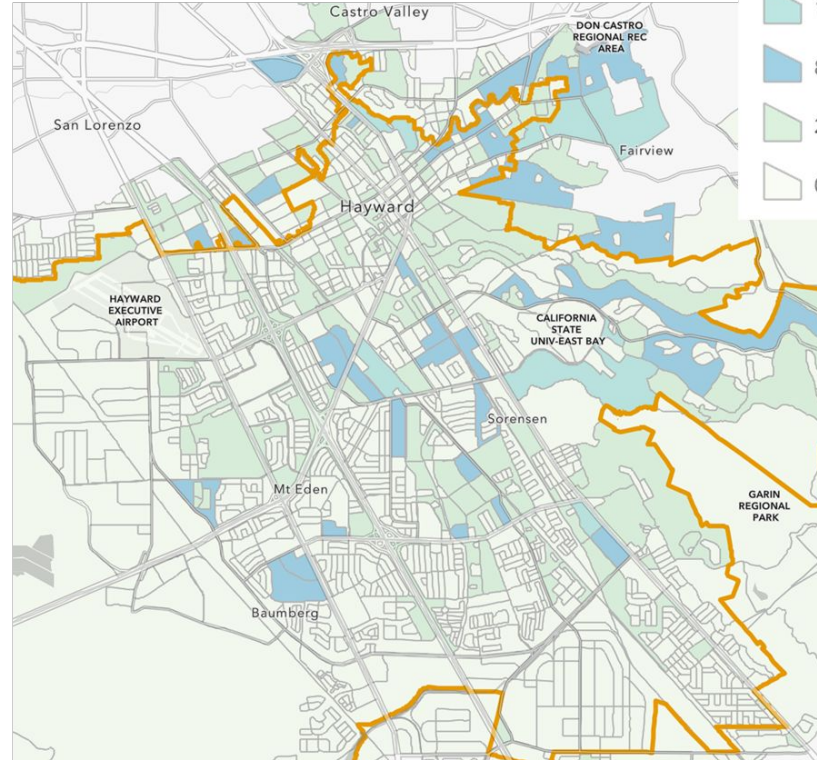
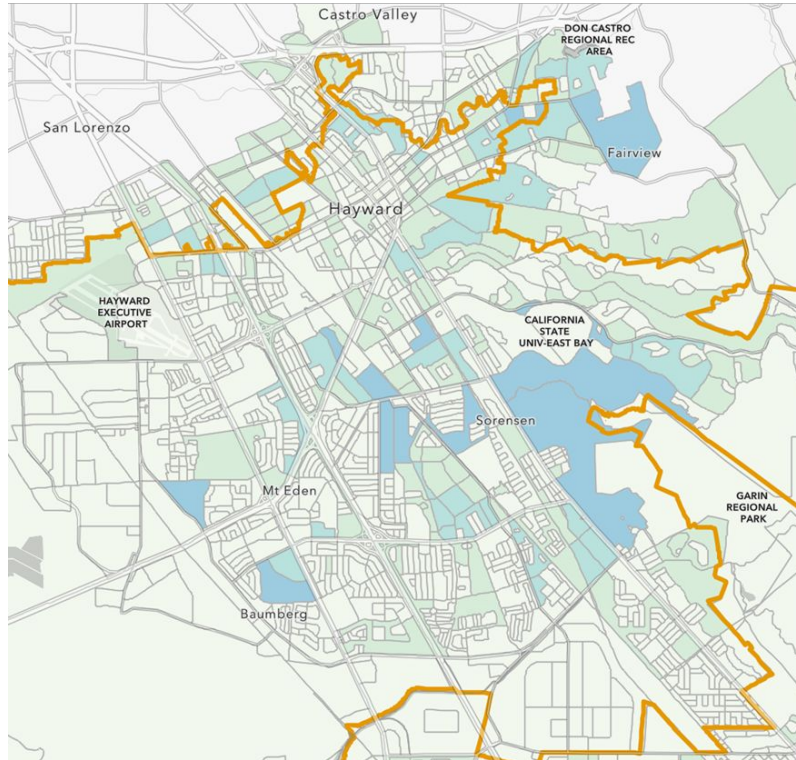

## Total Numbers of Residents Identifying as Black/African American Alone

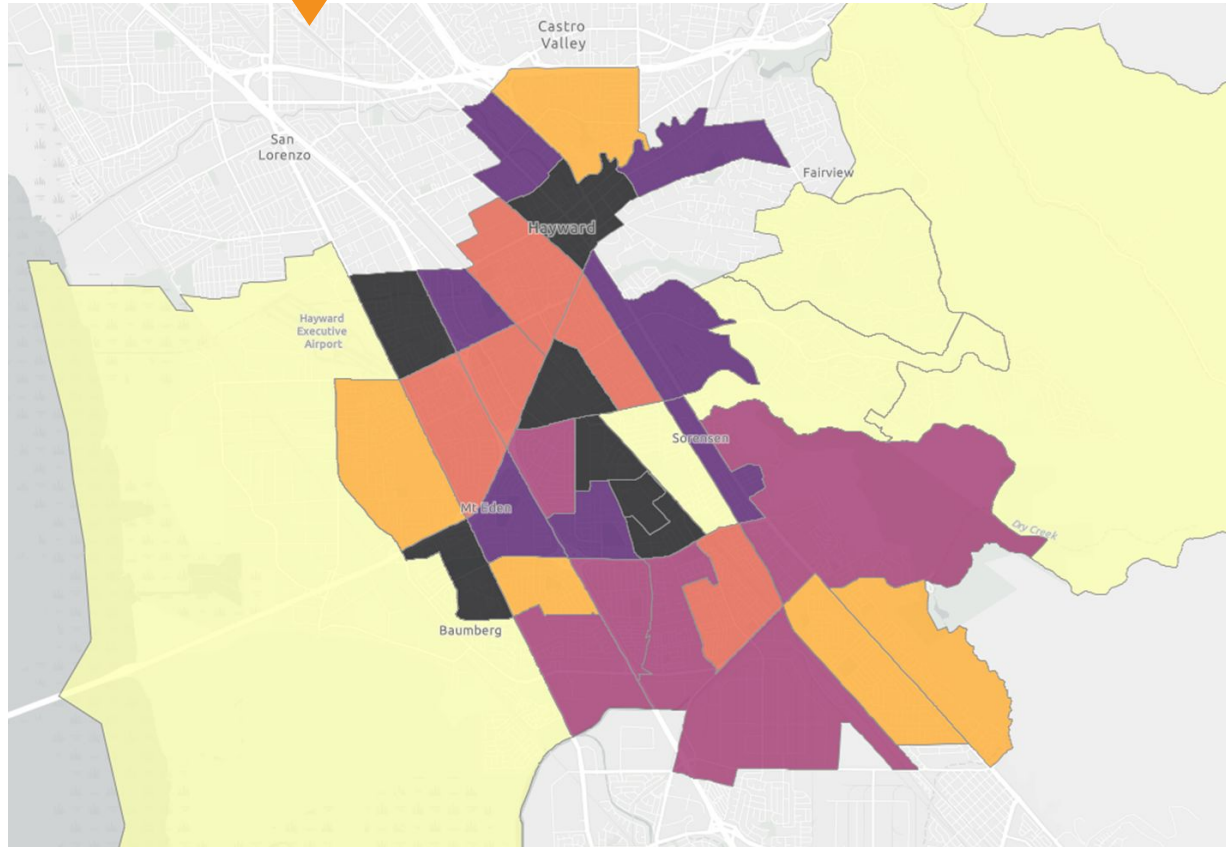

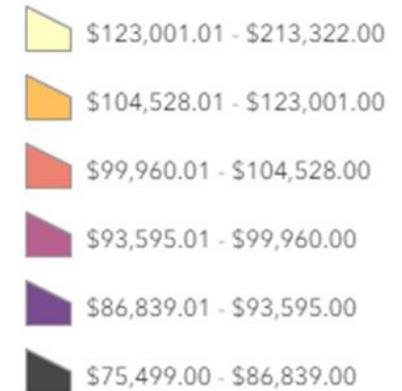

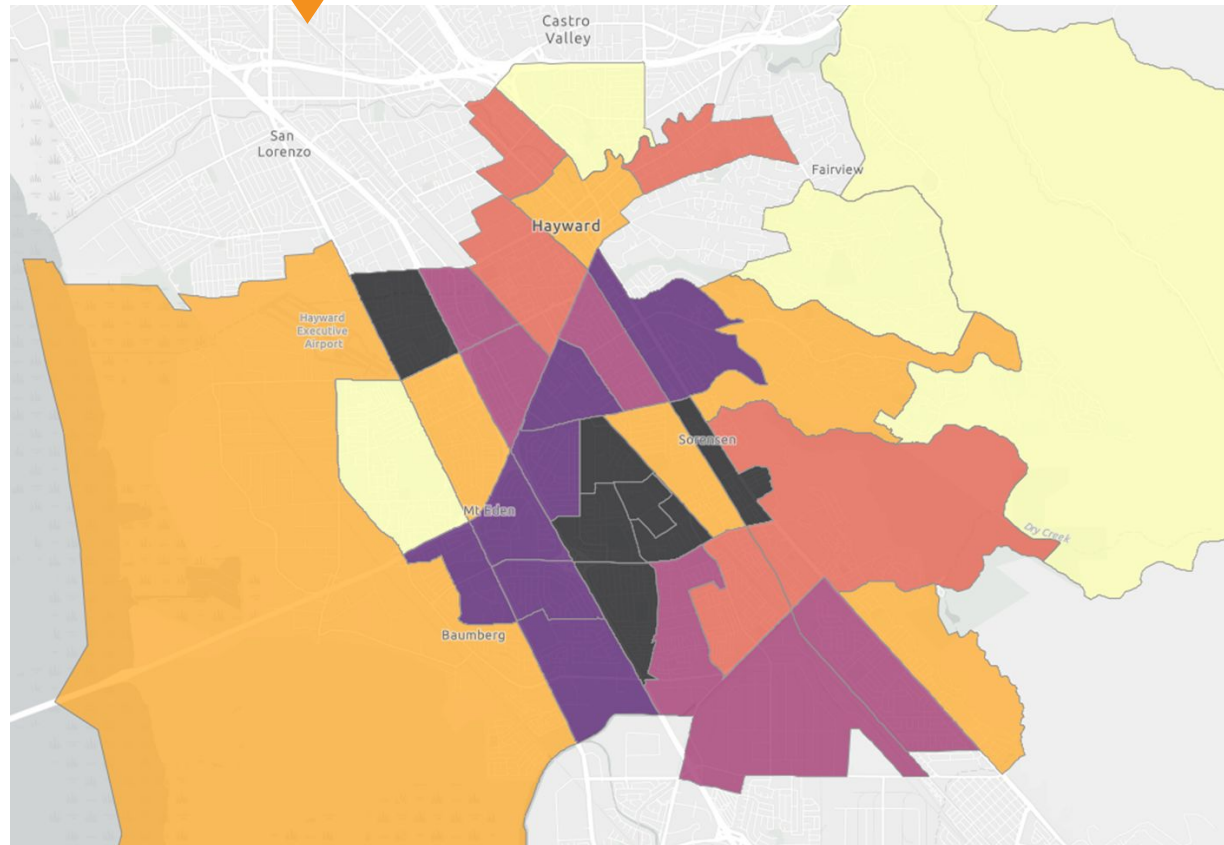
Mean Household

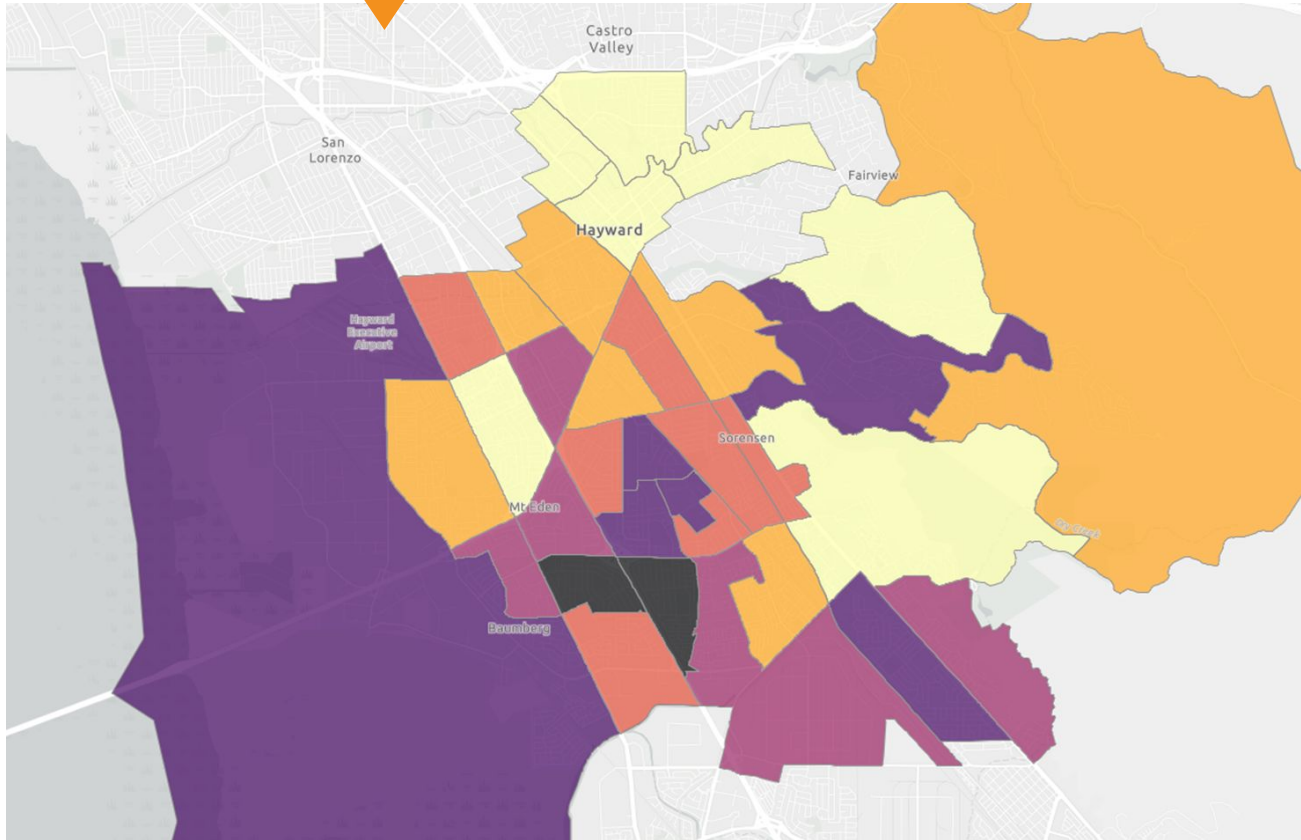


Per Capita Income

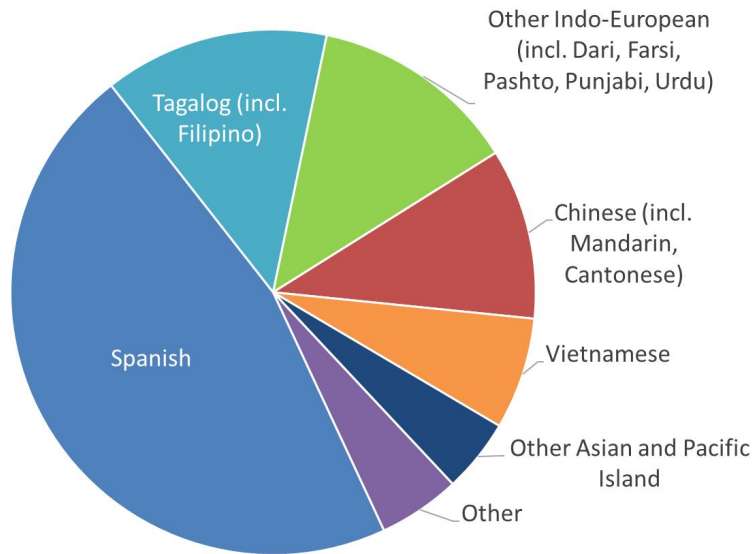

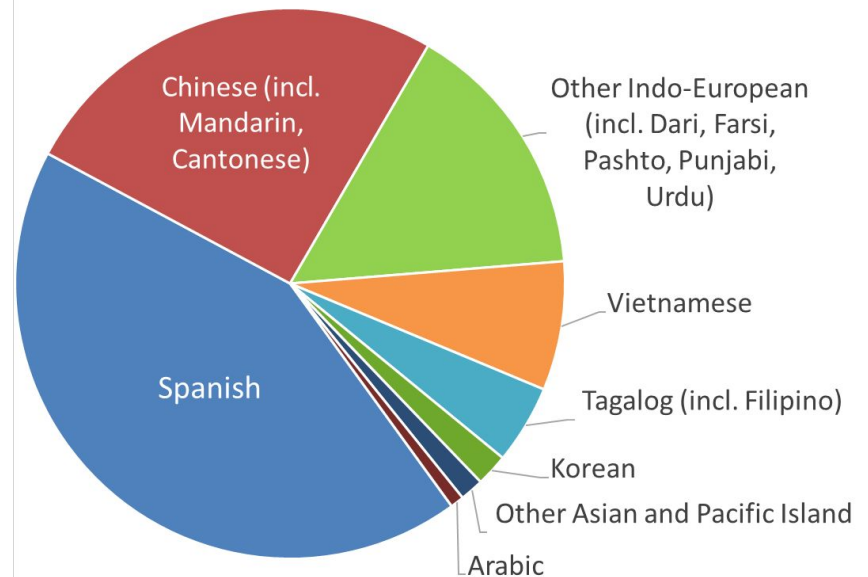

## E-Team DEI Case Study: Illegal Dumping Pilot

### Do you have any learnings to share?

- Doing the pilot will allow us to test success of different models in different neighborhoods
- The four lowest per capita income census tracts are close together and we wanted to have some geographic variation in the pilot, so we chose two that were slightly higher income but we know have high cases of dumping



## E-Team DEI Case Study: Housing Element

### What problem is this trying to address? Who is most impacted?

- The Housing Element is a policy document aimed at providing an analysis of a community's housing needs for all income levels.
- Historically, the City has not heard from all segments of the community when preparing these policy document updates which ultimately affect them.
- Generally the City hears from the same engaged members.

**GOAL:** Have well-attended engaging community conversations about housing, land use, and race, especially with underrepresented communities and/or those who do not typically engage in City processes.

## E-Team DEI Case Study: Housing Element

### What barriers are there to accessing existing services?

Some barriers to engagement include:

- Language
- Digital Divide/Technology Challenges
- Time/Capacity to engage
- Lack of human contact due to COVID

## E-Team DEI Case Study: Housing Element

### What is your approach? How will you know if you are successful?

Some of the strategies include:

- Hayward Housing Stories Social Media Campaign with Chabot (250+ interviews)
- Virtual Community Workshops
- Surveys (available through February)
- Gallery Walks (Library and City Hall)

Success = Strong attendance at workshops and response to surveys as well as more people in community feeling connected to the work we are doing and continue to engage and feel heard

## E-Team DEI Case Study: Housing Element

### Do you have any learnings to share?

Staff's challenges:

- Lack of initial response from partners
- COVID impacting personal connections with community
- Trust Building

## E-Team DEI Case Study: Bookmobile

What barriers are there to accessing existing services? Who is the most impacted?



Lack of access to transportation keeps many in the community from visiting the library



Residents who cannot afford computing devices and internet service are at a significant disadvantage in a digital world



Language barriers prevent many in the community from accessing library services

## E-Team DEI Case Study: Bookmobile

### What is your approach to addressing these barriers?

- The bookmobile will function as a small branch library
- Initial focus on the communities in South Hayward
- Use the data we have from HPN to determine areas of need
- Partner with other agencies (HPN, HUSD, senior centers, etc.) to offer high quality supplemental educational programs
- Track number of people served, new library cards created, items checked out, and community feedback



# E-Team DEI Case Study: Book Mobile

How will you know if you are successful?

## Usage Data

In the first 6 weeks:

- 447 new library card sign-ups
- 2,617 people served
- 650 items checked out
- 1,690 books given away



## Qualitative Data

- Positive community feedback
- Increasing partnerships
- Requests for new bookmobile stop locations

## E-Team DEI Case Study: Bookmobile

### Do you have any learnings to share?

- Focus on the end user
- Additional funding and staffing are absolutely necessary for the long-term success of equity projects, including the bookmobile
- Interdepartmental support is critical
- Partnering with other agencies
- Be flexible – e.g. Despite our best intentions, COVID continues to impact the services we can provide

## Questions we ask when we apply a racial equity lens to a service or project:

- What problem is this service/project seeking to address?
- Who benefits from this service/project?
- Who does this service/project not benefit?
- Who is currently accessing this service?
- Who is not accessing this service? Are there barriers?
- How are we communicating about this service/project? What barriers are there for people to find up-to-date information?
