Can you please define what the 2-1-1 services are?	2-1-1 is a free, non-emergency, confidential, 3-digit phone number and service that provides easy access to housing information, and critical health and human services. 2-1-1 operates 24 hours a day, 7 days a week with multilingual capabilities.
	211 Alameda County is the one stop for 24/7 access to housing, healthcare, disaster relief, and more. This free, three-digit telephone number connects callers in Alameda County with a live Community Resource Specialist who introduces them to resources and advocates who can help with a variety of needs including affordable housing, job training, childcare, legal assistance, health services, emergency shelter, education, food, and other basic needs assistance. Help is available in over 300 languages and all calls are completely confidential.
	As the only countywide comprehensive information and referral provider in Alameda County, 211 is relied upon by human service providers, local government and people in need as (1) a professional and compassionate partner in the delivery of human services; (2) the clearinghouse for accurate community information; (3) a key component of the disaster response network in Alameda County; (4) a reliable source for data on service needs and delivery systems; and (5) a culturally and linguistically diverse organization prepared to serve Alameda County's individuals and families.
	211 provides a critical information and referral bridge between Hayward individuals/families in need and human service agencies, including hundreds of governmental and community-based organizations.

How is trash being collected once it's filtered?	Trash collected in the full trash capture devices will be removed via a vacuum system or manual removal by opening each device. Each device is designed a little differently, but in general a grate is removed, and the device can be accessed and cleaned once opened. Collecting and disposing of trash in privately owned full trash capture devices will be the responsibility of each property owner. City staff will ensure all devices are maintained through an "Operation and Maintenance" agreement completed between each property owner and the City. The agreement assigns specific obligations to maintain the device and service them or "clean" them at a frequency to ensure they continue to filter trash from stormwater.
