Re: Poetry in the Park (Heritage Plaza)

Dear Mayor Halliday and Members of the City Council,

Hayward, it could be argued, is in the midst of an artistic renaissance. We've all seen the Fabulous murals and those colorful and unique electrical boxes. Even the library book drops are amazing...artistic and attractive. The Hayward Arts Council, Art Inc., and the Sun Gallery all keep visual art alive by maintaining several galleries throughout the area, including art installations in places of business such as the Chamber of Commerce and the Alameda County Law Library. Thus, the visual arts are alive and well in our community, but we are lacking in verbal art...in other words, poetry.

With the advent of the computer and social media, the written word has become truncated to the point of full messages in 140 characters, including symbols! The majesty of the written word, with its beauty of phrasing, its complexity of nuance, its specificity of meaning, its dexterity of usage, is not valued today as it was in the past. No one knows this better than those of us who serve on the Literacy Plus Council of Hayward because it is our goal to help break the cycle of intergenerational illiteracy in the Hayward community by supporting the Literacy Plus Program for adults and children. We believe that with each word that is written and spoken in the program, the tutors are endeavoring to forge brighter futures and promote better understanding throughout our community.

Poetry is one of the highest forms of the written and oral word. It speaks to people in very personal ways. In recent years, poetry has begun to be featured through various venues. Hayward has had two very successful poetry SLAMS, held on the lawn of the library through the energetic efforts of librarian Sally Thomas, the Friends of the Library have held wonderful poetry contests and awarded meritorious scholarships, colleges in the area have put on workshops to encourage young people to raise their voices in poetry, and Leticia Garcia Bradford has founded a local poetry group called the B Street Writers. Additionally, Hayward has taken a step toward emphasizing verbal literacy by naming Bruce Roberts as its first Poet Laureate.

The Literacy Plus Council of Hayward, in its role of promoting literacy education, both written and verbal, would like to see poetry showcased in the Heritage Plaza of the new 21<sup>st</sup> century library park. This can be done in a number of ways, including the use of raised stands with poetry plaques or poetry stenciled into the concrete pathways throughout the park. Either way, the intention is to take the walkers' eyes off the concrete under their feet and have them focus instead on meaningful poetry offerings. These offerings may spur conversation between those enjoying the walk or they may even spark children, walking with their parents, to read aloud. Both of these activities reinforce communication and literacy learning.

To give the Poetry in the Park Project an even wider community appeal, a contest could be conducted whereby aspiring Hayward poets, from eight to eighty, could submit their offerings with the winners having their poetry displayed prominently in the Heritage Plaza.

It is the belief of those of us on the Literacy Plus Council of Hayward that each of you take pride in our city, that each of you want to continue the artistic renaissance that you have begun through the commissioning of the magnificent murals and the artistic electrical boxes, and that each of you endeavor to promote education and literacy within your community. It is to this end that we, the members of the Literacy Plus Council of Hayward, request that you consider including Poetry in the Park in the Heritage Plaza. We believe that it will promote learning, it will enhance the beauty of the pathways and it will engender meaningful conversation.
