Why aren't the rental units included in this provision? Are they not part of the HOA? Can they be added? That was certainly the intent of the motion, if possible.	The rental units are not part of the HOA. The HOA only covers the for sale properties. The motion was specifically related to the HOA paying a specific amount of transit passes and that is reflected in the condition. If the Council wants the rental units added, then they would need the applicant to agree for the property management company (a subsidiary of William Lyon or future owner of project) to agree to provide those passes annually to all households in the multi-family rental component.
	If Council wants to modify the language in the Condition, staff has prepared a memo and amended Resolution to do so.

### RECOMMENDATION

Based on a Council question, staff has prepared a revised a condition of approval and amendments to the resolution if the Council wishes to modify this as it relates to the second reading of the Ordinance and accompanying Resolution of approval for the Sohay development project.

As drafted, Condition No. 58k refers to the "for sale" units while the intent of the Councilmember who made the motion was to provide \$400 Clipper Cards to all households within the development, including the multifamily rental units. To ensure that all households benefit from the ongoing transit subsidy, staff recommends that Condition 58k be modified as follows (new text is <u>underlined</u>):

The Homeowner's Association shall provide a \$400 Clipper Card annually to each for sale household <u>and the property owner of the multi-family rental development shall</u> <u>provide a \$400 Clipper Card annually to each multifamily rental household</u>, unless the <u>applicable</u> household declines the benefit in writing.

If the Council accepts this modification, it will be reflected in the Resolution accompanying the Ordinance.



# Clean air right use for VW cash

The Wolf administration has developed a sound program for using the state's share of the national settlement with Volkswagen for its pervasive cheating on diesel emission standards.

Federal regulators discovered several years ago that certain VW small-car diesel engines were programmed to perform differently during emissions testing than they did under actual driving conditions. The emissions those engines produced in testing were far lower than what they produced on the road.

VW acknowledged the cheating and agreed to a \$14.7 billion national settlement, \$2.7 billion of which was distributed to state governments.

Last week, Gov. Tom Wolf announced that Pennsylvania's \$118 million piece of the settlement would help produce cleaner air. The Driving PA Forward program's goal is to reduce nitrogen oxide emissions from diesel engines by 27,200 tons by speeding up the replacement of older diesel engines.

Competitive grants will be available for emission reduction projects, and dedicated grants will be available for electric and hydrogen vehicles, replacement of old and dirty heavy-duty trucks and buses, systems enabling ships in port in Philadelphia and Erie to use onshore electrical systems rather than diesel generators, replacement of diesel-powered industrial equipment such as forklifts with electric models, and to diminish the use of an array of other diesel-powered vehicles at airports and ports, and on rail lines and depots.

In some cases, the grants will support the use of newer, cleaner diesel technology. In other instances, grants will fund conversions from diesel to other forms of power that produce fewer emissions.

But in all cases, the projects will go to producing cleaner air, which is a perfect use of the money derived from VW producing dirty air.






