Dear Mayor and City Council,

It has been brought to my attention that this evening's closed session will include a discussion on negotiations of Caltrans Parcel 8.

I want to make clear my personal support for the tenants of Parcel 8. Their efforts for agency and control of the land and homes they occupy is not wholly apart from The Hayward Collective's anti-displacement efforts.

The Hayward Collective made it very clear how we felt about the evictions and displacement of the Parcel 5 tenants. By the time we understood what was happening on Parcel 5; it was too late.

But it is not too late for the Parcel 8 tenants. And it is not too late for the City of Hayward to affirm that community-controlled land has a distinct and important role in stabilizing vulnerable communities.

I know your goal is to maximize the sales of these parcels so that the City of Hayward gets money. I know the red in the City of Hayward's financial forecasts has only recently diminished. But it is not ok to prop yourselves up on the backs of vulnerable community members.

I hope you continue to collaborate and work with the Parcel 8 tenants and that the negotiations on the table tonight do not threaten what they are trying to achieve.

Item #6: Professional Services Agreement with St. Francis Electric, Inc.: Approval of Amendment No. 2 to Increase the Agreement by \$200,000 for a Total Not-to-Exceed Amount of \$475,000

In reviewing the agenda item regarding the contract to address streetlights, a couple questions came to mind.

- 1. How many streetlights are damaged each year?
- 2. Are there any visible trends to this issue (ex: specific intersections that need frequent repairs, times of day/week/year that have higher incidents)?

- 1. Staff approximates about 3-5 traffic cabinets hit per year, 12-20 street lights per year, and 16 signal poles per year.
- 2. Staff sees no trends based on time of day or year, but a trend regarding high speed corridors and corners.

Some of the light poles are decorative ones installed at Mission project and are several times more expensive than the non-decorative ones.

Schools without working fire alarms after Sandy

But for thousands, their schools will be missing something: working fire alarms!

Parents alarmed this could happen, reached out the 7 on your side for answers.

Would you send your kid to school with no working fire alarms? As the school year begins, that's the question scores of parents at four of New York public schools are asking themselves.

"We need safety in our kids' school," said Lina Elshawari, a parent.

Brought to tears out of fear her three kids could die in a fire while at school, Lina Elshawari says New York City should be ashamed it's allowing students inside a school with no working fire alarms.

"There's nothing for a teacher on the wall to pull that's what it comes down to," said Steven Jasiak, a P.S. 207 parent.

P.S. 207, the Howard Beach elementary school where their kids go, hasn't had functional fire alarms since October 29th.

The system, housed in the school basement along with the boiler, was destroyed during Superstorm Sandy and it's still not fixed in time for this school year.

Children are our future, so when it comes to their safety, parents, guardians, and adults have a duty to protect them. However, there are times when parents cannot be there to protect their children, such as when they are in school. Once children are on school property, their safety and well-being become the responsibility of the school personnel and administrators.

In reality, the safety and well-being of the children occurs long before they even step foot on a school campus. The preliminary stage for safety in schools starts when architectural plans are developed for the school and its buildings. These plans are reviewed by the state, county, or city building officials to ensure the buildings are being built per applicable code requirements.







Authorities having jurisdiction (AHJ), code officials, field inspectors, and school districts have the responsibility to ensure each building is built and maintained properly. Although construction of buildings is an important safety factor, building systems—such as security systems, fire sprinkler, and fire alarm systems—are equally important when it comes to protecting children and adults. Without a fire alarm system, most schools cannot be opened or occupied.

This article provides information to fire alarm designers, code officials, and school personnel about the basic requirements for school fire alarm systems, as well as the various design approaches for complying with the applicable codes and meeting the different fire safety needs of schools.

What the codes say

The International Building Code (IBC) and International Fire Code (IFC) provide minimum requirements for fire alarm systems, which consist of manual fire alarm boxes throughout the school. California adopts even more stringent codes, such as automatic detection throughout the buildings,







New bill could legalize liquid cremation in Texas

(KLTV) - The end is inevitable for all of us. When a loved on dies, families must decide whether to bury or cremate their remains. A Texas lawmaker wants to add a third, relatively new option to the list which would use liquid to dissolve the body.

"We are open to all options. We want to be able to help and assist a family do whatever they chose to do," said Rosewood Premier Funeral Home Marketing and Public Relations Director Savoy Fambles.

And a new option, one that leaves less of a carbon footprint could be coming to Texas. It's called alkaline hydrolysis or liquid cremation.

"It is really the same process as regular cremation, it just uses a water process as opposed to fire," Fambles said.

A hyperbaric chamber is used to steam off all soft tissue and organs, leaving bone fragments behind in a flour like white powder.

"And the bone fragments is still going to be returned to family members as ashes," Fambles added.
