Council Infrastructure Committee Members:

As a member of HAYWARD CONCERNED CITIZENS, I am writing in regards to agenda item ACT 21-100 being discussed this evening. I'm pleased to see the commitment, continued efforts, and follow-through from our police and city staff to develop an acceptable operations policy for the City Council-approved Unmanned Aerial Systems Program.

It is clear from reviewing the meeting documents that there is still voiced concern about privacy issues, but I strongly feel the benefits of having this surveillance technology far outweighs the risk of a privacy breach. I also feel confident that our city staff and HPD have done their due diligence to assure there will be full transparency and accountability in use of the drones, and that any potential policy violations will be fully investigated and addressed.

Nearly every other local city in the Bay Area has immediate access to drones and has successfully deployed them for search and rescue, critical incidents, in-progress burglaries, accident reconstruction, and for the purposes of de-escalation with positive outcomes. Workplaces, media, and civilians ALL freely use types of surveillance technology for various purposes in our city. The city of Hayward already has its own drone for mapping purposes. To my knowledge to date, there have been no voiced privacy concerns about that use of surveillance. Additionally, it is understood that our police cannot (and will not) just arbitrarily deploy drones in our city. HPD also routinely uses body cams. Drones are just another form of that same technology, offering a different perspective as well as keeping our officers and residents safe in potentially volatile situations.

As an advocate committed to ensuring our police have access to all of the necessary resources to keep our community safe, I respectfully encourage your recommendation to council that the latest UAS Operations Policy Manual be approved.
