Happy Juneteenth and thank you for your voice of support, Angela!

I am praying that Council *directs* Alex and Kelly (at a bare minimum), to create *safety* zones for residents whose driveways are on Campus Drive; where now we are *forced* to back into or try to race against 2 lanes of speeding traffic to get into our driveways.

This can be fairly simply achieved by designating the 2nd lane going the same direction (directly in front of our homes) as Resident Access only - with a streetside separation wall along this short strip - accompanied with interior lane multiple speed humps to discourage cut thrus; post the speed limit along this strip to 15 mph and provide Resident/Guest Parking Permits to provide much needed, but not currently available, parking for our families, guests and service providers - who currently block the bike lanes as needed - forcing bikers into the speeding traffic at these locations.

Please note that if the City wanted to create COMPLETE streets, a simple modification of this strategy could be used for *all* the homes whose driveways are on Campus Drive.

This solidly PROVEN, cost effective strategy on residential arterials, such as Campus Drive, is a Win-Win on so many levels:

• transforms the added 2nd lane into a safety *solution;* rather than its current status as a safety *hazard* for residents, pedestrians, bikers and drivers, by *forcing* drivers to slow down and simultaneously providing safe access to our homes

• fulfills Strategic Roadmap goals by enabling residents, bikers and pedestrians to *use* Campus Drive for alternate modes of non-car mobility, due to the new safety features from this modification

• physically prevents speeding at locations where instituted; keeping *all* who use the road safer at those locations

• reduces unacceptable levels of traffic noise at the modified locations where a separation wall is installed to a suitable height to block traffic noise in front of the homes with addresses posted on the streetside for quick identification

• increases property values, rather than decreasing the desirability of the neighborhood due to accidents, speeding, high noise levels and the proliferation of ineffective installations that do not resolve hazardous conditions, nor speeding

• if correctly and thoughtfully designed and landscaped, this modification can beautify Campus Drive as the main entryway into the CSUEB Campus; which in turn, can *elevate* the overall stature of Hayward by providing a safe, green, and multimodal route to this revered and iconic Hayward Landmark

• improve the health, safety and wellbeing of ALL who use Campus Drive, if the 2nd uphill lane is *totally* adapted to be used exclusively by residents, cyclists and pedestrians as a physically PROTECTED lane (via a non-accessible wall barrier to prevent collision and bombardment by speeding cars) and the overall speed limit on Campus Drive be posted at 20 mph, at least in front of the homes, as recommended by Slow Streets and Vision Zero on this currently dangerous, windy residential arterial road.

Thank you so much for your consideration of the safety for all who use and who will use, Campus Drive. I hope you all enjoy your weekend - I am signing off to enjoy mine!

Thank you, Francisco.

To your point, that is why residents want the 3rd lane reallocated to a residential entry lane only to have safe access to their homes and prevent the aggressive and hazardous 3 lane configuration of 2 lanes going in the same direction, as now exists on Campus Drive.

As a 2 lane street, in lieu of a 3 lane street; *without* 2 lanes going in the same direction, drivers will no longer have the *choice* to use it as a speedway.

If that is coupled with returning the speed limit to 25 mph or even 20 mph, along with physical protective barriers to ensure the safety of residents, their guests, bikers, pedestrians and service vehicles - this issue, which we have been reporting to Council for 7 years, can be resolved.

Painted lines, unmonitored signs or warning installations, such as flexible posts, have been installed, against residents advisories, and remain ineffective in slowing speeding drivers.

Not sure if you had the chance to read the articles I have sent, but this 'road diet' has been well supported as a *proven* way to stop speeding on residential arterials such as Campus Drive.

It is supported by Vision Zero, SFMTA, AARP, ITE and has been utilized nationally, as well as locally; in Oakland, Berkeley, Fremont, San Leandro, San Francisco, Union City and hopefully, Hayward; to stop hazardous speeding by implementing *physical* barriers to make it an impossibility.

If you reallocate the EXISTING 3rd lane to be a 'safe harbor', as we have requested, for bikers, residents, pedestrians and drivers who are affiliated with the residents, the problem is largely solved and Campus drive will be restored to a multimodal option for *all* users - not just cut thru cars.

This is also economically a viable option, because the 3rd lane already exists and is paved. The only new item is a wall to divert residents safely into their homes, as well as the other users (bikers, pedestrians, residents' guests and requested service vehicles) to their destinations.

I hope Council understands this.

Please reach out to me for clarification, if needed, as I have a very large body of data that supports this reuse of the existing lanes on Campus Drive to protect the lives and well being of *all* who use Campus Drive.

Thanks, Francisco for your reply.

But, in particular, the 5 households that have driveways across from the University Ct. cul-de-sac on the most dangerous curve of Campus Drive (this is where most of the accidents have happened); which we showed you, the other Council members, Kelly, Jennifer Ott and Alex Ameri last year; have *terrifying and unsafe experiences multiple times a day trying to get in and out of our driveways*, backing into 2 lanes of speeding traffic that threaten to hit us by racing right up to our car - which could cause a multi car accident if others in back are following too close, on their phones or don't recognize our car is stopped while trying to get into or out of our driveways.

The Hidden Driveway signs the City installed years ago have had no effect.

Since the City already added the 2nd lane and it is already paved and striped, the very simple solution is, as we presented to Council and City Staff previously, is to add a protective retainer wall, starting at the 1st driveway at the white pillar and ending at the 5th driveway - which is a fair distance before Highland Ave.

This would totally prevent the harrowing experiences we, and our circle of people, face multiple times a day.

It is a common solution seen in many cities, including Hayward in other locations; and if speed bumps/humps are installed before and after each driveway - along with restricted access signs at both ends of the restricted lane, 15 mph speed posted, with penalty warnings; cut-throughs will not benefit non-residents.

And, as was done across the street on University Ct., parked cars not displaying a Resident or Guest parking permit, could. be ticketed or face towing for violations.

This very common solution does not prevent, nor negatively affect, Emergency Vehicle access, but does prevent a tragic disaster, that is 'an accident waiting to happen', if nothing continues to be done.

I will again text the example photo to Angela, Alex and Kelly (due to my email storage limitation) as one of the many ways this simple solution can be implemented and our safety assured; as we, our family members, friends and service providers access our homes on a daily basis.

We beseech you to *please* have this very serious discussion and reach a resolution; allowing us to be protected from the trauma and hazardous conditions we face *daily*, trying to get in and out of our driveways; where the speed has been increased by the City and another lane added on this most dangerous curve of Campus Drive - right in front of our homes.

Our neighborhood definitely needs the City Council to direct the City of Hayward to cease spending more budgetary dollars on painting more lines on the street, putting up more signs and other 'reminder' installations that are just additional 'eye litter' on the street, have no imbedded enforcement component and are discretionary; in terms of compliance by the drivers.

These solutions of installing physical impediments to speeding, far outweigh the cost-benefit ratio and effective use of resources over the repetition of installing more, or similar measures of the same elk as has been repeated in the past on Campus Drive, and, that do not FINALLY solve the very solvable and most dangerous, problem of speeding in our neighborhood.

Greetings Mayor Halliday et. al:

The City of Oakland is very aggressively addressing the resolution of speeding and injury/property damage by taking multiple proactive steps that have been proven to be effective and fueled by Resident input.

As the long time residents and taxpayers of the University Campus Neighborhood Association (UCNA) have been advising your governance since 2016 of the chronic and ongoing problems surrounding unmitigated speeding, property damage, accidents and injury on Campus Drive, it is imperative that the City of Hayward make it an inmediate prerogative to install **physical impediments** that **prevent** this hazardous, predictable behavior from continuing.

In a few short weeks, a bombardment of new travellers will be unleashed on Campus Drive from the **478 new family rental residences** of Lincoln Landing.

To rely on optional and non-predictive measures of traffic mitigation, such as sporadic enforcement by an overstressed police force, painted lines on the street, flexible plastic posts, unmonitored speed readout signs and a proliferation of other signs; along with the 'sure to exacerbate the issue measures' of increasing the speed limits and adding lanes going in the same direction, are installations that have not worked in the past and most certainly, will not work moving forward, and are in direct opposition to protocols that would keep Hayward residents safe on Campus Drive.

Especially, as the City marches ahead with adding more and more housing units in and around our neighborhood.

This is not fair; it is not responsible to ANY Hayward residents and it endangers *everyone* who uses Campus Drive.

Add if you will, housing - but simultaneously, add the **required infrastructure** of PROVEN PHYSICAL IMPEDIMENTS THAT ABSOLUTELY <u>PREVENT</u> SPEEDING on Campus Drive.

And if you cannot do that - quit heaping more and more people on our street.

Thank you for your consciousness and concern for the well-being of Hayward Residents; who have chosen and want to remain safe in Hayward, as our Home.

For item 6 on Tuesday's agenda, there is reference in the staff report to the need to approve an addendum to the specifications. I'm not seeing that language in the resolution. Did I miss it?	An addendum to Item No. 6 was prepared and is being routed to Council with a revised resolution adding approval of Addendum No. 1 and additional funds to the Project.

For item 9 - Landscape and Lighting Districts, is it possible to smooth the increase for SoHay residents by only charging the expected costs for the year (ex: based on expected expenses of \$95,000)?	Staff has reviewed the proposed budget for Landscaping and Lighting District Zone 18 (SoHay) and has agreed to reduce the assessment from \$400 to \$300 for FY 2023. Council approval of the Resolution for the LLD on tonight's agenda, only approves the Preliminary Engineer's Report and does not finalize the rates in the Engineer's Report. Staff will make these changes to the Final Engineer's Report that will be brought back to Council for approval at the July 5 th Council meeting.
Is there any logic to adding murals to any of the walls / graffiti abatement areas of the various LLD's?	Many of our LLD areas have walls that are covered by plant material such as ivy that serve as living graffiti-deterrents. Generally, walls within and surrounding our LLD's aren't frequent targets of graffiti due to their location, as such, line-item budgets for graffiti abatement are typically low, usually around \$1k annually. Staff will evaluate areas that might be good opportunities for murals and solicit feedback from the respective district stakeholders for future consideration.

All law enforcement firearms, regardless of caliber, distance capability, or design, fall under our Use of Force policy, which defines deadly force and outlines the circumstances under which it can be used by an HPD officer.
Is there regulation or manufacturing standards in the creation of chemical agents?	The chemical process for the creation of chemical agents does not change, however the amount used is specific to the individual munition. The companies that manufacture munitions (primarily Defense Technologies and CTS) adhere to company specifications that ensure product reliability and manufacturing consistency. Manufacturing processes are regulated by OSHA.
To confirm, is the recommendation that if/when the Council adopts the policy, it be with an amended inventory list that does not include stingerballs?	Yes, if Council adopts the policy, the munitions highlighted in the staff report will be removed from the inventory list and physically destroyed.
While the legislation does not include sidearms, could they be added to future inventory lists and included for future review/discussions?	The intent behind AB 481 was to enhance transparency regarding equipment items, deemed to be "military equipment", and are outside of those normally possessed by law enforcement agencies. Sidearms are standard issued equipment for police departments.
Is there an update about when Council will discuss gun control issues?	A follow up work session on the gun control issues/Council referral is scheduled for Fall 2022.
Am I understanding correctly that the armored personnel carrier has been used 200+ times? Is that all in Hayward?	The deployment of the armored personnel carrier is not currently tracked, however the HPD is committed to doing so moving forward to comply with AB 481. The numbers provided in the staff report are estimates and, in the interest of being transparent, we felt it prudent to estimate on the high end. These deployments include all SRU activations, high-risk/critical incidents, transportation of equipment, and outside agency requests for assistance or the armored personnel carrier itself.

BE IT FURTHER RESOLVED NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that GSW Construction, Inc., is hereby awarded the contract for the Trash Capture Device Installation on Cotter Way, Project No. 07675, for \$188,600 with a 10% contingency budget of \$18,900, for a total amount not-to-exceed \$207,500, in accordance with the plans and specifications adopted therefore and on file in the office of the City Clerk of the City of Hayward, at and for the price named and stated in the final proposal of the hereinabove specified bidder, and all other bids are hereby rejected. That is simply adding fire to the flames that need to be extinguished. There has been no clear evidence that being heavily armed with military-grade equipment reduces crime nor helps the community. Who are the police going to war with? The city? Criminals?

A police officer's job is multifaceted. Law enforcement (including investigation of complaints, arrest and prosecution of suspects, and efforts at crime prevention) accounts for only about 10% of police activity. Maintaining order (intervening in family and neighborhood disputes, keeping traffic moving, responding to disturbances of the peace) accounts for about 30% of police activity.

As it has been stated HPD does not need these kinds of equipment. Instead, the funds should be redirected back into our community. Providing social programs, where funds will address social issues, like poverty, homelessness, and mental disorders.

These individuals are not criminals. Instead of placing more money in heavy arms that don't resolve anything, we should invest in our city of Hayward and really protect the community officers are sworn to also protect.
