MEETING

A regular meeting of the Hayward Planning Commission was called to order at 7:00 p.m. by Chair Goldstein.

PUBLIC COMMENT:

PUBLIC HEARINGS: For agenda item No. 1, the decision of the Planning Commission is final unless appealed. The appeal period is 10 days from the date of the decision. If appealed, a public hearing will be scheduled before the City Council for final decision.

1. Proposed Establishment of a Cocktail Bar and Lounge with Cabaret Entertainment Located at 990 B Street, Assessor Parcel No. 428-0056-057-00. VGJB, Inc. (Applicant); Corinne and Tinoleon Zaracotas (Property Owners), Requiring Approval of Conditional Use Permit Application No. 201802339

Assistant City Attorney Brick stated that as an action item, if any motion made does not achieve four votes, the item will be brought back at the next Planning Commission meeting.

Assistant Planner Martinez provided a synopsis of the staff report and a PowerPoint presentation.

Mr. Baltazar, Applicant, spoke about their vision for the proposed project for a high-end lounge and they want to help make Hayward a destination spot.

Mr. Vic Gill, applicant, spoke about the proposed project and their business plan.

In response to Commissioner Willis question regarding the applicant's experience with this type of business and what security measures are in place, Mr. Baltazar said he has approximately 20 years' experience, the general manager has operated a similar business for 16 years and security measures will be in place to ensure a safe environment for both staff and patrons and to minimize negative incidents.

Mr. James Vierra, Security expert with the project, spoke about the security measures that will be in place and staff will be trained to handle different situations to protect patrons and the business.

In response to Commissioner McDermott's questions of applicants experience with this type of challenging business, what security measures are in place and who is the target audience, Mr. Baltazar said the general manager has the experience with starting up a lounge and Mr. Gill relayed his experience as an investor in a hotel bar and restaurant. Mr. Baltazar said he is an entrepreneur and has opened multiple businesses and that security measures will be in place both inside and outside of the establishment to ensure this is a safe place for patrons. Mr. Baltazar said the target market will be young professionals age 25-40, expected revenue rate of 50K-100K, this will be an upscale lounge and the bulk of the business with be on weekends beginning Friday night through Sunday night. Mr. Vierra said in order to look out for patron's safety, proactive security measures will be conducted prior to entering the establishment that includes searching of purses, pat downs and utilize search devices which run along the body.

In response to Commissioner Willis' inquiry of what measures are in place to prevent over drinking by patrons who will be driving. Mr. Baltazar described the steps staff would take if they perceive patrons are over their alcohol intake limit such as stop serving the patron alcohol, provide the patron with water and snacks and if necessary call for an alternate form of transportation to get the patron home.

Mr. Baltazar responded to Commissioner McDermott that there will be light snacks such as nuts, chips and patrons can bring food into the lounge. Ms. McDermott mentioned that the Card Palace has excellent security. Mr. Gill mentioned that they plan to have food trucks on the weekends.

Chair Goldstein noted the applicant has coordinated with the Hayward Police Department (HPD) regarding their security permits.

Chair Goldstein opened and closed the public hearing at 7:36 p.m.

In response to Commissioner Schott's request for feedback from HPD and what is the anticipated additional calls for service, Detective Wright said the proposed lounge is in a high reporting area and it is important to have a strong security plan in place and to have security personnel at the establishment especially prior to patrons entering the establishment. Detective Wright said there were problems with Club Me when the restaurant would transition to a club in the evening and she noted Club Me was a lot larger establishment. Detective Wright said the proposed establishment holds a maximum of 85 people.

Commissioner Willis Jr. made a motion to approve the staff's recommendation. Commissioner McDermott seconded the motion.

Commissioner McDermott hopes that the applicant is successful and that the proposed establishment will be what it is expected to be.

Mr. Gill said they intend for their establishment to be a high-end lounge and that the kind of patrons an establishment attracts depends on the kind of atmosphere is created from the music that is played. Mr. Gill said that they are fully invested in the proposed lounge.

Commissioner Willis said he made the motion because he believes the applicants have the experience necessary to be successful.

Commissioner Schott said he supports the item, said the applicant has a good plan and the City will not get better unless the Commission takes a chance and moves forward with projects such as this one and wishes the applicants the best. Mr. Schott said there are many developments going up in the City and residents will need a place to go to.

Chair Goldstein said the applicant's presentation, vision and business plan are compelling. Mr. Goldstein said there are 4400 new residential units going up in the City and the proposed upscale lounge will benefit from the increase in residents. Mr. Goldstein said he appreciates the applicants have solid security measures in place which is positive for both the business and the patrons.
