PUBLIC COMMENTS

Mr. Jim Drake, Hayward resident, spoke about the eucalyptus trees that were removed from Jackson Street; and congratulated the re-elected members of the Council.

Mr. Monzella Curtis, Hayward resident, thanked the City Council for the moratorium on the decontrol of rental units and continued conversations; and congratulated the re-elected members of the Council.

Ms. Claire Cardinaux, Chabot College student, urged the City Council to consider increasing the funding for the Hayward Animal Shelter or advocating for more animal adoption.

Mr. Emilio Rojas, Hayward resident, noted the pavement section in front of his residence was painted red which reduced parking space and caused him parking citations. Mayor Halliday referred him to City staff.

Ms. Wynn Grcich, Hayward resident, spoke about atrazine herbicides and liquified remains in the water supply. Council Member Mendall clarified there was no recycled water in the water supply and the City was implementing recycling water for watering lawns.

CITY MANAGER'S COMMENTS

City Manager McAdoo announced City Hall would be closed from December 24, 2018 through Friday, January 4, 2019, and would reopen Monday, January 7, 2019.

COUNCIL REPORTS, REFERRALS, AND FUTURE AGENDA ITEMS

Council Member Márquez reminded the public about the City's contract with Alameda County Waste Management, which entitles residents to two free bulky pick-ups per calendar year

and encouraged everyone to take advantage of the service. Council Member Márquez congratulated SantaCon coordinators for organizing the 7th Annual SantaCon event on December 1, 2018, which helped pay for over 300 adoptions at the Hayward Animal Shelter.

Council Member Mendall asked the Council to task the City Manager with bringing to Council by January 15, 2019, a proposal for Council's consideration to issue a second round of cannabis RFPs, excluding retail and focusing on R&D and manufacturing cannabis businesses with the goal of issuing the RFP by the end of January 2019. There were at least four Council Members in support of the request.

Council Member Zermeño noted the Keep Hayward Clean and Green Task Force would take a break in December and encouraged the public to report liter related complaints via Access Hayward to ensure the city remains clean during the holidays.

Mayor Halliday thanked City staff for decorating City Hall and organizing the 2018 Downtown's Hayward Light Up the Season event on December 1, 2018. Mayor Halliday also shared she participated in the Ballet Petit's 40th Annual Nutcracker on December 2, 2018, at Chabot College.

Mayor Halliday announced the Council would hold a special meeting on December 11, 2018, for the swearing-in of re-elected and elected members of the City Council.

Mayor/Chair Halliday adjourned the meeting at 7:35 p.m., in memory of George H.W. Bush, 41st President of the United States.
