#### Discussion:

##### *2020 Commissioner Elections*

##### *FY 2020 Community Agency Performance Report*

Ms. Cole-Bloom provided and discussed a presentation on a summarization of the Commission's recommendation of both Community Development Block Grants (CDBG) and General Funds to the Hayward City Council for Fiscal Year 2019 – 2020.

##### *Community Development Block Grant COVID-19 Emergency-Related Funding*

Ms. Cole-Bloom provided presentation to review and discuss staff recommendations for allocating funding from the CARES Act, Round 3, that was awarded in September 2020.

Ms. Lobedan provided update on City's response to homelessness with announcement and information on a pilot program to expand the Navigation Center type services with a Pilot Program of a Navigation Center Annex operating out of a local hotel. This program would focus on providing services to 30 to 35 citizens that have an increased vulnerability due to the circumstances of COVID-19.

##### *Community Conversations on Policing*

Ms. Davis provided overview on Hayward Police Department's presentation to City Council at the November 17, 2020, meeting, regarding police performance over the past two years.

### *CSC Agenda Planning Calendar*

A motion to approve the minutes was moved by Commissioner Arti Garg with a second by Commissioner Zachariah Oquenda. The motion was approved with fourteen (14) ayes and two (2) commissioners abstaining.
