Acting Planning Manager Lochirco said the applicant is working collaboratively with City staff on added conditions of approval on the potential traffic improvements and cannot elaborate more at this time.

Commissioner Oquenda asked if the project has involved the Hayward Unified School District and has there been any outreach to the HUSD Board.

Acting Planning Manager Lochirco said that he cannot speak on this at this time and that since the item is being postponed that there should be limited discussion. Mr. Lochirco said when the item comes back, if there are specific questions, Commissioners can provide questions which will be forwarded to the project planner.

Commissioner Mendall asked if there needs to a formal motion and vote.

Assistant City Attorney Brick said he is comfortable with the informal unanimous vote that the item be continued to a date certain and echoed Mr. Lochirco's comments about there should be limited discussion on the item.

COMMISSION REPORTS

Oral Report on Planning and Zoning Matters:

Acting Planning Manager Lochirco asked if the Planning Commissioners have an interest in meeting informally with Planning Staff to meet and mingle noting that this would not be a work meeting. Chair Roche said that there are lot of head nods and thumbs up from the Commissioners and they will all be looking forward to this opportunity. Mr. Lochirco wanted to see if there is support for the Planning Commission to have a joint session with the City Council with a tentative date of September 21, 2021, from the hours of 5 to 7 p.m. This joint session is to discuss housing related items and concerns. Chair Roche said there is interest from the Commissioners. Mr. Lochirco announced that City Hall will begin a phased reopening beginning July 6, 2021, with public hours from 9 am to 1 pm for limited services. Then City Hall will open for regular hours from 8 am to 5 pm beginning Monday, September 13, 2021. Mr. Lochirco said that staff is working collaboratively with the City Manager's Office and the Maintenance Services Department to create a safe working environment for both staff and public members.

Mr. Lochirco announced that applications for the City Commission and Task Force recruitment are due by June 30, 2021. If there is interest for the various vacancies which includes the Planning Commission, to contact the City Clerk's Office at 510-583-4400 and can also view recruitment information at www.hayward-ca.gov/serve.

Mr. Lorcirco announced that the two items for the next Planning Commission meeting on July 8, 2021, are a conditional use permit application for a Starbucks drive through and the U-Haul Redevelopment project near Point Eden. He said for the U-Haul item, the environmental impact report (EIR) with all attachments will be available on the City's website for review on Friday, June 25, 2021, and encouraged the Commissioners to review the lengthy document.

Commissioners' Announcements, Referrals:

Commissioner Mendall asked about the status of the two Amazon proposals one on W. Winton that is going to Council and the other on Clawiter that is going before the Planning Commission.

Acting Planning Manager Lochirco said the applicant has requested to pause any decisions at this time on the W. Winton site and is not at liberty to speak about this. He said Amazon has not withdrawn their application and that the Planning Commission reviewed this application earlier this year and forwarded a recommendation to the City Council which is pending at this time.
