CLOSED SESSION ANNOUNCEMENTS

The City Council convened in a special closed session on March 29, 2022, at 4:00 p.m., with all members present, regarding conference with legal counsel pursuant to Government Code sections 54956.9(d)(2) and 54956.9(e)(1) regarding anticipated litigation. City Attorney Lawson announced there was no reportable action related to the item and the closed session adjourned at 5:15 p.m.

The City Council convened in closed session on April 5, 2022, at 5:30 p.m., with all members present, regarding the City Attorney's annual performance evaluation pursuant to Government Code section 54957. Mayor Halliday announced there was no reportable action related to the item.

Mayor Halliday presented a certificate of recognition to Ms. Germani A. Latchison in honor of her selection as the first-ever 2022 *Hayward Youth Poet Laureate*. Mayor Halliday presented a certificate of recognition to Ms. Papi Constantino, the 2nd place runner up, and recognized Ms. Kyri Taylor, the 1st runner up (not in attendance), in the City of Hayward's First Youth Poet Laureate Program. Poet Laureate Bruce Roberts read aloud his poem entitled, "Bookworms," in celebration of National Library Week.

WORK SESSION

11. Community Agency Funding: Fiscal Year 2023 Community Agency Funding Recommendations for Services, Arts & Music, and Economic Development and Infrastructure; and Overview of the FY 2023 Annual Action Plan and the City of Hayward Community Development Block Grant Citizen (CDBG) Participation Plan WS 22-007

Staff report submitted by Assistant City Manager Ott, dated April 5, 2022, was filed.

Development Services Director Ott introduced Community Services Manager Davis and Management Analyst Lee who provided an overview of FY 2023 Annual Action Plan, City of Hayward Community Development Block Grant (CDBG) Citizen Participation Plan updates and FY 2023 Community Agency Funding process. It was noted that the Community Agency Funding recommendations would be separated into two sections: I) General Fund/American Rescue Plan Act (ARPA) (Arts and Music and Services) and II) CDBG (Public Services and Economic Development & Infrastructure).

Community Services Manager Davis and Management Analyst Lee provided an overview of General Fund/American Rescue Plan Act (ARPA) (Arts and Music and Services) funding recommendations.

Mayor Halliday opened the public comment section at 8:05 p.m. to allow for comments on the Annual Action Plan, Citizen Participation Pan, and FY 2023 Arts & Music and Services (General Fund/ARPA) funding recommendations.

Ms. Heather Reyes, Hayward Arts Council President, was pleased with changes in the recommendations for funding, expressed she was not in agreement with seeing arts grouped together with special events, and spoke in favor of prioritizing funds for arts.

Ms. Suzanne Philis, Hayward Arts Council Board member, commented that art was a way for all community members to come together, and urged keeping the funds for arts and events separate.

Mr. Gerald Thompson, Hayward Arts Council Board member, asked the Council to increase the Arts & Music annual funding allocation to \$150,000 to adequately serve the needs of the community.

Ms. Carol Morgan, East Bay Youth Orchestra representative, thanked the Council for funding the agency over the years, and urged continued funding for music.

Ms. Arti Garg, Community Services Commission (CSC) Vice Chair, thanked the Council for reviewing CSC recommendations, and noted the demand for services funding has been outpacing funding availability.

Ms. Artavia Berry, Community Services Commission Chair, expressed the great need to expand the pot of available funds for growing social service and other needs in Hayward.

Mayor Halliday closed the public comments section at 8:21 p.m.

Members of the City Council thanked City staff and members of the Community Services Commission for their work relating to funding recommendations.

Discussion ensued among members of the City Council and City staff regarding the following: process for clarifying which organizations serve Hayward residents; Family Education Program (Library Program) and funding source (Community Agency Funding vs. General Fund); cannabis tax savings; FY 2022 available funding for arts and music; legal services funding; the new Mercy Brown Bag program; Crisis Support Services of Alameda County agency; social service awards infused with ARPA funding; Newcomer Navigation Center project for undocumented immigrant youth; clearinghouse of grants for agency funding such as for addressing human trafficking; staff's technical assistance for supporting agencies to be in CDBG category.

Members of the City Council provided the following recommendations: include the Library tutoring program in the budget discussion; provide details on how Blues Society funds for the Russell City Blues Festival were spent; continue the dialogue for funding arts & music, culture and special events; engage the Hayward Local Agency Committee (HLAC) and other community partners in discussion about arts to leverage different funds; consider prioritizing arts and removing them from events or setting a protected amount of funds for arts; consider partnering with the Hayward Chamber of Commerce to host and sponsor events; evaluate reprioritizing the use of City resources supporting for-profit events; evaluate programs that provide similar services to ensure there is not redundancy in service delivery; provide more detailed data from 2-1-1 reports related to Hayward calls; encourage public participation in funding process; explore how to incorporate public art as

a blight mitigation tool and give people a sense of place; explore how to expand cannabis funds and perhaps sooner than reaching the 1 million mark; evaluate reallocating funding to the appropriate source; reimagine economic development; think about public art parallel to economic development; consider an Art and Culture Commission to promote the diversity of cultures so the Community Services Commission can focus on CDBG and social service funding.

Council Members Salinas and Zermeño recused themselves for the remainder of the work session due to service on the St. Rose Hospital Foundation Board. Council Member Zermeño left the Council Chamber and Council Member Salinas disconnected from the Zoom webinar.

Management Analyst Lee provided a synopsis of Section II of the Community Agency Funding recommendations, CDBG (Public Services and Economic Development & Infrastructure).

There being no comments on this segment of funding, Mayor Halliday opened and closed the public comment section at 9:24 p.m.

Members of the City Council reiterated their appreciation for staff and the work done by members of the Community Services Commission. Council Member Andrews urged community members to donate to organizations seeking funding.

Staff noted the public hearing on CDBG funding allocations for FY 2023 would be held during the April 26, 2022, Council meeting.

Following the conclusion of the work session, Council Member Salinas rejoined the Council meeting on Zoom.

12. Solid Waste and Recycling Franchise Agreement: Update on Negotiations WS 22-008

Staff report submitted by Director of Public Works Ameri, dated April 5, 2022, was filed.

Public Works Director Ameri announced the item and introduced Solid Waste Program Manager Krump who provided a synopsis of the staff report.

There were no public comments for the item.

Members of the City Council thanked City staff for work related to the franchise agreement with Waste Management of Alameda County (WMAC), Senate Bill 1383 (Cart and Bin Requirements) and (Organics Procurement).

Discussion ensued among members of the City Council and City staff regarding: the main function of the Main Street office of Waste Management and the potential for that to close permanently, following its closure over the past two years; Waste Management's public education; bulk pickup service; tracking illegal dumping; potential of device for customers to pay their bills on site at City Hall; adding to the stickers on new bins with information about bulk pick-up service; addition of Electric Vehicle (EV) trucks in the future; and, street cleaning and pavement maintenance required.

Some members of the City Council expressed support for Option 1B (customers do not see an increase until March 1, 2023 but would see a franchise rate adjustment at that time) regarding a new rate schedule for solid waste and recycling services.
