RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A COOPERATIVE AGREEMENT WITH CALTRANS FOR REIMBURSEMENT FROM THE LATIP FUNDS FOR THE TRAFFIC SIGNAL IMPROVEMENTS ON JACKSON STREET (FORMERLY SR92)

WHEREAS, the Local Alternative Transportation Improvement Program (LATIP) included Phase 2, SR 238 Mission Boulevard from Industrial Parkway to the south City limit and SR 92 Jackson Street from Watkins Street to Santa Clara Street;

WHEREAS, California Transportation Commission (CTC) in October 2017 allocated \$19,900,000 for the construction phase of Phase 2;

WHEREAS, construction for the Phase 2 Mission Boulevard segment was completed in April 2021 and expended \$19,369,000 in LATIP funds;

WHEREAS, the scope of work for Jackson Street was originally included in Phase 2 of Mission Boulevard; however, removed from bid document during the bidding phase due to bidder questions that required additional time to design;

WHEREAS, the improvements to the traffic signals on Jackson Street includes new controllers, adaptive traffic management system (SCATS), video detection and PTZ cameras at four existing intersections on Jackson Street at Amador Street, Soto Road, Winton Avenue and Meek Avenue;

WHEREAS, during the March 2022 CTC meeting, the LATIP allocation was amended to utilize the remaining funds of \$531,000 to complete the originally scoped work on Jackson Street;

WHEREAS, Caltrans and the City of Hayward are authorized to enter into a cooperative agreement for the Jackson Street traffic signal improvements;

WHEREAS, Caltrans will reimburse the City of Hayward \$531,000 from the LATIP funds;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the City Manager is hereby authorized to execute a Caltrans Cooperative Agreement for the reimbursement of \$531,000 from the LATIP funds for the design, construction contract and construction support phases of the Jackson Street traffic signal improvements.
