**PUBLIC HEARINGS:** For agenda item No. 1, the Planning Commission may make a recommendation to the City Council.

1. Recommended Approval and Necessary Actions to Allow Construction of a New Single Family Home on a Site with Slopes that Exceed 20% at the Terminus of Dryden Court (Assessor's Parcel Number 081D-2086-064-00) for Bijan Mashaw (Applicant/Owner). Proposed Project Includes Adoption of Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program

Planning Manager Buizer provided a synopsis of the staff report.

Chair Parso-York opened the public hearing at 7:08 p.m.

Commissioner Schott invited Applicant/Owner Mr. Mashaw to speak about his project and the grading requirements for this project. Mr. Schott disclosed the Mr. Mashaw had called him to discuss the project and Mr. Schott wanted to make sure that Mr. Mashaw's questions were answered in regards to the grading permit. Mr. Mashaw said that his project qualifies for an exemption to the grading permit. Planning Manager Buizer expanded upon the

requirements for the grading permit and site plan review for the project because of a 1993 Council approval of the Parcel Map and Conditions of Approval dictated that future development at this site would have the requirements of a grading permit and site plan review. In response to Commissioner Schott's questions, Ms. Buizer said that each project will need to be reviewed individually.

Planning Manager Buizer responded to Commissioner Enders that the member of the public that had a question related to the underground spring on the site has not followed up and there were no other inquiries from the public.

Commissioner McDermott said she liked the plans and how the new larger building will fit into the hillside. Mr. Mashaw stated that the parcel was already subdivided when he purchased the property.

Planning Manager Buizer responded to Commissioner Willis that there are no existing easements. Mr. Willis said he likes the plans and was happy that Mr. Mashaw plans to have solar elements on the home.

Chair Parso-York closed the public hearing 7:17 p.m.

Planning Manager Buizer assured Mr. Mashaw that all corrections regarding the garage will be made prior to presenting the item to the City Council.

Commissioner Willis Jr. made a motion to move the item per the staff recommendation.

Commissioner Enders seconded the motion. Ms. Enders commented that she all the findings are in compliance and noted that the project will fit into the surrounding neighborhoods as the homes are similar to the project as far as being on a slope, being three tiered, beautiful structures and open to the mountainside. Ms. Enders said this home will complete the court and noted with the long driveway that wildlife will be able to navigate the mountainside via the driveway.
