

MINUTES OF THE CITY COUNCIL MEETING OF THE CITY OF HAYWARD Council Chambers 777 B Street, Hayward, CA 94541 Tuesday, May 2, 2017, 7:00 p.m.

The City Council meeting was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council Member Peixoto.

CLOSES SESSION

City Attorney Lawson announced the City Council convened in closed session regarding three items: 1) conference with labor negotiators pursuant to Government Code 54957.6 regarding all groups; 2) conference with legal counsel pursuant to Government Code 54956.9 regarding one anticipated case; and 3) conference with legal counsel pursuant to Government Code 54956.9 regarding Russell City Energy Company v. City of Hayward, California Court of Appeal Case No. A144749. City Attorney Lawson noted there was no reportable action.

PRESENTATIONS

Council Member Mendall read a proclamation presented to Carl Baker-Madsen for his dedication and service to the City of Hayward and the Downtown Hayward business community.

Mayor Halliday read a proclamation recognizing the week of May 7-13, 2017 as Public Service Recognition Week and presented it to City Manager McAdoo and Human Resources Director Collins.

PUBLIC COMMENTS

Mr. Jim Drake, Hayward resident, noted that the pine trees that were removed from Santa Clara and Jackson Streets have not been replaced; and spoke about issues with wheelchair ramps.

Ms. Wynn Grcich, Hayward resident, spoke about the deadly pesticide atrazine; a book entitled Science for Sale by David Lewis; Agenda 21, the Plan to Kill You by David Icke; Public Law 105-83; and an article entitled "New challenge to vaccine law."

WORK SESSION

 Review of 21st Century Library and Community Learning Center Staffing Considerations (Report from Library and Community Services Director Reinhart) WS 17-016 Staff report submitted by Library and Community Services Director Reinhart, dated April 25, 2017, was filed.

City Manager McAdoo announced the report and introduced Library and Community Services Director Reinhart who provided a synopsis of the report.

Mayor Halliday opened the public comments section at 7:57 p.m.

Ms. Iris Murillo, Library Commission member, urged the Council to consider the recommended moderate increase in library staffing and any revenue that might offset the cost of additional staffing.

Mayor Halliday closed the public comments section at 8:00 p.m.

Discussion ensued among Council Members and City staff regarding staffing increases to operate the new library; the anticipated revenue related to fees, fines, Café, and bookstore; vacancies within the Library and Community Services Department; partnerships with local agencies to operate programs and leverage outside resources; cross-training City employees for maximum productivity; six-month staffing plan and budgeting at fifty percent of the proposed cost; the Information Technology Analyst I/II proposed position; federal grants as sources of revenue; and the Heritage Plaza and underground rainwater storage system.

Council Members noted there would be additional discussion about the staffing considerations during the budget work session and offered the following recommendation: prioritize staffing increases to have the new library open for additional hours and Sunday hours; staff appropriately for the first months when the new library is open to address increase in service demand; after the initial spike tapers off, consider staffing up or maintaining staffing levels; consider expanding partnerships, internships, and volunteers for new programs; consider return on investment for the tax payers; align the library schedule with the California State University East Bay schedule and other educational institutions; and explore using rooms at the new library to hold classes.

PUBLIC HEARING

8. Approval of Fiscal Year 2017-18 Community Agency Funding Recommendations (Report from Library and Community Services Director Reinhart) **PH 17-020**

Staff report submitted by Library and Community Services Director Reinhart, dated May 2, 2017, was filed.

Library and Community Services Director Reinhart and Community Services Manager Bailey provided a synopsis of the report.

Mayor Halliday opened the public hearing at 8:45 p.m.

Ms. Diane Fagalde, Community Services Commission (CSC) member, urged the Council to approve the CSC recommendations.

Ms. Sharan Aminy, 2-11 Program Manager representing Eden I&R, Inc., thanked the Council for supporting the CSC recommendations.

Ms. Kate Hart, Safe Alternatives to Violent Environments (SAVE) Program Director, asked the City to reconsider the CSC recommendation and restore the funding for a Community Oriented Prevention Services (COPS) advocate to operate out of the Hayward Police Department.

Mayor Halliday closed the public hearing at 8:51 p.m.

In response to Council Member Zermeño' s inquiry about SAVE's request, staff noted that the 4/18/2017 Council staff report outlined justifications for programs that were not recommended for funding.

It was <u>moved by Council Member Zermeño</u>, seconded by <u>Council Member Márquez</u>, and <u>carried unanimously</u>, to adopt the following:

Resolution 17-052, "Resolution Authorizing an Application for Federal Assistance Under the Community Development Block Grant Program for Federal Fiscal Year 2017-2018"

9. FY 2018 Master Fee Schedule/Fine and Bail Schedule (Report from Director of Finance Claussen) **PH 17-023**

Staff report submitted by Finance Director Claussen, dated May 2, 2017, was filed.

Finance Director Claussen provided a synopsis of the staff report and Public Works Director Fakhrai provided information about the proposed increase in hangar fees.

Discussion ensued among Council Members and City staff regarding: fees in the proposed FY 2018 Master Fee Schedule; proposed increase in hangar fees at a rate of ten percent annually and deferred regular maintenance due to lack of sufficient funds; needed taxiway and ramp maintenance; fees for new and existing airport tenants; rent stabilization administration fees; cabarets and dance licenses and permits; animal services fees; Target Store purchase; water heater permit fees; and Comprehensive User Fee Study.

Mayor Halliday opened the public hearing at 9:26 p.m.

The following speakers spoke against staff's recommendation for increase in hangar fees for the following reasons: it was not reasonable to increase hangar rents by fifty percent (phasing in series of ten percent increases for the next five years); hangar rent increases have been historically controlled by a CPI formula; the Council Airport Committee does not have tenant representatives; the airport tenants represents the culture of the airport; the City receives federal funds for airport maintenance; and the vacancy hangar rate will increase due to the fee increase. Speakers urged the Council to postpone approval of the airport fees until staff and airport tenants can come to a mutually agreeable solution.

Mr. Ben Henderson, Hayward resident, asked the Council to agendize changing a street name at the Hayward airport from Tuskegee Drive to Tuskegee Airmen Drive, and spoke about a letter that was submitted to the City by Mr. Cunningham. Staff noted that staff had contacted Mr. Cunningham regarding the street name change.

Mayor Halliday closed the public hearing at 10:05 p.m.

In response to Mr. Ben Henderson, Council Members were in general agreement that the name change from Tuskegee Drive to Tuskegee Airmen Drive needed to be fixed.

Council Member Salinas offered a motion per staff's recommendation with a modification that the proposed fee increase for the airport be delayed for one year and during that year reintroduce a robust discussion about fee increases.

There being no second to the motion, it died for lack of a second.

Council Member Mendall noted that the funds coming to the airport had, for decades, been below what is needed for its maintenance, and the increased fees would go to the airport for its maintenance.

Council Member Mendall moved the staff's recommendation including the up to ten percent airport fee increase for the first year with a robust conversation to follow for subsequent year increases.



Council Member Zermeño seconded the motion noting the airport needed improvements and added that during the first year there will be an opportunity for discussion among all stakeholders.

Council Member Lamnin supported the motion and noted that she did not support a ten percent increase every year and suggested that other appropriate options be explored and included into the robust conversation such as market rate rent for new tenants. Ms. Lamnin added that water heater fees needed to be reviewed.

Council Member Márquez supported the motion, noted that the Council Infrastructure Committee could assist with the analysis of airport fees, supported having more community input in Council Airport Committee meetings, and suggested to prioritize holding a meeting with long-term airport tenants.

Council Member Salinas noted he would be voting against the motion regretting that the airport fees were included in the entire proposed FY 2018 Master Fee Schedule.

Council Member Peixoto supported the motion and noted that he trusted the consultant's professional recommendations related to the airport fees.

Mayor Halliday supported the motion and recommended that staff continue the conversation with airport tenants. Mayor Halliday was disappointed at the increase in alcohol fees for special events and expressed appreciation for the reduction in fees for animal impoundment fees.

It was <u>moved by Council Member Mendall</u>, seconded by <u>Council Member Zermeño</u>, and <u>carried</u> <u>with the following vote</u>, to adopt the resolution:
