RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH CEL CONSULTING, INC., FOR ON-SITE PLAN CHECK SERVICES FOR AN AMOUNT NOT TO EXCEED \$93,000.

WHEREAS, the City of Hayward Building Division has four permanent employees that are certified to conduct various levels of plan check review; and

WHEREAS, due to the vacancy of the City Building Official position, the Supervising Plan Checker/Expeditor was appointed to act as the City Building Official; and

WHEREAS, the Senior Plan Checker was simultaneously appointed to act as the Supervising Plan Checker/Expeditor; and

WHEREAS, the existing firms the City has on contract, have not been able to provide on-site personnel for plan check services; and

WHEREAS, the City of Hayward executed an Agreement with CEL Consulting on October 18, 2016 to provide temporary on-site plan check services for an amount not to exceed \$25,000; and

WHEREAS, an Amendment to the Agreement with CEL Consulting was executed on April 10, 2017 to amend the contract budget for an amount not to exceed \$75,000; and

WHEREAS, utilizing on-site plan check services provides more timely turnaround times for permit applicants, and allows permanent staff to focus on large project plans; and

WHEREAS, CEL Consulting is able to further provide on-site plan check review services; and

WHEREAS, amending the agreement with CEL Consulting to increase the contract amount to \$93,000 and extend the term to December 30, 2017, will allow Development Services staff to solicit bids for plan check services to include on-site assistance; and

WHEREAS, the costs to amend the agreement with CEL Consulting will be covered by existing budget appropriation in the approved FY18 Operating Budget.
