RESOLUTION AWARDING CONTRACT TO GSE CONSTRUCTION COMPANY, INC. FOR THE WATER POLLUTION CONTROL FACILITY FINAL CLARIFIER AND GRAVITY BELT THICKENER SLUDGE BLENDING TANK REHABILITATION, PROJECT NO. 07703

WHEREAS, By Resolution No. 18-073 on May 8, 2018, the City Council approved the plans and specifications for the Water Pollution Control Facility Final Clarifier and Gravity Belt Thickener Sludge Blending Tank Rehabilitation, Project No. 07703, and called for bids to be received on June 12, 2018; and

WHEREAS, Addendum No. 1 was issued to make minor revisions to the specifications; and

WHEREAS, On June 12, three (3) bids were received ranging from \$1,977,100 to \$2,572,400. The low bid, submitted by GSE Construction Company, Inc. of Livermore, CA, is approximately 2.9% below the engineer's estimate of \$2,037,000; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that Addendum No. 1 is hereby approved and adopted as part of the plans and specifications for the project.

BE IT FURTHER RESOLVED that GSE Construction Company, Inc. is hereby awarded the contract for the Water Pollution Control Facility Final Clarifier and Gravity Belt Thickener Sludge Blending Tank Rehabilitation, Project No. 07703, in accordance with the plans and specifications adopted therefore and on file in the office of the City Clerk of the City of Hayward, at and for the price named and stated in the final proposal of the hereinabove specified bidder, and all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute an agreement with GSE Construction Company, Inc. in the name of and for and on behalf of the City of Hayward, in an amount not to exceed \$2,137,100 (including administrative change orders), in a form to be approved by the City Attorney.
