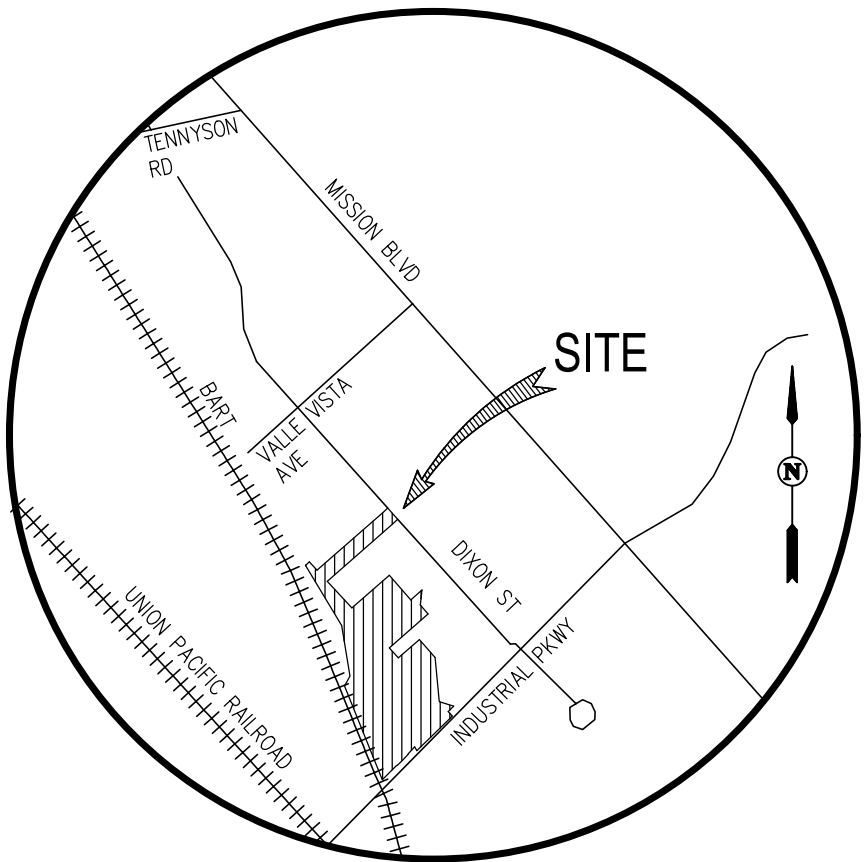

VICINITY MAP

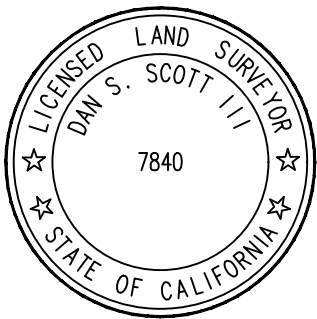

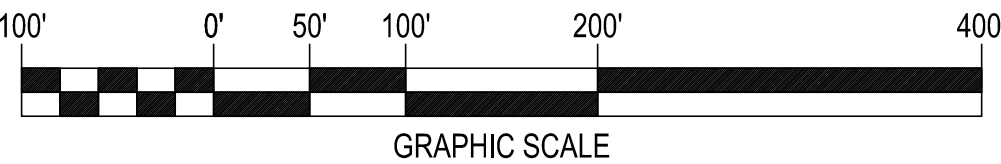
