RESOLUTION APPROVING AWARD OF CONTRACT FOR THE FY 2019 PAVEMENT REHABILITATION AND PREVENTATIVE MAINTENANCE PROJECT, PROJECT NOS. 05216, 05219, 05220, 05280, AND 05231 TO O'GRADY PAVING INC.

WHEREAS, by resolution on December 11, 2018, the City Council approved the plans and specifications for the FY19 Pavement Rehabilitation and Preventive Maintenance Project, Project Nos. 05216, 05219, 05220, 05280, & 05231, and called for bids to be received on January 15, 2019; and

WHEREAS, on January 10, 2019, Addendum No. 1 was provided to revise plans and specifications; and

WHEREAS, on January 15, 2019, six bids were received, ranging from \$4,064,057 to \$4,919,698; O'Grady Paving Inc. of Mountain View, California submitted the low bid in the amount of \$4,064,057, which is 22% below the engineer's estimate of \$5,211,145; and

WHEREAS, the Administrative Change Order (ACO) or contingency budget of \$1,406,943 was not disclosed; and

WHEREAS, the amount of the low bid provides an opportunity to increase the project scope to include additional work to Hesperian Boulevard, from Industrial Parkway to City limits, valued at \$1,406,943.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that O'Grady Paving Inc. is hereby awarded the contract for the FY19 Pavement Rehabilitation and Preventive Maintenance Project, Project Nos. 05216, 05219, 05220, 05280, & 05231, in an amount not-to-exceed \$5,471,000, in accordance with the plans and specifications adopted therefore and on file in the office of the City Clerk of the City of Hayward at and for the price named and stated in the bid of the hereinabove specified bidder, and all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute the contract with O'Grady Paving, Inc., in the name of and for and on behalf of the City of Hayward, in a form to be approved by the City Attorney.
