SUBJECT: Designation of Voting Delegates and Alternates for the League of California Cities 2019 Annual Conference

RECOMMENDATION

That the City Council designates a voting delegate and alternates as Hayward's representatives to the 2019 League Annual Business Meeting at the League of California Cities Annual Conference and adopts a resolution with the designees identified; and authorizes the City Clerk to submit the 2019 Annual Conference Voting Delegate/Alternate Form along with the adopted Resolution.

SUMMARY

The League of California Cities 2019 Annual Conference is scheduled for October 16-18, 2019 in Long Beach, California. The Annual Business Meeting (General Assembly), scheduled for Friday, October 18, 2019, is typically where various municipalities' voting delegates vote on resolutions considered by the League. To vote at the Annual Business Meeting, the City Council must designate a voting delegate and up to two alternates and submit the names to the League no later than October 4, 2019.

BACKGROUND AND DISCUSSION

Consistent with the League of California Cities bylaws, the City Council must designate the City's voting delegate and up to two alternates by formal Resolution no later than October 4, 2019. The voting delegate and alternates must be registered to attend the Annual Conference. At least one voter must be present at the Annual Business Meeting and in possession of the voting delegate card to cast a vote. The voting delegate card may be transferred freely between the voting delegate and alternates.

Currently Council Member Salinas is the City's delegate to the League of California Cities East Bay Division and Council Member Wahab is the City's alternate. Council Members Salinas and Mayor Halliday expressed interest in attending the League's Annual Conference, have registered to do so, and are available to represent the Council's position on legislative matters at the Annual Business Meeting.

The League's correspondence includes the Annual Conference Voting Procedures and the Voting Delegate/Alternate Form and are provided as Attachment III for Council's reference.

FISCAL IMPACT

There is no fiscal or economic impact associated with this report.

STRATEGIC INITIATIVES

This agenda item is a routine operational item and does not relate to one of the Council's Strategic Initiatives.
