Approval of Minutes of the Community Services Commission Meeting on May 15, 2019:

Discussion:

Update: Navigation Center

Ms. Davis provided the Commission with updates on the Navigation Center:

- City of Hayward received \$1,000,000 in Proposition 47 funds over the next four (4) years, which will offset operating expenses for the Navigation Center,
- Possible Fall opening,
- Engaging in community fundraising campaign to seek donations to develop the Center to be welcoming,
- Received donation of plants/trees from the Mosconi Center, repurposed from an event,
- City of Hayward's Maintenance Division transported the donation to the Corporation Yard,
- Donation was arranged through Homeaide who communicated with BrightView to align this donation for the Navigation Center,
- Announced the Commission will be notified of future opportunities for community engagement for on-site,
- Currently working on facility infrastructure: water, sewer, electrical service.

Update: CDBG Timeliness

 Ms. Davis updated the Commission on the Community Development Block Grant funding timeliness check on the amount of money spent by comparison of the amount of money granted. In 2017 the City of Hayward was unable to meet timeliness of less than a 1.5 ratio. In May of 2018, the City was still unable to make timeliness. In May of 2019, the City of Hayward made timeliness, putting a total of \$4.6 million dollars back into the community of Hayward.

• Fiscal Year 2019 – 2020 Agenda Planning Calendar was unanimously passed by remaining eleven members of the Commission.
