RESOLUTION AUTHORIZING THE CITY MANAGER TO AMEND THE PROFESSIONAL SERVICES AGREEMENT WITH LUHDORFF & SCALMANINI CONSULTING ENGINEERS TO INCREASE THE CONTRACT AMOUNT FOR TECHNICAL GROUNDWATER SUPPORT SERVICES BY \$35,000, TO A NOT TO EXCEED AMOUNT OF \$110,000

WHEREAS, the City of Hayward ("City") is the Groundwater Sustainability Agency ("GSA") for the portion of the East Bay Plain Groundwater Subbasin that underlies the City in accordance with requirements of the Sustainable Groundwater Management Act ("SGMA"); and

WHEREAS, under the requirements of SGMA, GSAs must prepare a Groundwater Sustainability Plan ("GSP") to sustainably manage the groundwater basin for which it is responsible and submit the GSP to the State by January 31, 2022; and

WHEREAS, on June 25, 2018, the City entered into a Cooperating Agreement with the East Bay Municipal Utility District ("EBMUD"), which is the GSA for the remainder of the East Bay Plain Subbasin, to prepare a single GSP for the entire Subbasin; and

WHEREAS, the City executed a professional services agreement with Luhdorff & Scalmanini Consulting Engineers ("LSCE") on December 12, 2016 for groundwater services related to SGMA, which has been amended twice, to a currently authorized maximum contract amount of \$75,000; and

WHEREAS, the City and EBMUD jointly selected LSCE to assist with preparation of the GSP for the East Bay Plain Subbasin; and

WHEREAS, the City needs additional groundwater support services related to data collection and development of the GSP, including installation of instrumentation in the City's emergency wells to continuously monitor water levels; and

WHEREAS, LSCE has demonstrated technical expertise and applicable experience and has reasonable hourly rates; and

WHEREAS, the cost of the additional groundwater support services is \$35,000 for LSCE to assist with the selection and installation of groundwater monitoring transducers in the City's emergency wells and to provide additional technical assistance to support the City in developing the GSP; and

WHEREAS, sufficient funding for this work has been approved in the FY 2020 Capital Improvement Program Water Improvement Fund.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward hereby authorizes the City Manager to amend the professional services agreement with Luhdorff & Scalmanini Consulting Engineers to increase the contract amount for additional technical groundwater support services related to the Sustainable Groundwater Management Act by \$35,000, to a total not to exceed amount of \$110,000
