SUBJECT:	Adopt a Resolution Authorizing the City Manager to Execute an Amendment to the Agreements with The Metropolitan Group, and CSG Consultants, for Planning and Engineering Services Increasing the Not-to-Exceed Amount to \$125,000 Per Agreement.	

RECOMMENDATION

That Council adopts a Resolution (Attachment II) authorizing the City Manager to execute an amendment to the agreements with The Metropolitan Group, and CSG Consultants, for Planning and Engineering Services Increasing the Not-to-Exceed Amount to \$125,000 Per Agreement.

SUMMARY

Staff seeks Council approval authorizing the City Manager to execute Amendments to the Agreements with The Metropolitan Group, and CSG Consultants to provide Planning and Engineering Services by increasing the not to exceed amount to \$125,000 per agreement and extending the terms to December 31, 2020.

BACKGROUND

The Development Services Department currently has valid agreements with The Metropolitan Group (M-Group), and CSG Consultants (CSG) to provide temporary, on-call, professional planning consultant services. These consultants provide qualified temporary staffing to perform a wide range of technical responsibilities related to Planning Division activities. Recent unexpected vacancies within the Planning Division, as well as the anticipation of several large projects, and the implementation of BlueBeam and EnerGov, result in a foreseeable need for further staff augmentation.

DISCUSSION

The current agreements with M-Group and CSG are valid through June 2020. Recent unexpected vacancies in the Planning Division requiring utilization of temporary staffing to maintain the workflow and customer service levels, have exhausted the original \$75,000 budget for these agreements.

The Development Services Department has also been designated to lead fifteen projects within the Strategic Roadmap. The Planning Division will be responsible for initiating six of those projects in years one and two. Staff is concurrently scheduled to implement new plan review software (BlueBeam) within the next two months in order to integrate it with the new EnerGov permitting software (Strategic Roadmap Priority of Organizational Health, Project #15), which is scheduled to begin development by the end of the fiscal year. Amending the current agreements to increase the not to exceed amount from \$75,000 to \$125,000 per agreement, and extending the term to December 31, 2020, will allow staff to develop the best approach to the projects associated with the Strategic Roadmap, as well as the best strategies for developing and implementing BlueBeam and the EnerGov permitting software.

STRATEGIC ROADMAP
