

MINUTES OF THE CITY COUNCIL Council Chambers 777 B Street, Hayward, CA 94541 Tuesday, January 28, 2020, 7:00 p.m.

The City Council meeting was called to order by Mayor Halliday at 7:00 p.m., followed by the Pledge of Allegiance led by Council Member Wahab.

CLOSED SESSION ANNOUNCEMENT

The City Council convened in closed session at 6:00 p.m., regarding four items: 1) conference with legal counsel pursuant to Government Code 54956.9 regarding AGG, et al. v. City of Hayward, et al., U.S. District Court, ND CA, No. #4: 4:19-civ-00697-DMR; 2) conference with legal counsel pursuant to Government Code 54956.9 regarding anticipated litigation; 3) conference with legal counsel pursuant to Government Code 54956.9 regarding anticipated litigation; and 4) conference with legal counsel pursuant to Government Code 54956.9 regarding anticipated litigation.

Mayor Halliday announced that, pursuant to Government Code Section 54954.2 (b) (2), the Council unanimously approved, with Council Member Márquez moving and Council Member Zermeño seconding, to add a fifth item to the agenda to discuss one anticipated litigation case, but the item was not discussed. City Attorney Lawson noted there was no reportable action related to Items 1, 2, and 3, and the City Council would reconvene in Closed Session after the regular meeting to continue discussing Item 4 and the new item added.

Staff report submitted by Public Works Director Ameri, dated January 28, 2020, was filed.

Environmental Services Manager Pearson announced the report and introduced Solid Waste Program Manager Krump who provided a synopsis of the staff report.

Discussion ensued among Council members and City staff regarding public notification about the garbage and recycling annual rate increase, bulky collection service, garbage services, and recycling program and diversion rate.

There being no public comments, Mayor Halliday opened and closed the public hearing at 7:35 p.m.

Council Member Wahab offered a motion per staff's recommendation and Council Member Márquez seconded the motion.

Council members commended staff's work related to the proposed garbage and recycling rates.

Council Member Lamnin recommended staff bring forward an informational item about a report on efforts at the county level to address the infrastructure needs for recycling.

Council Member Zermeño noted that as the City's representative to the Alameda County Waste Management Authority (ACWMA), he had been pushing for a system that would allow the country to take care of its own garbage as opposed to sending it to other parts of the world.

Mayor Halliday commended Council Member Zermeño for serving as the City's delegate to the ACWMA and Council Member Lamnin for her service as the alternate.

It was <u>moved by Council Member Wahab</u>, seconded by Council Member Márquez, and carried <u>unanimously</u>, to approve the following:

Council Member Lamnin reported on meetings she attended: CalPERS's forum to discuss more transparency in healthcare cost; League of California Cities, Policy Committee meeting to address sustainable use of taxpayers' dollars; AC Transit meeting to discuss bus service; and Hayward Local Agencies Committee meeting to address the Census.

Council Member Zermeño thanked City staff for the improvements along Tennyson Corridor.

Council Member Wahab wished a Happy Lunar New Year to those who celebrate; and spoke about potential efforts to add subtitles to meeting videos for community members.

Council Member Salinas reported on his attendance at a Land Use Law and Policy conference where policies around homelessness, producing, preserving, and protecting housing were discussed.

Mayor Halliday reported on her attendance, along with City Manager McAdoo, at a meeting convened by the Alameda County Board of Supervisors to discuss a potential half-cent sales tax to address housing issues.

COUNCIL REFERRALS

There were none.

ADJOURNMENT

Mayor Halliday adjourned the meeting at 7:51 p.m., in memory of former California Congressman Fortney "Pete" Stark. Mayor Halliday noted Congressman Pete Stark was a longtime East Bay congressman, had many accomplishments during his tenure, and was instrumental for the Affordable Care Act and had left papers to the Hayward Area Historical Society for future research. Mayor Halliday asked staff to work with the Stark family to plant a tree in memory of Pete Stark. Mayor Halliday expressed sadness for the tragic helicopter

crash in Los Angeles that took the life of retired National Basketball Association star, Kobe Bryant, and eight other people.

Mayor Halliday announced the City Council would reconvene into Closed Session in Conference Room 2A.
