RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAYWARD AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN EXCLUSIVE NEGOTIATING RIGHTS AGREEMENT BETWEEN THE CITY OF HAYWARD AND INTEGRAL PARTNERS FUNDING, LLC FOR A PROPOSED DEVELOPMENT LOCATED AT PARCEL GROUP 6: CARLOS BEE QUARRY

WHEREAS, the State Department of Transportation (Caltrans) purchased over 400 parcels of property in the City of Hayward for the planned construction of the 238 Bypass Freeway project, which was stopped because of a lawsuit filed by La Raza Unida of Southern Alameda County; and

WHEREAS, the City and Caltrans negotiated a Purchase and Sale Agreement (PSA) for the City to acquire a portion of the properties from Caltrans, that was approved by the City Council and the California Transportation Commission (CTC) in January 2016; and

WHEREAS, the PSA with Caltrans allows the City to buy and dispose of ten different parcel groups for a time period that expires in January 2027; and

WHEREAS, on November 19, 2019, the City Council approved a resolution certifying an addendum to the 2014 General Plan Environmental Impact report, approved the Master Development Plan ("MDP"), and approved a resolution authorizing the City Manager to issue a Request for Proposals ("RFP") for the disposition and development of Parcel Group 6 consistent with the MDP; and

WHEREAS, the Addendum to the GP EIR was certified by the City Council on November 19, 2019 pursuant to CEQA Guidelines Section 15164, which confirmed that the proposed development for Parcel Group 6 consistent with the MDP and is within the scope of the GP EIR; will have no new or more severe significant effects and no new mitigation measures are required, and, therefore, no subsequent or supplemental EIR or further CEQA review is required prior to approval of the proposed project, as described in the Addendum; and WHEREAS, two developer proposals were received in response to the RFP, were reviewed by an interdepartmental staff team, and both proposals were rejected because the minimum Caltrans purchase price was not met, and a subsequent Request for Qualifications (RFQ) was issued to solicit Statements of Qualifications (SOQ); and

WHEREAS, there were five responses received to the RFQ including Integral Funding Partners, LLC, and after thorough interdepartmental review of the SOQs by staff, Integral, a highly qualified developer, was recommended as the preferred developer for further negotiation with the City for the development of Parcel Group 6.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward hereby authorizes and directs the City Manager to negotiate and execute an Exclusive Negotiating Rights Agreement (ENRA) with Integral Funding Partners, LLC consistent with the terms generally outlined in the accompanying staff report, in a form approved by the City Attorney.
