RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT WITH REVEL ENVIRONMENTAL MANUFACTURING INC., FOR PURCHASE AND INSTALLATION OF SMALL TRASH CAPTURE DEVICES IN AN AMOUNT NOT TO EXCEED \$430,000

WHEREAS, the Municipal Regional Permit (MRP), adopted by the San Francisco Bay Regional Water Quality Control Board (Water Board) on November 19, 2015, requires 100% removal of trash from the stormwater system by the year 2022; and

WHEREAS, the City has achieved 62% removal of trash and submitted to the Water Board a plan for compliance with the current MRP trash mandate; and

WHEREAS, the City has identified the remaining areas required to be treated for trash as the Hayward Small Device Trash Capture Project (Project); and

WHEREAS, the Project will install small trash capture devices to filter trash and debris from the identified areas required to have trash treatment; and

WHEREAS, the Project is consistent with the City's plan for compliance with the current MRP trash mandate; and

WHEREAS, the City will contract with Revel Environmental Manufacturing Inc., to design, purchase and install the needed small trash capture devices to treat the remaining areas required to have trash treatment; and

WHEREAS, the Project costs will be reimbursed by the EPA using Water Quality Improvement program grant funds; and

WHEREAS, the Project is categorically exempt from environmental review in accordance with the California Environmental Quality Act (CEQA) because the Project consists of minor alteration of existing publicly owned facilities used for the conveyance of storm water.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hayward finds and determines the Project is deemed categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15301, Class 1 (Minor Alteration of Existing Facilities) of the CEQA Guidelines.

BE IT FURTHER RESOLVED by the City Council of the City of Hayward that the City Manager is hereby authorized and directed to negotiate and execute a contract with Revel Environmental Manufacturing Inc., in a form approved by the City Attorney, to design, purchase and install small trash capture devices in an amount not to exceed \$430,000, as part of the Hayward Small Device Trash Capture Project.
