RESOLUTION APPROVING ADDENDUM NO. 1 AND AWARDING A CONTRACT TO CALIFORNIA TRENCHLESS, INC., FOR THE SANITARY SEWER MAIN REPLACEMENT AT ALAMEDA COUNTY TRANSIT MAINTENANCE FACILITY PROJECT, PROJECT NO. 07781, IN AN AMOUNT NOT-TO-EXCEED \$627,600

WHEREAS, by Resolution No. 21-035, on March 16, 2021, the City Council approved the plans and specifications for the Sanitary Sewer Main Replacement at Alameda County Transit Maintenance Facility Project, Project No. 07781, and called for bids to be received on April 13, 2021; and

WHEREAS, Addendum No. 1 was issued to make minor revisions to the specifications; and

WHEREAS, on April 13, 2021, twelve (12) bids were received ranging from \$542,600 to \$998,550. The low bid, submitted by California Trenchless, Inc., is approximately 33% below the engineer's estimate of \$815,000.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that Addendum No. 1 is hereby approved and adopted as part of the plans and specifications for the project.

BE IT FURTHER RESOLVED that California Trenchless, Inc., of Hayward, CA, is hereby awarded the contract for the Sanitary Sewer Main Replacement at Alameda Country Transit Maintenance Facility Project, Project No. 07781, in accordance with the plans and specifications adopted therefore and on file in the office of the City Clerk of the City of Hayward, at and for the price named and stated in the final proposal of the hereinabove specified bidder, and all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized and directed to execute an agreement with California Trenchless, Inc., in the name of and for and on behalf of the City of Hayward, in an amount not to exceed \$627,600 (including administrative change orders) in a form to be approved by the City Attorney.
