Council Members and Planning Commissioners:

The Hayward Chamber of Commerce is wholeheartedly in support of the proposal by Merlone Geier Partners to develop commercial spaces and two drive-through restaurants at the former K-Mart site at the southwest corner of Mission Boulevard and Harder Road.
