

The City Council meeting was called to order by Mayor Halliday at 7:00 p.m. The meeting was conducted utilizing teleconferencing and electronic means consistent with State of California Executive Order No 29-20 dated March 17, 2020, regarding the COVID-19 pandemic. Members of the City Council, City Staff, and members of the public participated via the Zoom platform.

CLOSED SESSION ANNOUNCEMENT

The City Council convened in closed session on July 20, 2021, at 5:00 p.m., with six members present and Mayor Halliday absent, regarding the City Manager's performance evaluation pursuant to Government Code 54957. City Attorney Lawson announced the City Council unanimously approved, with Council Member Salinas moving, Council Member Zermeño seconding and Mayor Halliday absent, to add a labor item to the closed session agenda pursuant to Government Code section 54954.2(b)(2) as the matter came to the attention of City staff after the posting of the agenda. It was reported that Mayor Halliday joined the closed session at 5:14 p.m. Mayor Halliday noted there was no reportable action related to the City Manager's performance evaluation and City Attorney Lawson noted there was no reportable action related to the labor item.

PRESENTATIONS

Mayor Halliday read a Certificate of Commendation presented to Ann and Joe Farias for the donation of \$100,000 made in their name by the Sakai family to support the Teen Programs and the Teen Center at the Downtown Library. Mayor Halliday indicated the Sakai family have been long time supporters of the library and sponsors of the gift. Library Director Addleman thanked the Farias and Sakai families for their generosity and noted the Teen Center will be renamed the Ann and Joe Farias Teen Center.

City Manager McAdoo shared that on July 15, 2021, the State of California Energy Commission, during its public hearing, approved an application by Calpine Corporation to resume operation of its Russell City Energy Center power plant following an unexplained explosion and despite the objections of the City of Hayward. Ms. McAdoo spoke about the explosion at the plant on May 27, 2021, showed photos of the pieces of metal that crashed through the roof on an unoccupied trailer at the City's Housing Navigation Center and on the ground of the City's wastewater treatment plant, shared that the plant failed a 2019 safety

audit by the California Public Utilities Commission (CPUC), and spoke about a tour of the plant and steps to move forward in coordination with Calpine, the Fire Department, CPUC and the City. It was noted that Mayor Halliday, City Manager McAdoo, City Attorney Lawson, Fire Chief Contreras, and Communications Manager Finnie attended the July 15, 2021, public hearing.

PUBLIC COMMENTS

Ms. Manaal Shafi, Community and Government Relations Coordinator with Bloom Energy, invited all to the Inaugural Bloom Energy Stars and Strides 5k/10k and Kids Fun Run on August 22, 2021, in San Jose to support healthcare workers and raise funds for the Valley Medical Center Foundation.

Ms. Alyse Lui, City employee and SEIU 1021 member, noted the Animal Services Division provided public service during the pandemic and urged Council to give its employees a fair contract and noted employees also contribute to the local economy.

Ms. Doris Tang, City employee and HAME member speaking in alliance with IPFTE Local 21 and SEIU, outlined staff accomplishments during the pandemic, and urged Council to invest in City workers.

Mr. Tim Sira, City employee, Hayward resident and SEIU 1021 member speaking in coalition with IPFTE Local 21 and SEIU, noted the work provided to residents by the Utilities Division, read a petition signed by residents in support of City employees and urged Council to invest in City workers.


Ms. Suzanne noted she attended the Russell City Energy Center power plant public hearing; thanked the Mayor and City staff for speaking against the reopening of the plant; asked for the Bay Area Air Quality Management District (BAAQMD) timeline for public input; and hoped for the weekly coordination meetings with the Fire Department to happen continually.

Mayor Halliday noted there will be a 10-day public comment period for the proposed permit, and additional information will be on the website.

Mr. Randy Waage suggested to hang a vinyl banner at the Skywest Golf Course to advertise the website for use of the Skywest Golf Course and workshop dates with Zoom links; and also share information via Facebook.

Council Member Wahab asked the City Manager to address the potential support for having one of the Ohlone tribes recognized by the federal government.

City Manager McAdoo noted there were conversations with the chair of the Muwekman Ohlone Tribe. Mayor Halliday noted it would be appropriate to issue a letter of support and have Council consider a resolution in September.

City Manager McAdoo made three announcements: La Familia, in partnership with Alameda County Food Bank and Eden Youth and Family Center, will hold a food distribution and vaccination event on July 24, 2021 at La Familia Cherryland Testing Site; City staff had a community meeting on July 19, 2021 regarding proposed changes to Patrick Avenue, and will hold a meeting with the Council Infrastructure Committee on July 28, 2021 to address feedback received and proposed changes; and the grand opening of the Heritage Plaza on July 17, 2021 was a successful and well attended event.

WORK SESSION

15. Fireworks Mitigation Options WS 21-036

Staff report submitted by Assistant City Manager Ott dated July 20, 2021, was filed.

Assistant City Manager Ott introduced Policy Fellow Mao who provided a synopsis of the staff report.



Mayor Halliday opened the public comment section at 8:26 p.m.

Mr. Gabriel Chaparro, HUSD Board Trustee but speaking as a Hayward resident, shared that firework shows are a product of privilege and a great opportunity to teach scientific concepts, and suggested organizing a sanctioned $4^{\rm th}$ of July parade and launching fireworks from public venues such as the Skywest Golf Course.

Ms. Suzanne noted fireworks are a big issue for Hayward residents and suggested a proactive approach to finding a solution and not waiting until spring 2022 to enact regulations.

Ms. TJ, Hayward Concerned Citizens member, noted noise pollution and safety concerns are the main complaints, suggested streamlining the reporting of fireworks and having a dedicated phone line to report them and using drones to locate offenders, and added that raising fines for violations may have the largest impact and urged for a proactive approach and not waiting until spring 2022.

Mr. Pat Dyas indicated that public displays mitigate the use of illegal fireworks to a degree and suggested discussing professional displays and the use of drones.

Ms. Ro Aguilar supported a Municipal Code change to fine for possession and being a property host, supported the use of drones to photograph individuals as a deterrent, and suggested working with neighboring cities to ban illegal fireworks.

Mr. Tom Ferreira, Hayward Concerned Citizens member, suggested increasing fines for illegal fireworks (\$250 for the first offence, \$500 for the second and \$1000 for the third with a possible misdemeanor charge) and having a posting plan in place for officers to stay on scene to keep everyone safe.

Mr. Kevin Dowling indicated that \$5,000 or \$10,000 fines might get more attention, noted that outreaching to neighborhoods where cases are reported might help, urged for more enforcement, and added that drones might help.

Ms. Brenda Clark encouraged the City to consider a social host ordinance such as San Jose's ordinance that holds the property owner liable for the infraction, have a portal for homeowners to unanimously report activity and have Code Enforcement fine culprits.

Mayor Halliday closed the public comment period at 8:48 p.m.

Members of the City Council thanked City staff and community members for the work, the engagement and input provided.

Discussion ensued among members of the City Council and City staff regarding: the use of drones as "spotters" to issue citations based off surveillance and photographs; a proposed Municipal Code amendment eliminating the need for peace officers to witness fireworks being used and challenges conducting enforcement of State codes governing fireworks;

enforcing challenges due to staff capacity, volume of calls received and other competing calls for service such as drunk drivers and domestic violence; a probable Municipal Code amendment specifying enforcement officers and providing authority to employees other than Code Enforcement staff or Police officers; the Police Department focuses enforcement efforts on 4th of July and New Year's Eve holidays and relies on community members to report other incidents to deploy resources effectively; there was significant seizure done in 2021 based on investigative work to identify people bringing illegal fireworks into the city; Chief Contreras and Chief Chaplin's commitment to leading a regional effort to address illegal fireworks enforcement; and the challenge for cities selling fireworks is that nonprofits depend on firework sales for revenue.


Council Member Zermeño was wary about City-sponsored firework displays, was amenable to support stricter enforcement and larger fines for infractions, suggested a year-round approach to educate the public and contact East Bay organizations that sell fireworks and urge them to sell other products.

Council Member Wahab noted the Municipal Code has outdated sections, was concerned with execution and viability of drones for enforcement, suggested the Police could focus efforts on emergent situations occurring on July 4th and have Maintenance Services staff support enforcement and issuance of citations on July 5th, and added that some residents suggested that volunteers help take photos and share locations.

Council Member Andrews noted she hears fireworks year-round and at all hours of the day, was interested in discussing access to firework displays and addressing equity issues, shared there are public venues where children can see displays such as at sporting events; was interested in efficiency of sting operations, noted that through education people can be informed on how to report incidents, suggested that getting to know neighbors can foster conversations and putting a face to who is being burdened, was concerned with identifying Palma Ceia Park as a location for safe use of fireworks, was concerned about using drones to identify homeowners that might not be responsible for launching fireworks.

Council Member Lamnin concurred that issues with illegal fireworks is not limited to $4^{\rm th}$ of July celebrations, was concerned about enforcement as the primary approach from a capacity standpoint, was supportive of modifying the Municipal Code as capacity allows and to give staff the tools they need to enforce rules, noted she would not advocate for the City to put on firework displays due to lack of resources and noted there is an opportunity to reach out to the Palma Ceia neighborhood and community partners to solicit input, agreed to evaluate monitoring fireworks with drones while the citywide drone policy is crafted, and added that non-sworn response in addition to the Fire Chief and Police Chief should be part of the community conversation about illegal fireworks enforcement.

Council Member Salinas spoke against allowing fireworks, supported strengthening the Municipal Code, did not support citizen arrests, noted enforcement is key and was amenable to using drone technology, was concerned about the environmental impact of having firework displays at the Hayward Shoreline, suggested adding language to Adopt a Block



signage to indicate that fireworks are illegal, and noted that neighborhood watch groups could help educate.

Council Member Márquez concurred that the issue with fireworks has been the worst during the last two years, suggested creating a video campaign with short testimonies on how illegal fireworks negatively impact people's lives and sharing via the City's newsletter and social media platforms with a message that Council will take serious action, recommended working in partnership with HARD and HUSD to limit locations being used for illegal activity, appreciated staff leading a regional effort in addressing illegal fireworks enforcement, supported conducting sting operations to deter use, suggested creating as much flexibility as possible so it does not only fall on the Police Department for enforcement, noted she was wary about the use of drones and citing properties, and stressed the need to have another entity leading efforts.

Council Member Wahab shared concerns related to drones, spoke against any activities at the Hayward Shoreline, suggested partnering with the Chamber of Commerce and business associations to have events throughout Hayward and keeping people involved in other activities as an alternative to firework displays.

Council Member Andrews noted that fines might not be a deterrent and suggested a requirement to do community service hours and clean up after fireworks as this might have more impact on offenders' time.

Mayor Halliday noted that aerial and loud fireworks are the ones causing problems for individuals with PTSD (posttraumatic stress disorder) and war veterans, pets, and young children; was inclined to look at the social host nuisance ordinance but not to criminalize it; suggested partnering with HARD and HUSD to get more people in neighborhoods having illegal fireworks; and added that she would be amenable to use drones to find areas of illegal activity.

City Manager McAdoo thanked Council for their feedback; noted staff will review all comments and return with action items for Council to consider.



Staff report submitted by Director of Public Works Ameri, dated July 20, 2021, was filed.



Public Works Director Ameri announced the report and introduced Mr. Sanjay Gaur, with Raftelis Consultants, who along with Public Works Director Ameri provided a synopsis of the report related to FY 2022 and FY 2023 Water Rates. Management Analyst Lo provided a synopsis of the staff report related to FY 2022 and FY 2023 Sewer Rates.

Discussion ensued among members of the City Council, City staff and Mr. Sanjay Gaur regarding: the impact of cumulative rates on residents and fixed costs due to contracts and variables that can be mitigated with financial assistance programs; building reserve funds for emergency situations; and financial assistance programs for low income customers or unemployed residents such as the low income fixed rate program and the Advanced Metering Infrastructure (AMI) program and rebates for water leaks.

There being no public comments, Mayor Halliday opened and closed the public hearing at 10:35 p.m.

City Clerk Lens reported that no additional protest letters were received.

Mayor Halliday offered a motion per staff's recommendation.

Council Member Zermeño seconded the motion.

Council Member Márquez recommended that staff educate the community about low-income services and partner with local non-profit agencies to run social media campaigns and encourage residents to avail of resources particularly individuals struggling financially.

Council Member Lamnin supported Council Member Márquez's recommendation and suggested that when the robust engagement process is conducted for East Bay Community Energy programs, staff can share information about resources as well as information on how to reduce water/sewer usage.

Council Member Andrews suggested that the communication campaign include how fat, oil, grease, and wipes negatively impact sewer systems.

Mayor Halliday voiced her support for the recommendations and suggested adding outreach to landlords of multifamily properties.


