RE: Appeal of the Hayward Planning Commission's Decision on Parcel Group 3 Project (176 units Affordable Housing Development and Charter School)

Jihong(Julia) Zhang, reside at 818 Webster Street, Hayward, CA 94544 – just less than 500 feet from the project site.

Nancy Quintero, reside at 826 Webster Street, Hayward, CA 94544 – just less than 500 feet from the project site.

Joanne Lam, reside at 27827 East 16th Street, Hayward, CA 94544 – just less than 500 feet from the project site.

On July 22, 2021, the Hayward Planning Commission approved PH 21-063 (176 Affordable Housing units and a charter school). We are writing this letter to appeal the Planning Commission's approval based on the following:

1. The project will be located by the Hayward fault line. Did the City conduct seismic hazard analysis to determine whether the ground is stable and safe enough to accommodate two 5-story buildings and a school without endangering the lives of up to 500-600 residents and 300+ school age children? The City should have Geologists/scientists, who are experts in this field, conduct studies to determine if the ground will be stable enough to support the structures in the event of an earthquake on the Hayward fault line - lives of tenants and school children depend on this. (For guidance we referred to information found in SB 1155 and the CEQA.)
2. Many residents living near the project were not aware of the project; we discovered that some residents sent emails to the City requesting postponement of the City's July 22<sup>nd</sup> public hearing because they did not receive the notice and could not attend the virtual hearing, also some are not tech savvy and aren't familiar with Zoom. Nonetheless, their requests for postponement were ignored. Many residents, impacted by this project, heard about it when Julia informed them by going door-to-door. We have collected signatures from 95+ residents who signed a petition against the project, one signature per house address, it represents 200 to 500 residents (see the attached file). We shall drop off the original signed petitions at City Hall.

3. The additional points listed on the attached Petition: 1) Not enough allotted parking spaces will cause crowding on our already narrow and crowded streets; 2) Traffic congestion on our neighborhood streets (we already have traffic from parents and students of St. Clemente School, Moreau High School, and St. Clemente Church).

On another note, Julia attended the July 22nd public hearing via Zoom and when staff asked for public comment Julia raised her hand and was not called upon. Julia felt like the only people allowed to speak were people in favor of the project and Julia has to wonder if calling on those people was deliberate. Are the people in favor of the project residents of the neighborhood?

We doubt it. We are sure those people were affordable housing advocates or perhaps possible future tenants who might not know or understand that the development is near the Hayward fault line. Maybe they are other developers or employees of property management or resident service companies - more advocates who don't live in the neighborhood. The Planning Commission did not hear our voice because Julia was told by Denise A. Chan that she didn't see that Julia had raised her hand. Julia was not given the opportunity to voice our concern. Julia left that meeting feeling extremely disappointed and frustrated with the City's Planning Commission.

Residents from our neighborhood and nearby neighborhoods have signed a petition opposing the project - let their signed petition be their voice. Please hear their voices. The most important point of our appeal is to not put the lives of residents in danger. Please let the Geologists/scientists/experts in the field conduct research regarding the impact of building these structures on or near the Hayward fault line. The City should not put any lives in danger for the sake of creating more affordable housing and building a charter school to serve the residents of the development.
