#### SUMMARY

The City Council, Community Services Commission (Commission), and community agencies have all expressed a desire for the Community Agency Funding Process to be transparent around funding decision making, to see clearly articulated shared goals for the funding, and to utilize data for funding decision making and performance management.

In May 2019, the Commission formed a subgroup, the Community Agency Funding Review Committee (Committee), to review the current funding process, identify best practices, and provide recommendations to make the funding process more efficient and effective. Comprised of five members of the Community Services Commission, the Committee convened on four occasions in June and July of 2019. Across these meetings, members of the Committee conducted a comprehensive review and assessment of the current funding process and recommended several administrative changes to the application for funding. These changes include requiring demographic data, identifying service type based on prevention or responsive, removing the certain audit requirement for social service applicants, providing an opportunity for agencies to discuss any challenges from the past year that may have affected their performance, as well as formatting changes.
