Recommendation

As summarized, this establishment committed its first violation on April 14, 2022. Evidence supporting the violations listed below are included in the Exhibits listed on the following page and includes testimony from various Inspectors as indicated on the Notice of Violation and Case and Inspection Details who witnessed the violations, as well as dated photos of the violations. This is more than enough evidence to meet the City's preponderance of the evidence burden.

Here, the City does not recommend issuance of a lesser penalty due to the business's continued pattern of non-compliance, including failure to maintain an active business license and/or Tobacco Retail License, as well as failure to properly obtain, pay for, or post required licenses during repeated inspections. The business has also been observed selling prohibited flavored tobacco products, vape devices, and prohibited cigarillo packaging, including packaging containing fewer than the minimum required quantity of five cigarillos per pack.

Across multiple prior inspections, the business remained out of compliance with licensing requirements, with recurring violations involving expired or unposted licenses. The business has continued to accrue unpaid fees and administrative penalties associated with these violations while remaining out of compliance, including fees that have been specially assessed by the City due to nonpayment.

These ongoing violations demonstrate a sustained disregard for applicable local regulations and repeated failure to correct cited issues despite prior enforcement actions and educational outreach by the City.

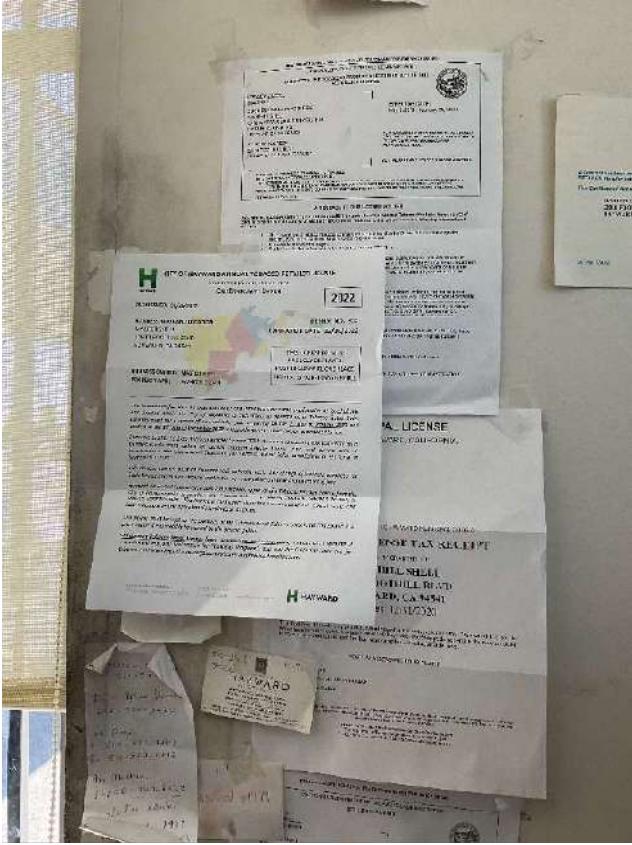

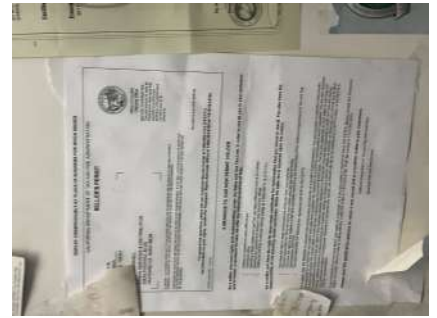

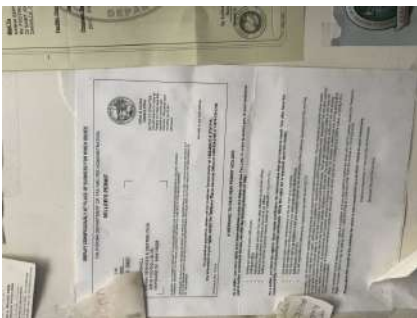

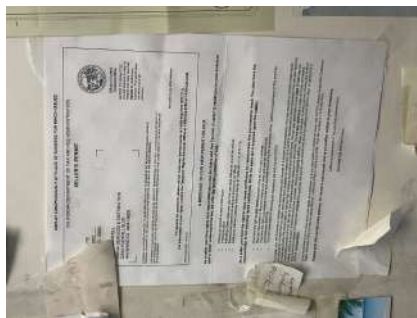
