MINUTES

Approval of the Minutes of the Community Services Commission Meeting on June 18, 2025

REPORT ITEMS

Informational Report: Bidders' Conference Debrief and ARC Selection

Dr. Cole-Bloom confirmed the Bidders' conference was cancelled and referenced an October email communication regarding the cancelation of the Community Agency Funding process for the next fiscal year. Dr. Cole-Bloom announced the termination of all fiscal year 2025 – 2026 General Fund contracts as of December 15, 2025. Recipients will receive half of their award and will not be required to submit the mid-year or year-end reports.

Ms. Hwang presented an overview of the Agency Stakeholder Survey, which was conducted to better understand how the termination of General Fund contracts and the pause in the Community Agency Funding process are impacting agencies, as well as gathering feedback on the types of non-monetary support the City and the Community Services Commission may provide.

Public Comments on Item:

- Socorro Moreland, Covenant House California, provided background information and a summary regarding the small community of individuals in Hayward who will be residing in the proposed young adult shelter. Mr. Moreland invited the Commissioners to consider the experiences of local youth facing homelessness and safety challenges on the streets of Hayward. He shared that he personally experienced homelessness as a youth and emphasized that his ability to overcome those circumstances was made possible through programs such as these.
- Duke Hwang, Spectrum Community Services, provided an overview of the services offered to seniors in the Hayward community. He explained that Spectrum's program focuses on providing nutritious, healthy meals to support senior well-being. Mr. Hwang thanked the Commission for its continued support and invited Commissioners to visit the program and participate through volunteer opportunities with the seniors served.

Action Item: CSC Agenda Planning Calendar

- Commissioner Jesse Gunn made a motion to adopt the calendar as red-lined and edited during the discussion of the item. It was seconded by Commissioner Jagdeep Singh. The motion was approved unanimously. See *Figure 1: Action Item Votes for roll call vote*.

 - New City Manager, Jennifer Ott, will start on 12/8/2025
