

## Summary of Evidence

### Business Information

### Recommendation

Here, the City does not recommend issuance of a lesser penalty due to the business's continued pattern of non-compliance, including the sale of prohibited flavored tobacco products and electronic smoking devices in violation of SEC. 10-1.2783 and SEC. 10-1.2785.

During the City's 2026 tobacco retail inspections, evidence was obtained from the property owner demonstrating that vape sales continued at the business after Notices of Violation had been issued to both the business and property owner. This evidence indicates that unlawful tobacco sales practices persists despite prior enforcement efforts.

Separately, the U.S. Food and Drug Administration (FDA) documented additional tobacco sales violations during federal compliance checks. On August 19, 2025, the business sold a Flum Mello Watermelon Peach Lime flavored vape product to a person under 21 years of age and failed to verify the purchaser's age. On February 24, 2026, the business sold Marlboro cigarettes to a person under 21 years of age during another FDA compliance check. These violations resulted in FDA enforcement action against the retailer which is evidence of additional violations under the Tobacco Retail Sales Establishment Ordinance.

Despite multiple prior enforcement cases, failed inspections, and FDA enforcement actions, the business has continued to engage in unlawful tobacco sales practices.

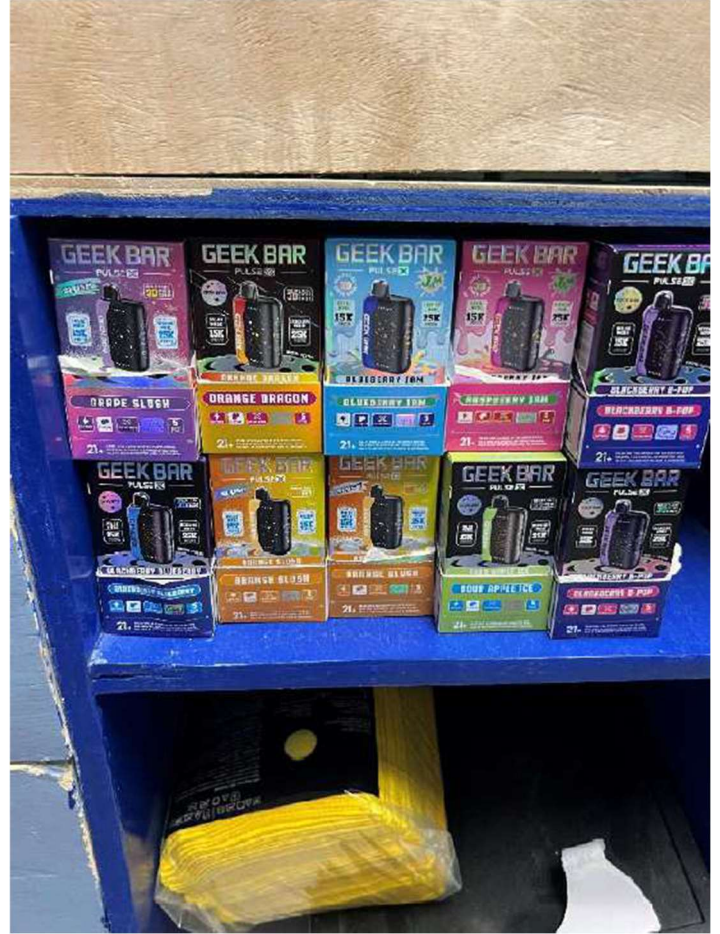

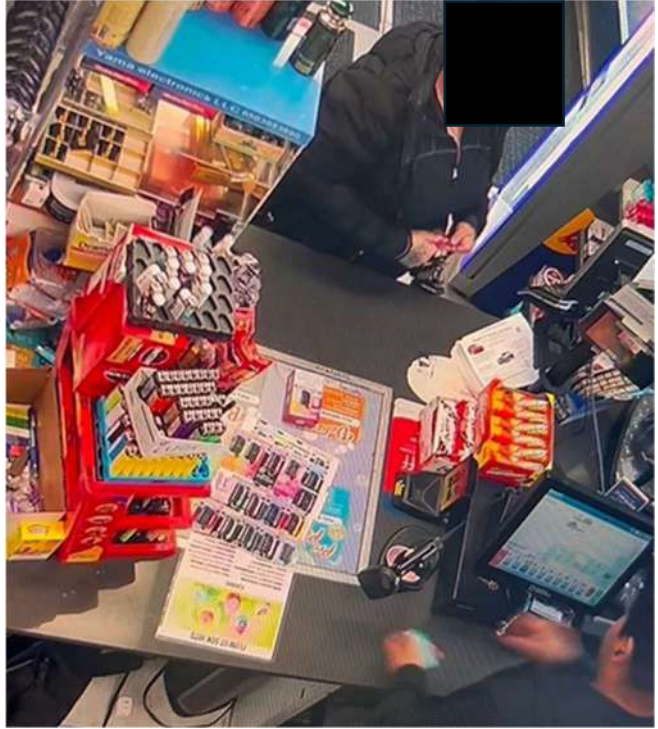

I want to provide some context regarding how our municipal code is applied. The City of Hayward holds property owners responsible for activity occurring on their property, including businesses that may be in violation of the Tobacco Retail License (TRL) ordinance. I share this so you are aware that any observed violations may result in administrative penalties issued to the property owner.

When violations are documented, an Administrative Penalty and Fee Notice is typically sent to the property owner and a copy is also provided to the business. In many cases, property owners are able to work directly with their tenants to address compliance and any associated penalties.

I plan to conduct an inspection of the business in the coming week. If you would like to receive updates on the status of the case, please feel free to reach out to me and I can provide additional information as it becomes available.

Inspection

On April 20, 2026, I conducted an inspection of the business. Prior to the inspection, Jesse Prins provided photographs and videos documenting suspected sales of illegal flavored vape products occurring at the location. 04/21/2026

Upon entering the business, I introduced myself to the clerk, with who allowed access behind the counter. I provided informational materials from the California DOJ regarding the unflavored tobacco product requirements.

During the inspection, I observed flavored tobacco products being offered for sale. stated that a previous inspector had advised that the items could be sold until inventory was depleted. I directed to remove the flavored items immediately, and complied without hesitation. The items, including but not limited to Backwoods Bold and Backwoods Black, were removed from display and placed in a bag.

Licensing was observed to be current and posted, with the exception of the City business license, which was not posted at the time of inspection. contacted the property owner by phone, and I spoke with directly. confirmed that a valid business license exists and stated would provide proof once posted.

During the inspection, I requested access to the office area, which is a potential storage location for tobacco products. did not allow full access to this area, limiting my ability to conduct a thorough inspection. Based on the prior evidence and the limited access granted during inspection, I was unable to verify full compliance.

With guidance from Deputy City Attorney II Amy Rothman, an Administrative Penalty and Fee Notice will be issued to the property owner.

This inspection is considered failed. Further enforcement action and follow-up inspection will be required to confirm compliance.

On April 30, 2026, I conducted a follow-up inspection at the property for an active TRL case. Upon arrival at the gas station convenience store, I was met by the property owner, Jesse Prins who spoke with me regarding ongoing activity at the site. 04/30/2026

vape sales are continuing despite prior enforcement actions. provided CCTV footage showing a transaction occurring at the counter, followed by the employee escorting the customer outside to a vehicle, retrieving a vape product from the trunk, and completing the sale. The property owner stated provide video evidence of ongoing sales occurring after the initial Notice of Violation was issued.

The property owner also explained that is currently in arbitration with the business owner and tenants in an effort to evict them due to illegal vape sales and breach of lease terms. confirmed that a three-day notice to cease activity has already been served. further expressed concern for personal safety and the safety of family due to the ongoing dispute.

In addition, the property owner provided hardcopy invoices showing vape product purchases from a wholesale retailer in San Leandro and indicated that will forward copies via email.

Based on the information and evidence provided, I will be issuing an additional failed inspection, Administrative Penalty and Fee Notice supported by the video evidence documenting violations occurring after prior notice.

This Warning Letter is notification from the United States Food and Drug Administration (FDA) advising you that Mobil was observed to be in violation of federal tobacco laws and regulations. Failure to address these violations may result in FDA initiating regulatory or legal action, including monetary penalties. Your response is requested in 15 working days.

On August 19, 2025, an inspector representing the FDA completed an inspection of the establishment located at 391 West A Street, Hayward Acres, CA 94541. During this inspection, the establishment was in violation because you or your employee sold an electronic nicotine delivery system (ENDS) product to a person under 21 years of age and failed to check photographic identification to verify the age of a purchaser under 30 years of age.

This inspection revealed that the establishment sells, distributes, and/or advertises tobacco products, including electronic nicotine delivery system (ENDS) products, which requires that the establishment and its owners comply with federal laws and regulations governing such practices. The violations observed during the August 19, 2025, inspection include the following:

1. A person under 21 years of age was able to buy a Flum Mello Watermelon Peach Lime electronic nicotine delivery system (ENDS) product on August 19, 2025, at approximately 10:29 AM in the establishment.

It is unlawful for any retailer to sell a tobacco product to any person younger than 21 years of age. Doing so violates Section 906(d)(5) of the Federal Food, Drug, and Cosmetic Act (FD&C Act).

2. No one in the establishment checked photographic identification to verify the age of the tobacco product purchaser before the sale of a Flum Mello Watermelon Peach Lime electronic nicotine delivery system (ENDS) product on August 19, 2025, at approximately 10:29 AM.

Page - 2 - Mobil

A retailer MUST check a photographic identification that includes a date of birth for any person under the age of 30 who attempts to purchase covered tobacco products, such as electronic nicotine delivery system (ENDS) products. Failure to do so violates 21 C.F.R. § 1140.14(b)(2)(i).

The listed violations cause your electronic nicotine delivery system (ENDS) product to be "misbranded" under Section 903 of the FD&C Act (21 U.S.C. § 387c).

You should take prompt action to address the violations listed above. Failure to address any violations of the Federal Food, Drug, and Cosmetic Act, 21 U.S.C. § 301 et seq., Chapter IX, relating to tobacco products including the tobacco regulations in 21 C.F.R. Parts 1140, 1141, and 1143, may result in FDA initiating regulatory or legal action. These actions may include, but are not limited to, civil money penalty, no-tobacco-sale order, seizure, and/or injunction.

Please note that this warning letter does not constitute final agency action, but if you have evidence or information that you believe demonstrates that this notice was issued in error, you should preserve any evidence or information relevant to this warning letter in the event FDA initiates regulatory action at a later date.

The violations indicated in this letter may not be a complete list of violations at the establishment.

We will periodically inspect your establishment and review your promotional activities (e.g., website(s)) related to FDA-regulated tobacco products to assess your compliance with all applicable laws and regulations, including access, marketing, labeling, and advertising restrictions.

Effective August 8, 2016, FDA deemed additional products meeting the definition of a tobacco product, except accessories to these newly deemed products, to be subject to regulation under the Act. These products include, but are not limited to, electronic nicotine delivery systems (including e-cigarettes), e-liquids, cigars, and pipe tobacco. See Final Rule, Deeming Tobacco Products To Be Subject to the Federal Food, Drug, and Cosmetic Act, as Amended by the Family Smoking Prevention and Tobacco Control Act; Restrictions on the Sale and Distribution of Tobacco Products and Required Warning Statements for Tobacco Products, 81 Fed. Reg. 28,974 (May 10, 2016), available at <https://federalregister.gov/a/2016-10685>.

On March 15, 2022, the President signed legislation to amend the FD&C Act to extend FDA's jurisdiction to products "containing nicotine from any source," not just nicotine derived from tobacco. See Consolidated Appropriations Act, 2022, Public Law 117-103, Division P, Subtitle B. Specifically, this legislation expanded the definition of "tobacco product" under 21 U.S.C. § 321(rr) to include products containing nicotine from any source.

As of April 14, 2022, it is illegal for a retailer to sell any tobacco product, containing nicotine from any source – including cigarettes, smokeless tobacco, cigars, and e-cigarettes – to anyone under 21.

Please be aware that the FD&C Act requires “new tobacco products” to have premarket authorization. A “new tobacco product” is any tobacco product that was not commercially marketed in the United States as of February 15, 2007, or any modified tobacco product that was commercially marketed after February 15, 2007. **INTRODUCTION**

1. The Center for Tobacco Products (CTP), Food and Drug Administration (FDA), United States Department of Health and Human Services, seeks a civil money penalty (CMP) in the amount of \$356 from Kareem & Laith, LLC, d/b/a Mobil / Hayward Gas and Food (Respondent) for violating Section 906(d)(5) of the Federal Food, Drug, and Cosmetic Act (Act) (21 U.S.C. § 387f(d)(5)) and/or FDA’s tobacco regulations at least two times within a twelve month period.

**LEGAL AUTHORITY**

2. FDA has the authority to seek a civil money penalty from any person who violates a requirement of the Act related to tobacco products. 21 U.S.C. § 333(f)(9).

3. The Act prohibits the misbranding of a tobacco product while such product is held for sale after shipment of the product or its components in interstate commerce. 21 U.S.C. § 331(k).
4. “Interstate commerce” means, among other things, “commerce between any State or Territory and any place outside thereof.” 21 U.S.C. § 321(b).
5. A tobacco product is deemed to be misbranded if it is sold or distributed in violation of Section 906(d)(5) of the Act (21 U.S.C. § 387f(d)(5)) or in violation of regulations issued under Section 906(d) of the Act (21 U.S.C. § 387f(d)). 21 U.S.C. § 387c(a)(7)(B); 21 C.F.R. § 1140.1(b).
6. Such regulations include those codified at 21 C.F.R. Part 1140, which were issued under Section 906(d) of the Act (21 U.S.C. § 387f(d)) to impose restrictions on the sale and distribution of and access to tobacco products.
7. As of August 8, 2016, pursuant to 21 U.S.C. §§ 387a and 387f(d) (Section 906(d) of the Act), FDA deemed additional products meeting the definition of a tobacco product, except accessories to these newly deemed products, to be subject to regulation under the Act. These products include, but are not limited to, electronic nicotine delivery systems (including e-cigarettes), e-liquids, nicotine pouches, cigars, and pipe tobacco.<sup>1</sup> See Final Rule, Deeming Tobacco Products To Be Subject to the Federal Food, Drug, and Cosmetic Act, as Amended by the Family Smoking Prevention and Tobacco Control Act; Restrictions on the Sale

<sup>1</sup> On January 24, 2025, the United States Court of Appeals for the District of Columbia Circuit largely affirmed a district court order finding FDA’s decision to deem premium cigars arbitrary and capricious but remanded the case to the district court for the limited purpose of considering “the appropriate definition of ‘premium cigar.’” *Cigar Ass’n of Am. v. FDA*, No. 132 F.4th 535 (D.C. Cir. 2025) (amended opinion issued on March 26, 2025); *Cigar Ass’n of Am. v. FDA*, No. 16-cv-01460 (D.D.C. and Distribution of Tobacco Products and Required Warning Statements for Tobacco Products, 81 Fed. Reg. 28,974 (May 10, 2016), available at <https://federalregister.gov/a/2016-10685> (hereafter "Deeming Regulation").

8. The Deeming Regulation amended the regulations codified at 21 C.F.R. Part 1140 to define the term "covered tobacco product" to mean "any tobacco product deemed to be subject to the [Act] under 1100.2 of this chapter, but excludes any component or part that is not made or derived from tobacco," see 21 C.F.R. § 1140.3, and to extend the Part 1140 restrictions on sale and distribution of and access to tobacco products to "covered tobacco products," see 21 C.F.R. § 1140.1(a) (defining the Part 1140 regulations as "set[ting] out the restrictions under the [Act] on the sale, distribution, and use of cigarettes, smokeless tobacco, and covered tobacco products."). Therefore, selling or distributing a tobacco product, including a "covered tobacco product," in violation of these regulations causes that tobacco product to be misbranded. 21 U.S.C. § 387c(a)(7)(B).
9. On December 20, 2019, the Act was amended by the Further Consolidated Appropriations Act, 2020, Pub. L. No. 116–94, § 603, to raise the federal minimum age of sale of tobacco products to 21. Specifically, Section 906(d)(5) of the Act (21 U.S.C. § 387f(d)(5)) states, "It shall be unlawful for any retailer to sell a tobacco product to any person younger than 21 years of age."
10. Retailers who violate Section 906(d)(5) of the Act (21 U.S.C. § 387f(d)(5)) and/or the regulations promulgated under Section 906(d) of the Act (21 U.S.C. § 387f(d)) may incur a civil money penalty up to the maximum amounts set forth

in a schedule found in the Family Smoking Prevention and Tobacco Control Act (TCA), Pub. L. No. 111-31, 123 Stat. 1776 (2009), § 103(q)(2)(A)(i) (codified at 21 U.S.C. § 333 note). See 21 C.F.R. § 17.2, referencing 45 C.F.R. § 102.3 (setting forth, among other things, the current CMP amounts, adjusted for inflation, for 2 or more violations). The current amounts are available at <https://www.fda.gov/tobacco-products/compliance-enforcement-training/ctp-compliance-enforcement#e>.

### **CURRENT ALLEGATIONS**

11. Respondent owns an establishment that does business under the name Mobil / Hayward Gas and Food and is located at 391 West A Street, Hayward, CA 94541.
12. Respondent's establishment receives tobacco products in interstate commerce, including Marlboro cigarettes and Flum Mello Watermelon Peach Lime electronic nicotine delivery system (ENDS) products, and holds them for sale after shipment in interstate commerce.
13. On February 24, 2026, an FDA-commissioned inspector conducted an inspection of Mobil / Hayward Gas and Food.. During this inspection, Respondent committed a violation of selling tobacco products to a person under 21 years of age, in violation of Section 906(d)(5) of the Act. Specifically, a person younger than 21 years of age was able to purchase a package of Marlboro cigarettes at Respondent's establishment on February 24, 2026, at approximately 3:45 PM.
14. On February 26, 2026, CTP issued a Notice of Compliance Check Inspection to Respondent's establishment, stating that an inspection had been conducted on

February 24, 2026, and that during this inspection, a person under 21 years of age was able to enter the establishment and purchase a regulated tobacco product at approximately 3:45 PM. This Notice stated that other potential violations of federal tobacco law may have been observed, and further stated that if, after review, CTP determined that there was a violation of federal law, the establishment may receive further notification from FDA.

15. On August 19, 2025, Respondent committed the following violations:
  - a. Selling tobacco products to a person under 21 years of age, in violation of Section 906(d)(5) of the Act. Specifically, a person younger than 21 years of age was able to purchase a Flum Mello Watermelon Peach Lime electronic nicotine delivery system (ENDS) product at Respondent's establishment on August 19, 2025, at approximately 10:29 AM; and
  - b. Failing to verify the age of a person purchasing covered tobacco products by means of photographic identification containing the bearer's date of birth, as required by 21 C.F.R. § 1140.14(b)(2)(i). Specifically, the underage purchaser's age was not verified before the sale, as detailed above, on August 19, 2025, at approximately 10:29 AM.
16. On September 23, 2025, CTP issued a Warning Letter to Mobil, notifying Respondent that FDA had documented the violations set forth in Paragraph 15. UPS records show that the Warning Letter was received on September 24, 2025. The Warning Letter stated that failure to correct the violations may result in a civil money penalty action or other regulatory action by FDA. The Warning Letter also stated that it was the responsibility of Mobil to ensure compliance with the law

and that the letter was not intended as an exhaustive list of violations.

Additionally, on August 21, 2025, CTP issued a Notice of Compliance Check Inspection to Respondent's establishment, stating that an inspection had been conducted on August 19, 2025, and that during this inspection, a person under 21 years of age was able to enter the establishment and purchase a regulated tobacco product at approximately 10:29 AM. This Notice stated that other potential violations of federal tobacco law may have been observed and further stated that if, after review, CTP determined that there was a violation of federal law, the establishment may receive further notification from the FDA regarding the violations.

### **RESPONDING TO COMPLAINT**

17. Respondent must respond to this Complaint. The cover letter provides information on options for responding. Respondent has the right to request a hearing by filing an Answer within 30 days after service of the Complaint. 21 C.F.R. § 17.9. The Answer will be deemed to be a request for a hearing unless the Answer states otherwise. Failure to file an Answer within 30 days after service of the Complaint may result in a default order imposing the proposed civil money penalty. 21 C.F.R. § 17.11. The Answer must be filed with the Departmental Appeals Board, Civil Remedies Division. Answers should be filed electronically at <https://dab.efile.hhs.gov> or, to request a waiver from filing your Answer electronically with DAB E-File, call the Civil Remedies Division of the Departmental Appeals Board at 844-880-5720. For additional instructions on how to file an Answer, see the Cover Letter that accompanies this Complaint.

18. Respondent has the right, but is not required, to retain counsel for representation.

**REQUEST FOR RELIEF**

19. CTP respectfully requests that an order assessing a civil money penalty against Respondent in the amount of \$356 be entered for two of Respondent's violations within a twelve month period.

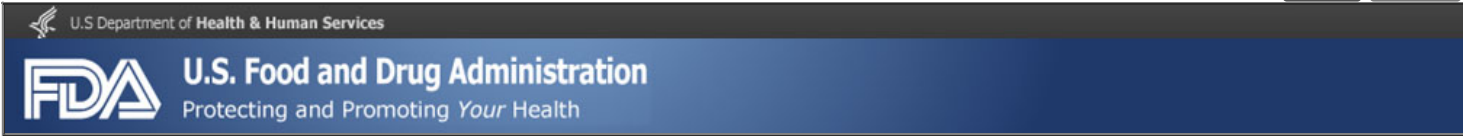
## **Notification of Update to Federal Law for Tobacco Products Containing Nicotine Not Derived from Tobacco**

On March 15, 2022, the President signed legislation to amend the Federal Food, Drug, and Cosmetic Act to extend FDA’s jurisdiction to products “containing nicotine from any source,” not just nicotine derived from tobacco. See Consolidated Appropriations Act, 2022, Public Law 117-103, Division P, Subtitle B. Specifically, this legislation expanded the definition of “tobacco product” under 21 U.S.C. § 321(rr) to include products containing nicotine from any source.

As of April 14, 2022, it is illegal for a retailer to sell any tobacco product, containing nicotine from any source – including cigarettes, smokeless tobacco, cigars, and e-cigarettes – to anyone under 21.
